**I. CLARIFICATION/S**


No.	Query/Request	Clarification/Resolution
1.	<p>Section 23.4.1.3. of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 states that, <i>the prospective bidder must have completed, within the period specified in the Invitation to Bid, an SLCC that is similar to the contract to be bid, and whose value, adjusted to current prices using the Philippine Statistics Authority (PSA) consumer price indices, must be at least fifty percent (50%) of the ABC. However, in the case of Expendable Supplies, said SLCC must be at least twenty five percent (25%) of the ABC.</i></p> <p>In the light of the above-quoted provisions of the IRR of R.A. 9184, a clarification on the percentage allowed for SLCC from 50% to 25% of the ABC is requested and that the provisions of Section 23.4.1.3, particularly that 25% of the ABC as requirement for SLCC under ITB Clause No. 5.4 of the Bid Data Sheet be applied and considered.</p>	<p>Similar contract is defined/stated in Bid Data Sheet (BDS). Similar contract for Lot 1 shall refer to Contracts for the Rental of Automatic Hand Sanitizer Dispensers with Provision of Supplies and Services, Lot 2 shall refer to Contracts for the Rental of Automatic Hand Soap Dispensers with Provision of Supplies and Services and Lot 3 shall refer to the Rental of Automatic Air Freshener Dispensers with provision of Supplies and Services.</p> <p>The Approved Budget for the Contract (ABC) for the Rental of Equipment with Provision of Supplies and Services for Ninety Three (93) sets of Automatic Hand Sanitizer Dispensers for CY 2019 (Lot 1), One Hundred Forty Eight (148) sets of Automatic Air Freshener Dispensers for CY 2019 (Lot 2) and One Hundred Forty (140) sets of Automatic Hand Soap Dispensers for CY 2019 (Lot 3) <b>consist of Supplies, Rental and Services not just expendable supplies</b> as shown in Price Schedule (Pages 86, 87 and 88 of the Bidding Documents).</p> <p>Based on the foregoing, <b><i>the request of Pure Clean Hygiene Solutions, Inc. is denied. Provisions stated in BDS 5.4 are retained.</i></b></p>
