AN ACT
MANDATING THE INSTALLATION OF CLOSED CIRCUIT TELEVISION (CCTV)
CAMERAS IN PUBLIC AND PRIVATE SCHOOLS NATIONWIDE

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1.** *Declaration of Policy.* It shall be the policy of the state to adopt
2 modern technology in apprehending and preventing crimes to enhance security and
3 maintain peace and order in public and private schools.
4

5 **SECTION 2.** *Definition of Terms.* For purposes of implementing the provisions
6 of this Act, the following terms shall be construed to mean as follows:

- 7 a) Closed circuit television camera (CCTV)- a device or system that could be
8 used to capture and record photo or still and moving or video images;
- 9 b) Schools- Any building, structure, yard, court and space dedicated for
10 education or learning.
11

12 **SECTION 3.** It is hereby mandated that public and private schools nationwide
13 shall install closed circuit television (CCTV) cameras within their establishments that

1 will cover strategic areas in their premises so as to capture photos or videos of
2 possible crimes or untoward incident that may occur thereat.

3
4 **SECTION 4.** The budget necessary for the implementation of this Act with
5 respect to public schools shall be included in the annual budget of the Department of
6 Education, State Universities and Colleges.

7 Private schools shall pay for the expenses necessary for the compliance of the
8 provisions of this Act.

9
10 **SECTION 5.** *Implementing Rules and Regulations.* The Department of
11 Education, State Universities and Colleges shall issue their corresponding rules and
12 regulation necessary for the implementation of this Act.

13
14 **SECTION 6.** *Repealing Clause.* All laws or parts of any law, orders, rules, and
15 regulations or parts thereof inconsistent with this Act are hereby repealed or
16 amended accordingly.

17
18 **SECTION 7.** *Effectivity Clause.* This Act shall take effect fifteen (15) days
19 after its publication in the Official Gazette or in at least two (2) newspapers of general
20 circulation.
