AN ACT
**DECLARING THE CITY OF CARCAR IN THE PROVINCE OF CEBU AS A
CULTURAL HERITAGE ZONE AND FOR OTHER PURPOSES**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. This Act shall be known and the cited as the "Carcar Cultural Heritage Zone Act of 2013.

SEC. 2. Purpose. – There is need to protect, preserve, conserve and promote the nation's cultural heritage, its property and histories, and the ethnicity of local communities.

SEC. 3. Definition Term.- For purposes of and as used in this Act.

Cultural Heritage Zone – refers to historical, anthropological, archeological, artistic geographical areas and settings that are culturally significant to the country, the context of which needs to be preserved. It includes within its comprehension, cultural space;

SEC. 4 The town of Carcar its premises located in the province of Cebu is hereby declared as a Cultural Heritage Zone. The town of Carcar is the setting of century-old architecturally significant and historic houses, the largest such ensemble in Cebu and certainly one of the most townscapes of its kind in the country. The rotunda, a principal landmark of Carcar, is similarly unique for its design and scope. The province, with the added historic symbolism of marking the encounter with people's movement from Southwestern Cebu and vice versa. As such it shall be accorded priority development by the Department of Tourism in coordination with the concerned agencies of government, and shall be subject to the rules and regulations governing the conservation and preservation of heritage sites.

SEC. 5. Department of Tourism in coordination with the Philippine Tourism Authority and other government agencies concerned, the Provincial Government of Cebu and the Local Government of the Town of Carcar, shall within one year after the approval of this Act, prepare the development plan involving the preservation, conservation, restoration and/or maintenance of such appropriate facilities which shall enhance tourism in the area; Provided, that said conservation plan shall ensure the preservation and maintenance of identified structures, covering the technical standards for conservation and restoration, the survey, planning, engineering and construction work.

SEC 6. Department of Tourism shall promulgate the necessary rules and regulations for the proper implementation of this Act.

SEC. 7. This Act shall take effect upon its approval.
