EXPLANATORY NOTE

The Province of Sarangani was established as an independent province in the year 1992 through the enactment of Republic Act 7228.

Today, more than twenty years after, Sarangani is still to establish its own provincial hospital. The precious health of its people is only being catered by the Municipal and Barangay Health Centers scattered in the seven municipalities of the province.


This proposed measure seeks the creation of a public provincial hospital for Sarangani. The provincial hospital shall be at least with 100 bed capacity.

The Department of Health shall have full administrative and technical control of the said hospital. It shall also be in charge of the increase in its operating fund, upgrading of its medical equipment and facilities, and construction of its needed infrastructure.

With this measure, the citizens of Sarangani, especially the indigent patient, no longer need go to General Santos City for their medical treatment. They can be treated and provided with high-quality medical care in their very own province.

During the incumbency of the Honorable Emmanuel D. Pacquiao as Representative of the Lone Congressional District of Sarangani in the 15th and 16th Congress, this bill was filed but not enacted. Hence, considering the urgency and necessity of a public hospital in the Province of Sarangani, the undersigned refiles this bill.

In this respect, the early consideration and passage of this measure bill is sincerely sought.

AN ACT ESTABLISHING A TERTIARY PROVINCIAL HOSPITAL IN THE PROVINCE OF SARANGANI TO BE KNOWN AS THE SARANGANI PROVINCIAL HOSPITAL, APPROPRIATING FUNDS THEREFOR, AND FOR OTHER PURPOSES

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled.

SECTION 1. Short Title. - This Act shall be known as the “Sarangani Provincial Hospital Act of 2016”.

SECTION 2. Establishment of Sarangani Provincial Hospital in the Municipality of Alabel. - The creation of Sarangani Provincial Hospital is hereby mandated to be located at Alabel, Sarangani, with a minimum 100 bed capacity, to be known as the Sarangani Provincial Hospital. -

SECTION 3. Supervision of the Department of Health. - The Sarangani Provincial Hospital shall be under the full administrative and technical supervision of the Department of Health (DOH), which shall increase its operating fund; upgrade its medical equipment and facilities; and construct its needed infrastructure.

SECTION 4. Appropriations. - The amount of Two Hundred Million (P 200,000,000.00) necessary to carry out the provisions of this Act shall be included in the General Appropriations Act of the year following its enactment into law and thereafter.

SECTION 5. Implementing Rules and Regulations. - Within sixty (60) days after the affectivity of this Act, the Secretary of Health shall promulgate the necessary rules and regulations for the effective implementation of this Act.

SECTION 6. Separability Clause. - If any provision of this Act, or any parts thereof, is declared unconstitutional, the same shall not affect the validity and effectivity of the other portions.

SECTION 7. Repealing Clause. — All laws, executive orders, presidential decrees,

proclamations, rules, regulations, issuances and enactments of parts thereof inconsistent with this Act are hereby repealed or modified accordingly.

SECTION 8. Effectivity. — This Act shall take effect fifteen (15) days from its complete publication in the Official Gazette or in a newspaper of general circulation in the Philippines, whichever comes earlier.
