EXPLANATORY NOTE

This bill is a refilled version of House Bill 1462 that was approved by the House on June 6, 2015 and transmitted to and received by the Senate on June 4, 2015.

This measure aims to complete the creation of Barangay Poblacion 2 in the Municipality of Villanueva, Province of Misamis Oriental.

Barangay Poblacion 2, Villanueva, Misamis Oriental has a population of 2,227 as of the latest Census of Population and Housing (2010). Currently, it does not get its Internal Revenue Allotment shares as mandated in the Local Government Code of 1991 and is thus not capable of effectively delivering the social and governance services to its constituencies.

Thus, the people and local government of Barangay Poblacion 2 are earnestly requesting for the approval of this measure.

The passage of this bill is earnestly sought.

AN ACT
CREATING A BARANGAY TO BE KNOWN AS BARANGAY POBLACION 2 IN
THE MUNICIPALITY OF VILLANUEVA, PROVINCE OF MISAMIS ORIENTAL

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

SECTION 1. *Creation of Barangay Poblacion 2.* – There is hereby created a barangay to be known as Barangay Poblacion 2 in the Municipality of Villanueva, Province of Misamis Oriental.

SECTION 2. *Territorial Boundaries.* – The technical description of Barangay Poblacion 2 shall be as follows:

SECTION 3. *Conduct and Supervision of Plebiscite.* – The plebiscite conducted and supervised by the Commission on Elections (COMELEC) pursuant to Provincial Ordinance No. 914-2006 of the Sangguniang Panlalawigan of the Province of Misamis Oriental which ratified the creation of Barangay Poblacion 2 as proclaimed by the Plebiscite Board of Canvassers on April 22, 2006 shall serve as substantial compliance to the plebiscite requirement under Section 10 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991.

SECTION 4. *Barangay Officials.* – The incumbent elected barangay officials of Barangay Poblacion 2, Municipality of Villanueva, Province of Misamis Oriental shall continue to hold office until such time that their successors have been duly elected and qualified.

SECTION 5. *Public Infrastructures and Facilities.* – All existing public infrastructure and facilities for public use existing therein at the time of the approval of this Act are hereby transferred without cost or compensation to the new barangay and shall be administered by the same.

SECTION 6. *Internal Revenue Allotment Shares.* – Barangay Poblacion 2 shall be entitled to Internal Revenue Allotment shares pursuant to Section 285 of Republic Act No. 7160, as amended, otherwise known as the “Local Government Code of 1991”.

SECTION 7. *Effectivity Clause.* – This Act shall take effect fifteen (15) days after its publication in any newspaper of general circulation.
