**AN ACT REINSTITUTING THE MANDATORY DRUG TESTING  
FOR APPLICATION/RENEWAL OF DRIVER'S LICENSE,  
THEREBY REPEALING A PORTION OF SECTION 19 OF  
REPUBLIC ACT NO. 10586**

***EXPLANATORY NOTE***

The use of illegal drugs has been documented to alter perception and therefore pose a hazard not only to the driver himself but also to the public. Considering hazards caused by these substances, it is the policy of the State to ensure the road safety of motorists by providing policies that would help prevent further risks caused by illegal drugs and similar substances.

The mandatory drug testing provision under Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002, prior to its repeal by Republic Act No. 10586 served as an effective measure in preventing drug users from becoming licensed drivers. Data from the Land Transportation Office (LTO) in 2013 reveal that more than 6,000 applications for driver's licenses were rejected in the first four months of the same year after said applicants tested positive for illegal use of drugs. Thus, mandatory drug test as a preventive measure enables the State to protect its citizens from the dangers of having drug users as licensed drivers.

This bill aims to revive the mandatory drug testing for the application/renewal of driver's license in consonance with this administration's war against illegal drugs. It further mandates the LTO to conduct a periodic review of drug testing laboratories relative to the number of incidence of drivers who had been issued drug-free certifications but were subsequently apprehended for driving under the influence of drugs. This is to warrant the credibility of mandatory drug testing as a preventive measure and a deterrence of dangerous drug use among drivers.

In view of the foregoing, the early passage of this bill is earnestly requested.

**AN ACT REINSTITUTING THE MANDATORY DRUG TESTING FOR APPLICATION/RENEWAL OF DRIVER'S LICENSE, THEREBY REPEALING A PORTION OF SECTION 19 OF REPUBLIC ACT NO. 10586**

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

**SECTION 1. Mandatory Drug Testing.** – Subparagraph (a), Section 36, Article III of Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002 is hereby reinstated.

**SECTION 2. Periodic Review of Drug Test Certificates Issued.** – The Land Transportation Office (LTO) shall conduct a periodic review of drug testing clinics or laboratories that had issued drug-free certifications in favor of applicants which led to the corresponding issuance of their driver's licenses, but who were subsequently apprehended for driving under the influence of drugs.

The high rate of incidence of drivers driving under the influence of drugs relative to drug-free certifications shall be a ground for the suspension or revocation of the certificate of accreditation of said clinic or laboratory.

**SECTION 3. Repealing Clause.** – A portion of Section 19 of Republic Act No. 10586 and all other laws, decrees, executive orders, memorandum circulars inconsistent with the provisions of this Act are hereby amended, repealed or modified accordingly.

**SECTION 4. Effectivity.** – This act shall take effect fifteen (15) days after its publication in the Official Gazette or in two (2) newspapers of general circulation.
