
AN ACT  
ESTABLISHING A NATIONAL BUREAU OF INVESTIGATION (NBI)  
DISTRICT OFFICE IN THE MUNICIPALITY OF MALAY, AKLAN,  
APPROPRIATING FUNDS THEREFOR, AND FOR OTHER  
PURPOSES

EXPLANATORY NOTE

The Municipality of Malay, where the island of Boracay is situated, lies on the western side of the province of Aklan. Among the seventeen (17) Municipalities comprising the Province of Aklan, the Municipality of Malay is the second most populated, with 52,973 people residing in the area, according to the latest census conducted by the Philippine Statistics Authority in 2015. In order to cater to the need of a growing population, a subsidiary authority of national executive offices, such as the National Bureau of Investigation, is most desired at the local level.

The significance of having a National Bureau of Investigation District Office lies not only for the issuance of clearances most commonly used as requirement for employment opportunities, but also for seeking for assistance of the public for the probe of matters within its mandate.

In view of the foregoing, the earnest passage of this bill is sought.

AN ACT  
ESTABLISHING A NATIONAL BUREAU OF INVESTIGATION  
(NBI) DISTRICT OFFICE IN THE MUNICIPALITY OF MALAY,  
AKLAN, APPROPRIATING FUNDS THEREFOR, AND FOR  
OTHER PURPOSES

*Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:*

1 **SECTION 1. *Establishment.*** - There shall be established a National Bureau of  
2 Investigation District Office at the Municipality of Malay, Province of Aklan, to be  
3 known as the NBI-Malay District Office.

4  
5 **SEC. 2. *Rules and Regulations.*** - The Director of the National Bureau of Investigation  
6 shall issue rules and regulations as may be necessary for the effective implementation  
7 of this Act.

8  
9 **SEC. 3. *Appropriations.*** - The Director of the National Bureau of Investigation shall  
10 immediately include in the programs of the National Bureau of Investigation the  
11 operationalization of the NBI-Malay District Office, the initial funding of which shall  
12 be charged against the current year's appropriations of the National Bureau of  
13 Investigation. Thereafter, the amount necessary for the continued operation of the said  
14 District Office shall be included in the annual General Appropriations Act.

15  
16 **SEC. 4. *Repealing Clause.*** - All laws, decrees, orders, rules and regulations or other  
17 issuances or parts thereof inconsistent with the provisions of this Act are hereby  
18 repealed or modified accordingly.

19  
20 **SEC. 5. *Separability Clause.*** - If any portion or provision of this Act is declared  
21 unconstitutional, the remainder of this Act or any provisions not affected thereby shall  
22 remain in force and effect.

23  
24 **SEC. 6. *Effectivity.*** - This Act shall take effect after fifteen (15) days following the  
25 completion of its publication either in the Official Gazette or in a newspaper of general  
26 circulation in the Philippines.
