**EXPLANATORY NOTE**

This bill seeks to declare the Cebu Safari and Adventure Park in the Municipality of Carmen, Province of Cebu, a tourist destination of the Philippines.

Section 1, Article XII of the 1987 Philippine Constitution provides that the goals of the national economy are a more equitable distribution of opportunities, income, and wealth; a sustained increase in the amount of goods and services produced by the nation for the benefit of the people; and an expanding productivity as the key to raising the quality of life for all, especially the underprivileged.

Furthermore, Republic Act No. 9593 or the Tourism Act of 2009 declared tourism as an indispensable element of the national economy that shall spur socio-economic growth, investment and employment in the country.

The Municipality of Carmen is a 3<sup>rd</sup> income class municipality located in the Fifth District of the Province of Cebu. According to the 2015 census, it has a population of 51,325 people. It is bordered on the North by the town of Catmon, to the West by the town of Tuburan, on the East by the Camotes Sea, and on the South by the City of Danao. Carmen is comprised of 21 barangays, and the main industries in the municipality are mango farming, manufacturing, home décor & furniture, and sinamay (an abaca product).

The Municipality of Carmen is popularly known as the home of the largest safari in the Philippines, the Cebu Safari and Adventure Park.

The Cebu Safari and Adventure Park is a 170-hectare development with some 1,200 animals imported from Spain, Australia, US, Africa, and other parts of the world. Founded in 2018, the Park also caters to adventure seekers with its very own Adventure Park which features one of the longest and highest Ziplines in the country at 1.3 kms. long and 671 m. above sea level.

The Cebu Safari and Adventure Park is also home to a zoological and botanical complex that is the only one of its kind in the Philippines. It is becoming one of the emerging tourist

1 destinations in the northern Cebu because of its diverse attractions, such as African Savanna,  
2 Michelle's Garden, Gardens of the World, and the White Lion Safari.\

3 Recognizing its enormous potential to contribute to the country's roster of tourism  
4 destinations as a phenomenally well-developed attraction in Southeast Asia, this Bill is filed to  
5 declare officially as a tourism destination the Cebu Safari and Adventure Park located in the  
6 Municipality of Carmen in the Fifth District of the Province of Cebu.

7 Developing the said Safari will generate investment and foreign exchange in the area and  
8 will also provide employment opportunities for local residents. With the influx of tourists, these  
9 tourist spots will also be a significant source of business opportunities that can support local  
10 entrepreneurship and livelihood in Cebu.

11 In view of the foregoing, approval of this Bill is earnestly requested.

12 **AN ACT**  
13 **DECLARING THE CEBU SAFARI AND ADVENTURE PARK IN THE**  
14 **MUNICIPALITY OF CARMEN, PROVINCE OF CEBU, AS A TOURIST SPOT AND**  
15 **APPROPRIATING FUNDS THEREFOR**  
16

17 Be it enacted by the Senate and House of Representatives of the Philippines in Congress  
18 assembled:  
19

20  
21 Section 1. The Cebu Safari and Adventure Park located in the Municipality of Carmen,  
22 Fifth District of the Province of Cebu, is hereby declared as a tourist spot. This is located in  
23 Barangay Corte in the Municipality of Carmen.  
24

25 As such, the development of this tourist spot as well as the access roads leading thereto  
26 shall be prioritized by the Department of Tourism (DOT), subject to the rules and regulations  
27 governing the development of tourist destinations.  
28

29 Section 2. Within one (1) year from the approval of this Act, the DOT, in coordination with  
30 the concerned local government units and agencies of the government, shall prepare a tourism  
31 development plan containing, among others, the construction, installation and maintenance of such  
32 appropriate facilities and infrastructure that shall encourage tourism in the area.  
33

34 Section 3. The DOT shall take immediate steps to implement the development plan and  
35 incorporate the same in its tourism development program for the ensuing calendar year.  
36

37 Section 4. The Secretary of the DOT shall include in its Department's program the  
38 implementation of this Act, the funding of which shall be included in the annual General  
39 Appropriations Act from internally generated funds of the DOT.  
40

41 Section 5. This Act shall take effect fifteen (15) days after publication in the Official  
42 Gazette or in a newspaper of general circulation.  
43

44 Approved,  
45
