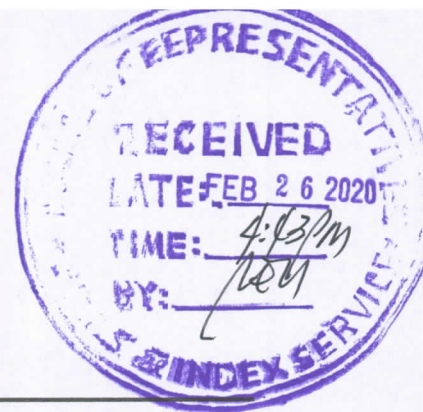

**RESOLUTION**

**COMMENDING THE NUEVA SEGOVIA CONSORTIUM OF COOPERATIVES FOR ITS OUTSTANDING ACHIEVEMENT AND LEADERSHIP IN THE UPLIFTMENT AND DEVELOPMENT OF COOPERATIVES IN THE COUNTRYSIDE**

**WHEREAS**, on September 17, 1992, the Nueva Segovia Consortium of Cooperatives (NSCC) was registered with the Cooperative Development Authority with 18 church based cooperatives from different parts of Ilocos Sur as pioneer members;

**WHEREAS**, the concept of establishing the NSCC started with a goal of the Archdiocese of Nueva Segovia to help, serve and achieve a holistic development of people within all barangays and municipalities of the Province of Ilocos Sur, to gather big and small cooperatives from different parts of Ilocos Sur, including those in the mountain areas, to create one strong cooperative and ensure economic progress;

**WHEREAS**, the NSCC has diversified business endeavors after making several innovations on its programs and services that changed its membership structure, area of operation, and manpower;

**WHEREAS**, the NSCC has been providing its members with financial services, agro-enterprise and marketing, capability building trainings, tourism and social services, and established other institutions for the mutual benefit of the federation and its members, as well as multi-purpose cooperatives to serve the individual regular members;

**WHEREAS**, stepping beyond the sphere of its entrepreneurial goals, and in the fulfillment of its social responsibility, NSCC established Macro-NSCC Colleges, Inc. to help provide affordable education for the youth sector especially the children of the members of the cooperatives;

**WHEREAS**, the sincere determination of the NSCC to serve was duly recognized and received the following awards and recognitions: Gawad Parangal Winner as Best Performing Cooperative Federation by the Cooperative Development Authority (2013-2015); Third National Winner of CDA Gawad Parangal Award for Most Outstanding Cooperative Leader in 2015; Third Best Performing Cooperative Federation in 2015; and Sipag Awards Winner as Most Outstanding Microfinance Institution in Luzon by the National Livelihood Development Corporation in 2012 and 2013;

**WHEREAS**, the success of the Nueva Segovia Consortium of Cooperatives is a product of innovative and energetic leadership driven by hardworking, skillful, humble, and dedicated men and women, and it is most fitting to recognize their commitment towards the upliftment of lives in the countryside and their continuous aspiration to make cooperatives catalysts for progressive communities and empowered people: Now, therefore, be it
