Higher and Technical Education	HBs 1583, 1942, 2635, 2771, 3427 & 3452	Reps. Vargas, Santos-Recto, Gatchalian, Salceda, Tan (S.), and Villarín	Providing full tuition subsidy for students enrolled in state universities and colleges (SUCs) and appropriating funds therefor	<p>The Committee, chaired by Rep. Ann Hofer (2<sup>nd</sup> District, Zamboanga Sibugay), agreed to create a technical working group (TWG) to study and harmonize the 50 bills providing free education to qualified students.</p> <p>The authors present during the meeting manifested that the explanatory note to their bills be registered as their respective sponsorship speeches.</p> <p>Commission on Higher Education (CHED) Commissioner Minella Alarcon signified the CHED's support to the proposed measures, and promised to submit to the Committee its position paper.</p> <p>Jephte Muñoz, a consultant of the Unified Student Financial Assistance System for Tertiary Education (UniFAST) Board, reported that the Board, in its previous meeting, agreed that the guidelines for the first year of implementation of the free tuition fee program pursuant to RA 10687 is set to be finalized by February 15, 2017.</p> <p>He mentioned that RA 10687 or the UniFAST Law, which was enacted on July 27, 2015, provides for a comprehensive and unified financial assistance system for tertiary education in both public and private institutions, including scholarships, grants-in-aid, and student loans.</p> <p>Reps. Hofer and Celso Lobregat (1<sup>st</sup> District, Zamboanga City) asked the CHED to submit a report on the actual number of enrollees per SUC in every province and the actual cost of tuition per SUC before the TWG's scheduled meeting next week, to determine the impact of the proposed measures on public funds.</p> <p>The Members of the Committee agreed to invite CHED Chair Patricia Licuanan, as well as representatives from the Coordinating Council of Private Educational Associations (COCOPEA) and the Private Education Retirement Annuity Association (PERAA), to attend the TWG meeting.</p>

Legislative Franchises	HB 1941	Rep. Espino	Granting the Gulf Waves Communications Corporation (GWCC) a franchise to construct, install, establish, operate and maintain radio and television broadcasting stations throughout the Philippines	<p>The Committee, chaired by Rep. Franz “Chicoy” Alvarez (1<sup>st</sup> District, Palawan), agreed to create a technical working group (TWG) to come up with recommendations on the bill, taking into consideration the comments made during the meeting.</p> <p>AKO Bicol Party-List Rep. Rodel Batocabe asked the National Telecommunications Commission (NTC) how the bill can cover other operations of franchise applicants, aside from radio and television broadcasting, that involve the use of the internet and other information and communications technologies.</p> <p>NTC Deputy Commissioner Edgardo Cabarios said that franchise grantees can operate new and emerging technologies, like the internet, if this is stated in the legislative franchise itself.</p>

Continuation... Legislative Franchises	HB 1422	Rep. Cosalan	Renewing the franchise granted to Satellite Paging Systems Philippines, Inc. (presently known as Now Telecom Company, Inc.) under RA 7301, as amended by RA 7940, or the law granting the Satellite Paging Systems Philippines, Inc. a franchise to construct, establish, operate and maintain radio paging systems and trunked radio systems within the Philippines for a period of 25 years	<p>The Committee will deliberate further on HB 1422 in its next meeting.</p> <p>To determine the financial capacity of Now Telecom to operate and maintain its radio paging systems, Rep. Batocabe required the company to submit its financial statements, income tax returns (ITRs) for the past 25 years, and other pertinent documents.</p> <p>Now Telecom Company's Corporate Secretary Angeline Macasaet said that the company can only submit a copy of its ITRs for the last three years and a copy of the general information sheet submitted annually to the Securities and Exchange Commission (SEC).</p> <p>When asked by Rep. Johnny Pimentel (2<sup>nd</sup> District, Surigao del Sur) if the company is applying for tax exemptions, Macasaet answered in the negative.</p> <p>On the request of KABAYAN Party-List Rep. Harry Roque Jr., Macasaet promised to submit her company's business plan and other related documents.</p> <p>The NTC endorsed the approval of the bill.</p>
	HB 3864	Rep. Go (M.)	Amending and renewing the franchise granted to Beta Broadcasting System, Inc. to construct, install, establish, operate and maintain radio broadcasting stations in the Philippines	<p>The Committee will deliberate further on HB 3864 in its next meeting.</p> <p>The Committee agreed to delete Section 8 (Tax Provisions) of the bill because, according to Rep. Batocabe, all legislative franchise holders are required to pay all taxes, duties, fees or charges and other impositions under the National Internal Revenue Code of 1997 and other applicable laws, unless granted an exemption.</p> <p>The NTC endorsed the approval of the bill.</p>
	HB 4464	Deputy Speaker Hernandez	Renewing the franchise granted to Subic Broadcasting Corporation under Republic Act 7511 or the law granting the Subic Broadcasting Corporation a franchise to construct, install, operate and maintain radio and television broadcasting stations in the Philippines for another 25 years	<p>The Committee will deliberate further on HB 4464 in its next meeting.</p> <p>Deputy Speaker Ferdinand Hernandez (2<sup>nd</sup> District, South Cotabato) apprised the Committee of the track record and various accomplishments of the Subic Broadcasting Corporation for the past 25 years.</p> <p>Rep. Rodrigo Abellanosa (2<sup>nd</sup> District, Cebu City) underscored the need to monitor the compliance of grantees with the provisions of their respective franchises, and to revoke their franchise if they fail to do so.</p> <p>The Committee agreed to invite the SEC to give its comments on the franchise bills.</p>
