Aurelio "Dong" Gonzales Jr. (3rd District, Pampanga), author of HR 654, explained that his resolution aims to determine whether the sale of the <i>Paskuhan</i> Village located in San Fernando, Pampanga was in order and to explore alternatives to boost Pampanga's local tourism.</p> <p>TIEZA Chief Operations Officer Guiller Asido explained that pursuant to RA 9593 or the Tourism Act of 2009, TIEZA is authorized to regulate and supervise tourism enterprise zones (TEZs) established by law, as well as develop, manage, and supervise tourism infrastructure projects in the country. Asido added that TIEZA has the power to sell government properties in the best interest of the country.</p> <p>Rep. Gonzales requested the Register of Deeds of the City of San Fernando, Atty. Lorna Dee, to hold the transfer of the title of the property occupied by <i>Paskuhan</i> Village to the buyer while the Committee is still conducting the inquiry.</p> <p>Early on, Dee informed the Committee that the title has not been transferred to the buyer (SMDC) yet because it still needs to secure a Certificate Authorizing Registration (CAR) from the Bureau of Internal Revenue (BIR), which will certify that the transfer and conveyance of the property was reported and the taxes due have been fully paid.</p> <p>BIR San Fernando Regional Director Jethro Sabariaga disclosed that the buyer has already paid the documentary stamp tax due on the sale, but is seeking exemption from the payment of the capital gains tax.</p> <p>Deputy Speaker Gwendolyn Garcia (3rd District, Cebu) manifested that all government officials and private individuals involved, including the members of the Bids and Awards Committee (BAC) that facilitated the transaction, be invited in the next meeting to clarify issues themselves instead of the current officers answering for them.</p> <p>TIEZA was directed to submit its position paper on the matter and other pertinent documents with regard to the sale of <i>Paskuhan</i> Village.</p>

Human Rights				<p>Chair of the Committee on Human Rights during the 13th Congress and currently the chair of the BIBLEMODE, opposed the inclusion of “sex, gender, sexual orientation, and gender identity” within the anti-discrimination’s legal framework. He explained that “far from fostering equality, the proposed law creates a class of citizens protected in a matter that is more advantaged than the general citizenry,” in violation of the equal protection clause of the Constitution. It can give rise to a new form of discrimination by socially isolating certain religious and moral beliefs and principles, he added.</p> <p>Rep. Mawared Services, which processes visas for Filipinos bound for Kuwait, only accepts medical certificates issued by the medical clinics accredited by Winston Q8, as supporting documents to visa applications.</p> <p>On the query of Rep. Estrellita Suansing (1st District, Nueva. Ecija), Securities and Exchange Commission (SEC) General Counsel Camilo Correa said that Winston Q8 and Mawared are locally registered companies, incorporated last 2015. Camilo added that based on the articles of incorporation of Winston Q8, the company's primary purpose is general business consulting. He promised to submit to the Committee certified true copies of the companies' documents that were submitted to SEC.</p> <p>Assistant Secretary Agnette Peralta of the Department of Health (DOH) disclosed that both Winston Q8 and Mawared are neither recognized nor accredited by the DOH.</p> <p>The DOH and Philippine Competition Commission (PCC) were directed to conduct their own investigation on this issue and to present their findings to the Committee.</p> <p>The Committee will invite the owners of the eight medical clinics accredited by Winston Q8 in its next meeting. (Source: UNFCCC website)</p> <p>The Instrument of Accession is a document signifying the Philippines' ratification of the agreement, while the COCs serve as an assurance that the concerned agency understands and approves the agreement and vows to do its share in implementing the country's commitments under the deal.</p> <p>CCC Assistant Secretary Rommel Cuenca reported that, of the 95 PSF project proposals received by the CCC, two projects are already approved costing P119.75 million, while seven projects with an aggregate cost of P962.73 million are still on the pipeline.</p> <p>Cuenca said that the PSF is a special fund in the National Treasury that is earmarked to finance climate change adaptation programs and projects. The PSF has an annual budget of P1 billion.</p> <p>The CCC will again be invited in the next meeting of the Committee to present a more detailed report on the PSF.</p>
<p>Overseas Workers Affairs</p>	<p>Update on the situation of stranded overseas Filipino workers (OFWs) in Saudi Arabia, particularly those affected workers from the Mohammad Al-Mojil Group</p>	<p>The Committee, chaired by BUHAY Party-List Rep. Mariano Michael Velarde Jr., will continue its discussion on the situation of stranded OFWs in the Kingdom of Saudi Arabia (KSA) in its next meeting.</p> <p>Assistant Secretary Grace Princesa of the Department of Foreign Affairs (DFA) reported that Saudi Arabia's King Salman bin Abdulaziz Al-Saud already issued a royal decree directing the release of all monetary claims due to the displaced OFWs. She went on to say that the Saudi Ministry of Justice had already appointed lawyers to represent the OFWs in filing their claims, explaining that only lawyers who are Saudi nationals are recognized by the Saudi court system.</p> <p>In 2016, thousands of OFWs in Saudi were retrenched by Saudi-based construction companies which were financially affected by the plummeting oil prices.</p> <p>Assistant Secretary Hope Hervilla of the Department of Social Welfare and Development (DSWD) reported that the affected OFWs from KSA already received relief assistance, transportation assistance, and other support services from the Department.</p> <p>Atty. Robert Chuan, officer-in-charge of the Legal Staff Division of the Overseas Workers Welfare Administration (OWWA), reported that the agency has allocated P500 million for the affected OFWs in Saudi Arabia, through its Relief Assistance Program (RAP). Those who were already repatriated were given P20,000 each. Each family of OFWs who are still in KSA were also given P6,000. Chuan added that OWWA also distributed food and hygiene kits to the stranded OFWs at KSA and covered the post-repatriation service expenses of repatriated OFWs who stayed at the OWWA halfway home.</p> <p>Executive Director Luz Victoria Amponin of the Technical Education and Skills Development Authority (TESDA) said that since January of this year, 491 out of the 5,000 profiled OFWs have availed themselves of TESDA's scholarship program. TESDA also offers free competency assessment and certification, and technical-vocational training to interested OFWs or to their family members.</p> <p>Reps. Winston "Winnie" Castelo (2nd District, Quezon City) and Wes Gatchalian (1st District, Valenzuela City) stressed that with what is happening now with the OFWs in Saudi, the immediate passage of the proposed law creating a Department of Overseas Filipino Workers</p>
