Cesar Sarmiento, will deliberate further on the draft substitute bill in its next meeting. At the outset, Rep. Sarmiento remarked that the objectives of the proposed law are: to improve pilotage services through a liberalized pilotage service; prevent maritime accidents and ensure navigational safety; and regulate pilotage fees and charges.			
				At present, the pilotage services are provided only by harbor pilots affiliated with the United Harbor Pilots' Association of the Philippines, Inc. (UHPAP), the umbrella organization of harbor pilot associations rendering pilotage service in the different port districts of the Philippines.			
				Expressing his support for the proposed law, Philippine Inter-Island Shipping Association (PISA) Executive Director Peter Aguilar claimed that notwithstanding the existence of Executive Order 1088, which provides for uniform and modified rates			

		for pilotage services, the PISA members are still being charged exorbitantly.
		The Philippine Ports Authority (PPA) was requested to submit data on its pilotage revenues from all pilotage districts.
		The resource persons were requested to submit their respective position papers on the proposed law.
