At 4:00 p.m., Deputy Speaker Sharon S. Garin called the session to order.

THE DEPUTY SPEAKER (Rep. Garin, S.). The session is now called to order.

NATIONAL ANTHEM

THE DEPUTY SPEAKER (Rep. Garin, S.). Everybody is requested to rise for the singing of the National Anthem.

Everybody rose to sing the Philippine National Anthem.

PRAYER

THE DEPUTY SPEAKER (Rep. Garin, S.). Please remain standing for a minute of silent prayer and meditation.

Everybody remained standing for the silent prayer.

THE DEPUTY SPEAKER (Rep. Garin, S.). Thank you.

The Dep. Majority Leader is recognized.

ROLL CALL

REP. BONDOC. Mme. Speaker, I move that we call the roll.

THE DEPUTY SPEAKER (Rep. Garin, S.). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.

The Secretary General will please call the roll.

The Secretary General called the roll, and the result is reflected in Journal No. 36, dated October 11, 2017.*

THE SECRETARY GENERAL. The Speaker is present.

Mme. Speaker, the roll call shows that 238 Members responded to the call.

THE DEPUTY SPEAKER (Rep. Garin, S.). With 238 Members responding to the call, the Chair declares the presence of a quorum.

The Dep. Majority Leader is recognized.

REP. BONDOC. Mme. Speaker, I move that we defer the approval of the Journal.

I so move, Mme. Speaker.

THE DEPUTY SPEAKER (Rep. Garin, S.). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.

CONSIDERATION OF H. RES. NO. 1397 RE: DISMISSAL OF IMPEACHMENT COMPLAINT AGAINST COMELEC CHAIRMAN ANDRES D. BAUTISTA

REP. BONDOC. Mme. Speaker, I move that we consider House Resolution No. 1397, contained in Committee Report No. 429.

May I ask that the Secretary General be directed to read only the title of the measure.

THE DEPUTY SPEAKER (Rep. Garin, S.). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.**

The Secretary General is directed to read only the title of the measure.

With the permission of the Body, and since copies of the measure have been previously distributed, the Secretary General read only the title thereof without prejudice to inserting its text in the Congressional Record.

THE SECRETARY GENERAL, House Resolution No. 1397, entitled: RESOLUTION DISMISSING THE IMPEACHMENT COMPLAINT FILED BY JACINTO V. PARAS AND FERDINAND S. TOPACIO AGAINST

COMMISSION ON ELECTIONS CHAIRMAN ANDRES D. BAUTISTA.

THE DEPUTY SPEAKER (Rep. Garin, S.). The Dep. Majority Leader is recognized.

REP. BONDOC. Mme. Speaker, I move that we recognize to sponsor the adoption of the Committee Report, our honorable Chairman of the Committee on Justice, the Gentleman from the Second District of Oriental Mindoro, the Hon. Reynaldo V. Umali.

I so move, Mme. Speaker.

THE DEPUTY SPEAKER (Rep. Garin, S.). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.

REP. UMALI. Thank you, Mme. Speaker, distinguished Members of this august Body.

I hereby submit as Chair of the Committee on Justice Committee Report No. 429, which is a resolution dismissing the impeachment complaint filed by Jacinto V. Paras and Ferdinand S. Topacio against Commission on Elections Chairman Andy Bautista. To abbreviate my sponsorship remarks, may I just read into the records, Mme. Speaker, the dispositive portion of this report, and I quote:

WHEREFORE, premises considered, the Committee on Justice finds, resolves and concludes that the impeachment complaint filed by complainants Paras and Topacio against COMELEC Chairman Bautista is INSUFFICIENT IN FORM. Accordingly, and pursuant to the previous ruling of the Committee during the impeachment proceedings against President Duterte as contained in Committee Report No. 257 and adopted by the House in Plenary on May 30, 2017, the said complaint is hereby DISMISSED.

So, Mme. Speaker, I hereby submit this Committee Report for the consideration of the Body.

At this juncture, Deputy Speaker Garin relinquished the Chair to Deputy Speaker Raneo "Ranie" E. Abu

THE DEPUTY SPEAKER (Rep. Abu). The Majority Leader is recognized.

REP. FARIÑAS. We second the...

REP. LAGMAN. Mr. Speaker. Mr. Speaker.

REP. BARBERS. Mr. Speaker.

REP. FARIÑAS. I move that we recognize Hon. Gwendolyn F. Garcia of Cebu, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Abu). Hon. Gwen Garcia from Cebu is recognized.

REP. GARCIA (G.). Thank you, Mr. Speaker.

This Representation must object to the Committee Report consistent with my position that the impeachment complaint with the charges contained therein must be heard and tried in the Senate, perhaps, also, in order for Chairman Bautista to be given the opportunity to answer these charges, and so, I must object to the Committee Report, Mr. Chair.

THE DEPUTY SPEAKER (Rep. Abu). The Majority Leader is recognized.

REP. FARIÑAS. I move that the Gentleman from Surigao del Norte, the Hon. Robert Ace S. Barbers, be recognized, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Abu). Hon. Ace Barbers from Surigao del Norte is recognized.

REP. BARBERS. Thank you, Mr. Speaker. Thank you, Majority Leader, and of course, thank you to the good Chairman of the Committee on Justice.

Following the thoughts of our distinguished colleague, Congresswoman Garcia, this Representation likewise objects to the Committee Report in order for the Committee to give the Chairman of the Commission on Elections the opportunity to explain because it is perceived that there were some infractions that were committed by no less than the Chair of the Commission and we never heard any reply to the accusations hurled at him.

So, Mr. Speaker, Majority Leader, and to all my distinguished colleagues, I object to the adoption of the Committee Report.

THE DEPUTY SPEAKER (Rep. Abu). Majority Leader.

REP. FARIÑAS. Mr. Speaker.

REP. LAGMAN. Mr. Speaker. Mr. Speaker.

REP. FARIÑAS. I move that the Gentleman from Albay be recognized.

THE DEPUTY SPEAKER (Rep. Abu). The Gentleman from the First District of Albay, Honorable Lagman, is recognized.

REP. LAGMAN. Thank you, Mr. Speaker. May we ask the distinguished Chairman of the Committee

on Justice to tell and explain to this Body why the Committee—why the impeachment complaint against COMELEC Chairman Andy Bautista was dismissed for insufficiency in form.

I think, the Members of the Chamber of this House of Representatives should be informed on the basis of the dismissal of the complaint filed against COMELEC Chairman Andy Bautista.

THE DEPUTY SPEAKER (Rep. Abu). The Majority Leader is recognized.

REP. FARIÑAS. I move that the Sponsor...

THE DEPUTY SPEAKER (Rep. Abu). Is the distinguished Sponsor willing to reply to the question of the Gentleman from Albay?

REP. UMALI. Gladly, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Abu). Proceed.

REP. UMALI. The impeachment complaint was dismissed and was recommended for dismissal after the Committee members, on a vote of two in favor of the sufficiency, and 25 or 26 against the same, voted to dismiss the complaint for insufficiency in substance by reason of the defective verification that was signed by the complainants.

And so, by reason of that, there was a lengthy discussion on the matter and notwithstanding that the Committee and the majority of the Members or one-half or the majority of the Members voted to dismiss the same for insufficiency in form.

REP. LAGMAN. Thank you, distinguished Chairman.

But I was asking, what was the reason for saying that the complaint against COMELEC Chairman Andy Bautista was defective in form? What was the finding of the Committee where the vote was overwhelmingly in favor of declaring the impeachment complaint insufficient in form?

REP. UMALI. If I may just read, the verification made by the complainants Jacinto Paras or former Congressman Paras, and Atty. Ferdinand Topacio, if I may just go over these documents—anyway, it did not conform to the rules. I do not have the complaint with me now, but it did not contain the verification as required by our rules. The verification stated that the complainants had personal knowledge and/or belief of the allegations contained therein, which is not consistent with how our rules require that it must be based on authentic records and no authentic records were appended to the complaint and for which reason, it was dismissed for insufficiency in form.

REP. LAGMAN. Thank you, distinguished Chairman, but let me just quote from the Committee Report of the Committee on Justice with respect to this particular issue, and I quote passages from page 11.

After the discussions for and against the motion of Rep. Roque to admit the substitute verification, there being several objections to the said motion, the Chair put the matter to a vote. With only two (2) votes in favor, and twenty-seven (27) against, the motion of Rep. Roque to admit the substitute verification was DENIED.

I recall that among those who objected to the admission of the substitute verification was no less than our distinguished Majority Leader.

Let me continue:

Having denied the motion to admit the substitute verification, the Committee proceeded to deliberate on the sufficiency in form of the Paras-Topacio Complaint as filed. Rep. Gwendolyn Garcia, another endorser of the Paras-Topacio Complaint, moved to find the said complaint sufficient in form. The motion was objected to by Reps. Lagman, Roger Mercado, Oaminal, Salo and Vincent Crisologo.

The objectors noted that the Verification in Paras-Topacio Complaint, as filed, states that the allegations in the complaint are true and correct based on the "knowledge and belief" of the complainants, and based on their "reading and appreciation of documents and other records pertinent thereto." The same arguments and objections to the previous motion of Rep. Roque were also raised by the objectors to the motion of Rep. Garcia, especially considering that Verifications based on "knowledge and belief" are considered as unsigned pleadings under case law. It was also noted that the fact that the complainants filed a substitute verification is an admission that the original verification of the complainants to the impeachment complaint was defective as to form.

Will the distinguished Chairman confirm?

REP. UMALI. Yes, I do, that is correct.

REP. LAGMAN. That was the established quotation from the Committee Report.

May we know whether the distinguished Chairman of the Committee on Justice is sustaining the report and

requesting the approval of the dismissal of the complaint against COMELEC Chairman Andy Bautista?

REP. UMALI. Yes, I am, Mr. Speaker, Your Honor.

REP. LAGMAN. I join the distinguished Chairman of the Committee on Justice in sustaining the Committee Report and the approval of the dismissal of the complaint against Chairman Andy Bautista as being insufficient in form.

REP. PICHAY. Mr. Speaker, parliamentary inquiry.

THE DEPUTY SPEAKER (Rep. Abu). The Majority Leader is recognized.

REP. FARIÑAS. Our parliamentary status now is that the honorable Chairman of the Committee on Justice submitted the Committee Report of the Committee on Justice finding dismissal of the case. May I refer you, for the benefit of the membership, to Section 11 of Rule No. III of the Rules of Procedure in Impeachment Proceedings.

It states:

Section 11. Where Dismissal Recommended. – When the report of the Committee on Justice dismisses the complaint, it shall submit to the House a resolution for the dismissal of the verified complaint and/or resolution of impeachment. A vote of at least one-third (1/3) of all the Members of the House shall be necessary to override such resolution, in which case the Committee on Justice shall forthwith prepare the Articles of Impeachment.

So, there was a motion for the adoption of the report which was objected to. Now, I move, Mr. Speaker, that we divide the House by voting by ...

THE DEPUTY SPEAKER (Rep. Abu). By roll call.

REP FARIÑAS. ... roll call, pursuant to Section 12 of our Rules.

REP. PICHAY. Mr. Speaker, parliamentary inquiry, please.

NOMINAL VOTING

THE DEPUTY SPEAKER (Rep. Abu). We are now in the process of voting. The Secretary General is directed to call the roll of Members for voting on

the dismissal of the impeachment complaint against COMELEC Chairman Andres Bautista.

The Chair directed the Secretary General to call the roll for nominal voting. Thereafter, pursuant to the Rules of the House, a second roll call was made. The result of the voting is reflected in Journal No. 36, dated October 11, 2017.*

REP. PICHAY. Mr. Speaker, before we go on voting, may I have a parliamentary inquiry. It is very vital to the voting.

THE SECRETARY GENERAL. Roll call of Members, in consideration of House Resolution No. 1397, entitled: RESOLUTION DISMISSING THE IMPEACHMENT COMPLAINT FILED BY JACINTO V. PARAS AND FERDINAND S. TOPACIO AGAINST COMMISSION ON ELECTIONS CHAIRMAN ANDRES D. BAUTISTA.

REP. ACOP. Mr. Speaker, may I be recognized.

THE DEPUTY SPEAKER (Rep. Abu). Yes, Representative Acop.

REP. ACOP. To be consistent with my vote during the Committee hearing, I still move for the dismissal of the case against Chairman Bautista.

REP. ACOSTA. My vote is "Yes."

REP. ALEJANO. Mr. Speaker, I vote "Yes" for the dismissal of the impeachment complaint.

REP. ALVAREZ (P.). Mr. Speaker, I believe that the charges against the Chairman of the Commission on Elections, Chairman Bautista, are very serious. Therefore, I vote "No" on the Committee Report.

Thank you, Mr. Speaker.

REP. ANTONINO. The Representation from the Fourth District of Nueva Ecija votes "No" on the Committee Report.

REP. BAG-AO. Mr. Speaker, I vote "Yes" on the dismissal of the impeachment complaint for insufficiency in form, actually also in substance.

REP. BERTIZ. Mr. Speaker, I vote "No."

REP. BORDADO. Mr. Speaker, I am supporting the position taken by the Committee to dismiss the impeachment charges.

REP. BRAVO (A.). I vote "Yes," Mr. Speaker.

REP. CASTRO (F.H.). Mr. Speaker, consistent with my vote in the Committee level, I vote "Yes" on the Committee Report.

REP. CHIPECO. Mr. Speaker, may I be allowed to explain my vote.

THE DEPUTY SPEAKER (Rep. Abu). After the voting.

REP. CHIPECO. No, just one sentence, Mr. Speaker.

I think this is the chance when we shall be able to give meaning to why all the 33 percent ...

THE DEPUTY SPEAKER (Rep. Abu). What is the vote of the distinguished colleague?

REP. CHIPECO. This is the first time, I think, we shall be able, the House will be able to give meaning as to why it is only 33 percent to overcome the vote and this is also the chance for ...

THE DEPUTY SPEAKER (Rep. Abu). Please state the vote.

REP. CHIPECO. I will cast my vote, Mr. Speaker. This is the chance ...

THE DEPUTY SPEAKER (Rep. Abu). You can explain the vote after the voting.

REP. CHIPECO.... for everybody—for Mr. Bautista to explain very well in the Senate, in impeachment. So, Mr. Speaker, I vote "No."

REP. COJUANGCO. Mr. Speaker, I vote "No."

REP. CRISOLOGO. Mr. Speaker, to be consistent with my stand during the Committee hearing, I vote "Yes" on the Committee Report dismissing the charges against the COMELEC Chairman because of insufficiency in form.

Thank you very much.

REP. DEL MAR. Mr. Speaker, I vote "Yes" for the adoption of the Committee Report.

REP. DIMAPORO (M.). Mr. Speaker, I join our Deputy Speaker, Deputy Speaker Gwen Garcia, in her objection. My vote is "No."

REP. FERRER (J.). Mr. Speaker, consistent with my vote in the Committee level, I vote "Yes."

REP. FORTUN. Mr. Speaker, consistent with my position in the Committee, I vote "Yes" on the Report, dismissing the impeachment complaint.

REP. GARBIN. Mr. Speaker, in consonance with my decision to support the Resolution and the Committee Report, I vote "Yes."

REP. GARCIA (G.). Mr. Speaker, consistent with my position and the position of our respected Speaker of the House of Representatives, I vote "No."

REP. GARIN (O.). I vote "No," Mr. Speaker.

REP. GASATAYA. Mr. Speaker, this Representation votes "No" for the adoption of the Committee Report.

REP. GONZALES (A.D.). I vote "Yes" for the Committee Report.

REP. HERNANDEZ. Mr. Speaker, consistent with my position in the Committee Report, I vote "Yes" to the dismissal of the complaint.

REP. KHO. My vote is "Yes."

REP. LAGMAN. Mr. Speaker, I vote "Yes" and I reserve the right to explain my vote.

REP. MACEDA. Mr. Speaker, to be consistent with having affixed my signature on the Committee Report being tackled today, which means that I agree in toto with everything that is contained in it, I vote "Yes."

REP. MARCOLETA. Mr. Speaker, consistent with my earlier stand in the Committee dismissing the complaint, I vote "Yes."

REP. PRIMICIAS-AGABAS. Mr. Speaker, consistent with my vote in the Committee, I vote "Yes."

REP. RAMIREZ-SATO. Mr. Speaker, I side with the Committee Report dismissing the impeachment complaint on the ground of insufficiency in form. I strongly affirm my vote.

REP. ROQUE (H.). Mr. Speaker, as an endorser of the impeachment complaint, and in support of the vote of my Speaker and Deputy Speaker Gwen Garcia, I vote 'No." Impeach Andres Bautista.

REP. SALIMBANGON. Mr. Speaker, in support of the stand of the Speaker and the objection of Deputy Speaker Garcia, I vote "No." REP. SILVERIO. Mr. Speaker, I am not a lawyer, and consistent with the Committee's Report, wisdom to dismiss the complaint, and after thorough scrutiny by our lawyer-Members, I vote "Yes."

REP. SUAREZ. Mr. Speaker, consistent with my congressional resolution, questioning the performance of the Chairman of COMELEC during the last 2016 elections, I am voting "No."

REP. SY-ALVARADO. Mr. Speaker, kasama po ako ng Committee on Justice na pumapayag na mai-dismiss itong impeachment complaint laban kay Chairman Andy Bautista sa kadahilanang insufficient in form.

Maraming salamat po.

REP. TINIO. Mr. Speaker, I vote "Yes."

REP. TUGNA. Mr. Speaker, consistent with my vote in the Committee level, I vote "Yes."

REP. UMALI. Mr. Speaker, I cannot go against my Committee Report, I vote "Yes."

REP. VELARDE. Mr. Speaker, as well explained by Deputy Speaker Garcia earlier before the voting, I vote "No."

REP. VERGARA. Mr. Speaker, consistent with the spirit that each and every Member of this Body must be given the chance to examine the allegations in a proceeding as serious as an impeachment, I vote in the negative.

REP. VILLARICA. Mr. Speaker, consistent with the position I took in the Committee, I vote "Yes."

REP. VILLARIN. Mr. Speaker, I vote "Yes," having participated in the deliberations of the Committee and I believe there was insufficiency in form in the impeachment complaint.

Thank you, Mr. Speaker.

REP. ZARATE. Mr. Speaker, I vote "Yes" on the Committee Report.

REP. FARIÑAS. I vote "Yes," consistent with my vote in the Committee.

RESULT OF THE VOTING ON H. RES. NO. 1397 RE: DISMISSAL OF IMPEACHMENT COMPLAINT AGAINST COMELEC CHAIRMAN ANDRES D. BAUTISTA

THE DEPUTY SPEAKER (Rep. Abu). The voting on House Resolution No. 1397, under Committee Report

No. 429, shows 75 voted in affirmative, 137 voted in negative, 2 in abstention. It is about House Resolution No. 1397, dismissing the impeachment complaint filed by Jacinto V. Paras and Ferdinand S. Topacio against Commission on Elections Chairman Andres D. Bautista. The vote shows that the resolution is overridden and pursuant to Section 11, Article III of the Rules of Procedure in Impeachment Proceedings, a vote of at least one-third of all the Members of the House shall be necessary to override such resolution, in which case and I am directing the Committee on Justice to prepare the Articles of Impeachment immediately. So ordered.

Hon. Edcel C. Lagman is recognized to explain his vote.

REP. LAGMAN EXPLAINS HIS VOTE

REP. LAGMAN. Thank you, Mr. Speaker.

The vote in the Committee was overwhelming, 26 in favor and 2 against the determination of the Committee that the complaint against COMELEC Chair Bautista is insufficient in form.

With the solid support by the members of the Committee to that determination, I think we should have supported the integrity of our Committee system. The rejection of the Committee Report is a virtual no confidence vote against the leadership of the Committee on Justice.

The dismissal of the impeachment complaint due to insufficiency in form was based on precedent in the case of the *Jimenez-Mallari complaint against the Chief Justice* whose verification was virtually identical to the verification of the impeachment complaint against the COMELEC Chairman. Since both were flawed, the same result should obtain a dismissal based on insufficiency in form. There was even an attempt to file a substitute verification which was a virtual admission that the original verification was defective, fatally defective.

The distinguished Presiding Officer said that the Committee on Justice should now prepare the Articles of Impeachment. To my mind, Mr. Speaker, that is grossly premature because this Chamber voted only on the sufficiency of form because the issue before this Body is whether to sustain or reject the recommendation of the Committee that the impeachment complaint against COMELEC Chairman Andres Bautista is insufficient in form. So, only form was discussed and voted upon this afternoon, Mr. Speaker.

Considering that only the sufficiency in form was voted upon, the Plenary should return to the Committee on Justice, for further proceedings, the complaint against the COMELEC Chair Bautista, ...

THE DEPUTY SPEAKER (Rep. Abu). Your Honor, you have already spent the three-minute rule.

REP. LAGMAN. ... we start with the determination of sufficiency in substance.

In view of the foregoing, Mr. Speaker, Mr. Chairman, I voted "Yes" on the dismissal of the impeachment complaint and I urge the leadership of this House to return the impeachment complaint to the Committee on Justice for further proceedings because we only voted on the sufficiency in form of the impeachment complaint.

Thank you, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Abu). The Dep. Majority Leader is recognized.

REP. BONDOC. Mr. Speaker, there being no other colleague of ours who wishes to explain his or her vote, I move that we proceed to the Reference of Business.

THE DEPUTY SPEAKER (Rep. Abu). Is there any objection? (Silence) The Chair hears none; the motion is approved.

The Secretary General will please read the Reference of Business.
