# NOMINAL VOTING ON H.B. NO. 6775 ON THIRD READING

REP. BELARO. Mr. Speaker, I move that we vote on Third Reading on House Bill No. 6775 and direct the Secretary General to read the title of the measure, and call the roll for nominal voting.

I so move.

THE DEPUTY SPEAKER (Rep. Hernandez). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.

Thereupon, the Secretary General read the title of the measure, printed copies of which were distributed to the Members on February 8, 2018, pursuant to Section 58, Rule X of the House Rules.

THE SECRETARY GENERAL. House Bill No. 6775, entitled: AN ACT CREATING THE DEPARTMENT OF HUMAN SETTLEMENTS AND URBAN DEVELOPMENT, DEFINING ITS MANDATE, POWERS AND FUNCTIONS, AND APPROPRIATING FUNDS THEREFOR.

The Chair directed the Secretary General to call the roll for nominal voting. Thereafter, pursuant to the Rules of the House, a second roll call was made. The result of the voting on Third Reading\* on the aforesaid measure is reflected in Journal No. 62, dated February 13, 2018.

REP. BROSAS. Mr. Speaker, my vote is "No" and I would like to explain my vote later.

THE DEPUTY SPEAKER (Rep. Hernandez). That is duly noted.

REP. CASILAO. Mr. Speaker, ang boto ko po ay "No" at ako po ay magpapaliwanag mamaya.

THE DEPUTY SPEAKER (Rep. Hernandez). That is duly noted.

REP. CASTRO (F.L.). Mr. Speaker, my vote is "No."

REP. DE JESUS. Mr. Speaker, I vote "No" and I would like to explain my vote later.

THE DEPUTY SPEAKER (Rep. Hernandez). That is duly noted.

REP. TINIO. Mr. Speaker, I vote "No."

#### RESULT OF THE VOTING

THE DEPUTY SPEAKER (Rep. Hernandez). The result shows 193 affirmative votes, six negative votes and no abstention.

House Bill No. 6775 is approved on Third Reading.

REP. BELARO. Mr. Speaker, I move that we recognize the Members who wish to explain their votes.

THE DEPUTY SPEAKER (Rep. Hernandez). Representative Brosas is hereby recognized. You have three minutes.

#### REP. BROSAS EXPLAINS HER VOTE

REP. BROSAS. Thank you, Mr. Speaker.

Mr. Speaker, mga kapwa ko Kinatawan, ang Representasyong ito ay tutol sa pagsasabatas ng House Bill No. 6775, ang panukalang batas na naglalayong buuin ang Department of Human Settlements and Urban Development. Sa mahabang kasaysayan ng pakikibaka ng mamamayang Pilipino para sa abot-kaya, pang-masa at may kalidad na programang pabahay sa mga maralita, ang susing usapin na hindi nareresolba ng gobyerno ay ang patakaran sa palupa at pabahay na nakabalangkas sa pribatisasyon at sa layuning kumita. Kung mayroon mang kailangang baguhin sa mga batas sa usapin ng pabahay, ito ay ang pagbabago nito mula sa pagiging profit-oriented to being service-oriented na may layuning makatuwang sa mamamayang nagdarahup, sa halip na sila ay lalo pang ibaon sa pagkakautang sa patung-patong na mga bayarin dahil napakalaki po ng binabayaran nila—milyun-milyon pero sila ay mga maralita—sa mga pabahay na ginawa ng gobyerno.

Maraming mga probisyon sa panukalang batas na nakababahalang magamit upang lalo pang pagkakitaan ang serbisyong pabahay sa mga maralita. Sa "Definition of Terms," nakatali ang pagpapakahulugan sa informal settler families o ISFs sa lugar na kinatitirikan ng kanilang mga tahanan, sa halip na pagkilala sa kanilang panglipunan at pang-ekonomiyang katayuan na siyang nagtutulak sa kanilang manirahan sa mga estero, riles at maging sa waterways. Sa ganitong depinisyon nagmumula ang mga arbitraryong mga desisyon, halimbawa, mula sa mga local government units o LGUs na mga banta at aktwal na pagpapalayas. Isang tiyak na halimbawa nito ang naranasan ng maralita sa Pasig Floodway, sa Tondo, sa Quezon City at sa iba pa. Nakapangangamba rin ang pagtingin ng panukalang batas na ito sa social housing. Sa inihahapag na depinisyon ng social housing, nakatuon ito sa walang pigil sa pagtatakda ng interest sa pautang sa pabahay, malayung-malayo sa ultimong layunin ng social housing na dapat sana ay nakatuon sa mga programa para sa ating mga maralita na kababayan, kulang o di kaya naman ay wala halos na kinikita. Samakatuwid, walang nireresolbang usapin sa pabahay ang panukalang batas. Layunin pa nitong ibukas sa pribado ang mga batayang serbisyong panglipunan tulad ng pabahay pati nga sa mga dayuhan. Bukod pa rito, pinangangambahan ng Representasyong ito ang magiging malawakang tanggalan sa hanay ng mga kawani ng gobyerno dahil sa magaganap na pagsasanib at pagrereorganisa ng dating pitong ahensiyang nakatutok sa pabahay. Sa panukalang batas, walang probisyong magtitiyak para sa mga kawaning maaapektuhan ng ganitong reorganisasyon. Sa karanasan ng ating mga maliliit na kawani sa gobyerno, ang abolition, restructuring, merging, streamlining at integration ay nangangahulugan ng malawakang layoff sa likod ng mga pabalat-bungang reporma ng redundancy, overlapping in programs or functions at pagpapalakas ng private sector participation. Sa National Housing Authority pa lamang tinatayang mahigit 2,000 regular na mga manggagawa ang maaaring mawalan ng ikinabubuhay. Sa ngayon pa nga lamang na proseso ng rationalization, higit 200 kawani na ang natanggalan ng plantilla positions o di kaya naman ay na-demote. Halos 6,000 kawani din mula sa iba pang key shelter agencies tulad ng HLURB at HUDCC ang maaaring matanggal sa trabaho.

Naninindigan ang Gabriela Women's Party na hanggang nananatiling nakatuon sa layuning kumita ang balangkas ng programang pabahay sa Pilipinas, hindi mareresolba ng pagtatayo ng hiwalay na departamento ang usapin ng kawalan ng masisilungan ang milyong Pilipino na patuloy na pinagkakaitan ng batayang serbisyo sa ilalim ng ganitong patakaran.

THE DEPUTY SPEAKER (Rep. Hernandez). You will please wind up.

REP. BROSAS. Yes, Mr. Speaker, I am wrapping up. Sa bawat panukalang batas patungo sa ilang mga reporma, marapat na matiyak natin ang kasiguruhan sa kabuhayan ng ating mga kawani. Muli iginigiit ng Representasyong ito ang pagtutol sa panukalang batas at ang pagtindig para sa pang-masang pabahay at seguridad sa trabaho ng mga maralita at kawani ng gobyerno.

Thank you, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Hernandez). The Hon. Ariel "Ka Ayik" B. Casilao is recognized. You have three minutes.

#### REP. CASILAO EXPLAINS HIS VOTE

REP. CASILAO. Salamat, Mr. Speaker. Ako po ay bumoboto ng "No" o ng negative dahil aminado naman po ang ating mga Sponsor ng panukalang batas na ito, House Bill No. 6775, na hindi po matutugunan nito

ang balangkas ng polisiyang sa usapin ng serbisyong pabahay. Nakabalangkas pa rin ang panukalang batas na ito doon sa Urban Development and Housing Act. Ang anumang istruktural na pagbabago o pagsasaayos mula sa pitong shelter agencies hanggang maging isang departamento, hindi pa rin nito tinatanggal ang oryentasyong pumapabor at nasa pangunahin, nasa unahan ng pagpapatupad ng programang pabahay sa ating mga maralita ay ang usapin ng mga pribadong negosyo. Pangalawa, Mr. Speaker, hindi po matutugunan nito ang papalaki at papalawak na bilang ng mga informal settlers at iyong housing backlog. Aminado din ang ating mga Sponsor na ang 5.1 million na housing backlog ay hindi matutugunan sa panukalang batas na ito. Pangatlo, Mr. Speaker, magdudulot at magdudulot ng tanggalan ang reorganisasyon. Ang pagbubuo ng isang departamento mula sa pitong housing or shelter agencies ay magdudulot ng tanggalan ng mga empleyado.

Sa kasalukuyan, ang ating gobyerno ay isa sa pinakamalaking taga-hire ng mga kontraktwal na mga manggagawa sa iba't ibang antas o ahensiya ng ating gobyerno. Sa panukalang batas ding ito, Mr. Speaker, mas maiging tugunan itong usapin ng oryentasyon ng public housing bill. Hindi po magkakaroon ng malinaw na implementasyon ang Department of Human Settlements and Urban Development kung ang balangkas nito ay nasa pribado o negosyo.

Kaya tumututol, at ang boto po ng Kinatawang ito ay "No," Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Hernandez). The Hon. Emmi A. De Jesus is hereby recognized. You have three minutes.

# REP. DE JESUS EXPLAINS HER VOTE

REP. DE JESUS. Thank you, Mr. Speaker.

Kamakailan lang, na-disperse ng city government ng Manila ang kampuhan ng mga maralita sa Mendiola—eyesore at mabaho. Ito ang mga tinanggalan ng tirahan, tulad ng nabanggit kanina, mula sa Manggahan Floodway, at napilitan silang magkampo sa Mendiola at umasang haharapin sila ni Pangulong Duterte dahil hanggang ngayon ay wala pa ring paglilipatan sa kanila. Malayo ang ibinibigay na relocation site, bukod pa sa hindi nila kaya ang bayarin. Paulit-ulit ang ganitong

kuwento at mauulit kung hindi uugatin ang suliranin sa pabahay. Kailangan nating ma-recognize na sa karamihan ng mga tinatawag nating informal settlers sa mga urban areas, galing sila sa mga pamilya ng mga magsasaka sa kanayunan, at lumuwas sila sa siyudad para maghanap ng mas magandang buhay dahil, ano na nga ba ang kalagayan ng kanayunan? Kahirapan, pangangamkam ng lupa, militarisasyon, pandarambong at kawalan ng oportunidad sa trabaho sa agrikultura. Dumating sa lungsod, nakahanap ng trabaho, at nagtirik ng bahay sa kung saan mang espasyo, kanugnog ang barung-barong at iba pang maraming kaparehong istorya.

Karamihan sa mga ito ay dekada nang naninirahan sa kinatatayuan ng bahay nila. Sampu, dalawampu, limampung taon sa nadatnan nilang tiwangwang na lupa, at hinawan, pinagyaman, pinaunlad ng umusbong na komunidad sa pagdaan ng panahon. Dadating ang isang pribadong entidad o di kaya ay mismong gobyerno, papaalisin sila dahil wala silang pinanghahawakang papel na sa kanila ang lupa. Kasunod ay demolisyon at dislokasyon. Ano ba ang kahulugan nito? Pagsadlak sa ibayong kahirapan. Paulit-ulit na ang kuwento.

Sa ganitong kalagayan, solusyon ba ang House Bill No. 6775?

Sa totoo lang, ang pagsasabatas ng Bill na ito ay mangangahulugan lamang ng muli na namang pagtalikod ng gobyerno sa responsibilidad nito na magbibigay ng pang-masa at abot-kayang pabahay sa mga tao. Korporasyon pa rin ang tunguhin ng ahensiyang mamamahala sa pabahay. Ibig sabihin, ang mga tinatawag na beneficiaries ang muli na namang babalikat sa mga bayarin. Negosyo muli ang diin at hindi serbisyo, gaya pa rin ng dati. Ang pagre-reorganize ng mga ahensiya ay halos inulit lang ang nilalayon nitong palitan. Bumuo ng mga bagong andana ng burukrasyang hindi naman kinakailangan. Kabilang ng libo-libong rank-and-file employees na mawawalan ng trabaho ay mga empleyadong ilang taon nang nagsisilbi sa ahensiya at ngayon, wala nang katiyakan sila sa trabaho.

Hindi ang panukalang batas na ito ang sagot sa problema sa pabahay. Gusto ko ring banggitin, case in point, baka puwede pang aralin ang ginawa ng lokal na pamahalaan ng Valenzuela sa kanilang Disiplina Village. Ang pagkakaroon ng abot-kaya, pang-masa at may kalidad na pabahay ay hindi maihahatid sa nangangailangan sa pamamagitan ng pagbibigay ng kapangyarihan sa mga korporasyon. Ang usapin sa pabahay ay kaakibat ng malaking usapin tungkol sa kahirapan. Kung walang trabaho ang papatirahin sa mga bahay na ito, wala rin silang kapasidad na magbayad at muli na naman silang mawawalan ng masisilungan. Kailangan munang kilalanin ang ganitong katotohanan bago masabing tunay na maglilingkod sa inaasahang stakeholders ang anumang panukalang batas patungkol sa housing.

Muli, "No" ang boto ng Representasyong ito. Maraming salamat po.

# CONSIDERATION OF H.B. NO. 7115 ON SECOND READING

#### PERIOD OF SPONSORSHIP AND DEBATE

REP. MATUGAS. Mr. Speaker, I move that we consider House Bill No. 7115, contained in Committee Report No. 596, as reported out by the Committee on Agrarian Reform.

May I ask that the Secretary General be directed to read only the title of the measure.

THE DEPUTY SPEAKER (Rep. Hernandez). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.\*\*

The Secretary General is directed to read only the title of the measure.

With the permission of the Body, and since copies of the measure have been previously distributed, the Secretary General read only the title thereof without prejudice to inserting its text in the Congressional Record.

THE SECRETARY GENERAL. House Bill No. 7115, entitled: AN ACT PENALIZING THE

CONVERSION OR CAUSING THE CONVERSION OF IRRIGATED AND IRRIGABLE LANDS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO 6657, AS AMENDED, OTHERWISE KNOWN AS THE COMPREHENSIVE AGRARIAN REFORM LAW OF 1988.

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized.

REP. MATUGAS. Mr. Speaker, I move that the Chairperson of the Committee on Agrarian Reform, the honorable Representative Relampagos, be recognized for the sponsorship of the measure.

THE DEPUTY SPEAKER (Rep. Hernandez). Representative Relampagos is hereby recognized.

REP. RELAMPAGOS. Thank you, Mr. Speaker. On behalf of the Committee on Agrarian Reform, we would like to manifest before this august Body our desire for the adoption of the Explanatory Note of House Bill No. 7115, principally authored by the Honorable Speaker and the Hon. Erlpe John "Ping" M. Amante as our sponsorship speech on House Bill No. 7115.

THE DEPUTY SPEAKER (Rep. Hernandez). Is there any objection? (*Silence*) The Chair hears none; the motion is approved.

The Majority Leader is recognized.

REP. MATUGAS. Mr. Speaker, considering that there are no interpellators, I move that we—I am sorry, Mr. Speaker, I move that we open the period of sponsorship and debate. I so move, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Hernandez). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.

The Majority Leader is recognized.

REP. MATUGAS. Mr. Speaker, I move that we recognize the honorable Rep. Edcel C. Lagman for his interpellation. I so move, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Hernandez). Rep. Edcel Lagman is hereby recognized.

REP. LAGMAN. Thank you, Mr. Speaker. I would like to manifest that I am in favor of this Bill. At a time that we have this rice shortage, the enactment of this Bill is indispensable because it would enhance rice production when we are able to save irrigated and irrigable lands from conversion to other purposes.

I just would like to seek clarification, distinguished Chairman: One, Section 4, on Effectivity, reads: "This Act shall take effect fifteen (15) days following its publication in the Official Gazette or in any newspaper of general circulation." This means, distinguished Chairman, that the effectivity of this Bill, once enacted, will be prospective. Is that correct?

REP. RELAMPAGOS. Yes, Mr. Speaker, Honorable Lagman, that is correct.

REP. LAGMAN. Another question and this is my second question. In other words, all pending applications for conversion prior to the approval of this Act will not be covered. Is that correct?

REP. RELAMPAGOS. Mr. Speaker, Honorable Lagman, actually, if we go by Republic Act No. 6657, there is already a provision in the law under Section 65 that prohibits conversion of irrigated and irrigable lands. Unfortunately, in spite of this, there is still rampant and unchecked conversions, and the conversion of irrigated and irrigable lands, the existence thereof, is actually acknowledged by no less than the Department of Agrarian Reform itself, and it would seem that there are certain elements within the government bureaucracy that may directly have a hand in this present reality. So, precisely, because of this and in order to address this, there is a need for us to add, under the existing law, the act of converting or causing the conversion of irrigated and irrigable lands among the prohibited acts prescribed under Republic Act No. 6657, precisely under Section 73 thereof. By doing so, it would also specify the amendment thereof in terms of who would be those responsible, for which acts would constitute the conversion, or causing the conversion of irrigable or irrigated lands.

In the same legislation that is being proposed for consideration, we are also, at the same time, making a clear definition, as part of the amendments to be introduced, of irrigated lands—what are irrigable lands—to include an increase in the penalty to be imposed on those persons who would be found liable in violation of this proposed amendment of the law. Sad to say, because under the existing law, the penalty is not that great and so, there is a need to impose a higher penalty just to give a strong message that this act will never be tolerated.

REP. LAGMAN. So, in other words, Mr. Speaker, distinguished Sponsor, this is a reiteration, a restatement of Section 73 of Republic Act No. 6657, but it enumerates specifically the prohibited acts and would increase the penalty imposable for violation. Is that correct?

REP. RELAMPAGOS. That is correct. Under the existing law, under Section 73, this is not included in the

listing or enumeration under Prohibited Acts. So, we are proposing under this House Bill for the addition, under paragraph (J), that this will be included—the actual physical or legal conversion or causing the physical or legal conversion of irrigated and irrigable lands. It also provides there an enumeration of persons who would be liable for violation of this Act.

REP. LAGMAN. Is there any study, distinguished Sponsor, Mr. Speaker, on the effect of this Bill, once enacted into law, on the competitive claims on land like, for example, for housing, commercial or industrial use?

REP. RELAMPAGOS. Well, the thing there, Mr. Speaker, Honorable Lagman, as I was saying earlier, while there is already an express provision of the law that prohibits the conversion of irrigable and irrigated lands under Section 65 of Republic Act No. 6657, it is very unfortunate that still there is the existence of conversion of irrigable and irrigated lands. So, precisely because of this reality, we are instituting the amendment of this law in order to address it.

REP. LAGMAN. Okay. Well, the moratorium is for 15 years. Is that correct?

REP. RELAMPAGOS. You are talking of the Bill filed by one of the authors, the Honorable Amante. House Bill No. 7115 is already a substitute bill of the two bills that were passed—one, by the Honorable Speaker of the House that seeks to provide for a prohibition of the acceptance, processing and approval of applications for land use conversion of agricultural lands, irrigated lands and irrigable lands to non-agricultural purposes, and the one authored by the Hon. John "Ping" Amante that seeks to provide for a 15-year moratorium on the processing and approval of applications for conversion of all irrigated and irrigable lands covered by irrigation projects.

Now, just to expound further on this. The reason the Committee came up with the substitute bill to focus on including as one of the prohibited acts under Section 73 the act penalizing the conversion or causing the conversion of irrigated and irrigable lands is that the Committee finds it wise that there would no more be any need of passing the bills originally proposed by the two authors because there is already an existing law that addresses the prohibition of the conversion of irrigated and irrigable lands.

REP. LAGMAN. Under this Bill once enacted into law, there will be a permanent ban on the conversion of irrigable and irrigated lands. Is that correct?

REP. RELAMPAGOS. Yes. That would be the net effect, Mr. Speaker.

REP. LAGMAN. That is why I had a prior question on the impact of this prohibition on the other competitive claimants to land like housing, commercial and industrial use; but if there is no such prior study, then most probably there would be a need for a post-enactment study on how this permanent ban would affect the claims for housing, commercial and industrial usages of land. In any event, I would like to reiterate my previous statement that I am in favor of this measure.

Thank you.

REP. RELAMPAGOS. Thank you for that, Mr. Speaker. Thank you for that, Honorable Lagman, and rest assured that the Committee will work with the Department of Agrarian Reform for them to conduct the study as you so suggested, and perhaps, if the Honorable Lagman would be amenable, considering that you had already expressed your manifestation to support, probably you can be a coauthor of this measure. Okay. So, this Representation would like to manifest, Mr. Chairman, Mr. Speaker, that the Honorable Lagman will be a coauthor of this measure and we will also include all those still present in the Plenary Hall if they are so amenable.

THE DEPUTY SPEAKER (Rep. Hernandez). That is noted.

The Majority Leader is recognized.

REP. MATUGAS. Mr. Speaker, there being no other interpellators and there being no Member who wishes to speak against the Bill, I move that we close the period of sponsorship and debate. I so move, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Hernandez). Is there any objection? (*Silence*) The Chair hears none; the motion is approved.

The Majority Leader is recognized.

REP. MATUGAS. Mr. Speaker, I move that we open the period of amendments.

THE DEPUTY SPEAKER (Rep. Hernandez). Is there any objection? (*Silence*) The Chair hears none; the motion is approved.

REP. MATUGAS. Mr. Speaker, there being no Committee or individual amendments, I move that we close the period of amendments. I so move, Mr. Speaker.
