PRIVILEGE SPEECH OF REP. FERNANDO

REP. FERNANDO. Mr. Speaker, distinguished colleagues, the traffic problem in Metro Manila remains

to be one of the challenging problems that the government needs to resolve. After years of finding solutions, administration after administration, we have yet to implement an effective strategy to finally solve this decadelong problem. This is one of the hottest issues today, as the MMDA pushes for the provincial bus ban along EDSA as one of the solutions to the traffic problems.

Mr. Speaker, allow me to speak on this matter as it is very close to my heart. I served as the Chairman of the Metro Manila Development Authority from 2001 to 2009. I cannot just sit here and watch from the sidelines. Hence, I want to share some of my ideas relative to finding solutions to Metro Manila transport needs and traffic problem through an Organized Bus Route System— it is OBR.

The buses are a part of the mass transport system as much as the MRTs, LRTs and subways. They have been here for a long time now and are here to stay. These are basic in any transport system: 1. That the number of carriers at any given time should be proportionate to the number of passengers on the road and timed to minimize passenger waiting time and long waiting lines; 2. That a limited number of carriers on the road with optimum passenger loads be allowed to minimize road space requirement; and 3. That effective dispatching is the key to any good transport system to serve its mission of service and make good returns on investments. These requirements can be met by an organized bus system put in place by the MMDA in 2006.

OBR in EDSA is BRT

Secretary Oscar Orbos, in his time with the MMDA, designated a lane on EDSA which was called the "yellow lane." In 2006, under my term, with the increasing number of passengers and buses, it became two lanes marked "A" and "B" exclusively for city buses. Each lane was provided with bus stops in areas of high passenger volume and fenced off as physical restraint to undisciplined commuting public and likewise force equally unruly drivers to pick up passengers on the designated gates. The buses were given a limited or a few seconds to unload and load passengers in any stop. Seven bus terminals were established within the perimeter of Metro Manila and were controlled by the MMDA, where all buses terminate at the end of their trips to await their turn to be dispatched again by the MMDA, which was timed with the number of passengers on the road.

At this juncture, Deputy Speaker Pimentel relinquished the Chair to Deputy Speaker Ferdinand L. Hernandez.

Provincial buses marked "P" leaving the metro were only allowed to run on the third lane as they were supposed to be a point-to-point service and so, were not allowed to pick up passengers elsewhere other than in their terminals. They were to take the flyovers to cross intersections. Arriving provincial buses were to unload incoming passengers in five stations under the flyovers where taxis and short-haul jeepneys can take these provincial passengers, who usually have some cargo with them, to their final destination. The whole operations were closely monitored by the MMDA personally on the ground.

In the first three months of the OBR operations, the following were noted: The income of buses before the OBR, from five trips in a day but now, with the OBR, was earned after four trips, which was a 20 percent improvement. Buses had higher load factors, 60 to 100 percent full, thus, reducing the number of bus trips a day. There were more earnings for the operators and the drivers. There was more order on the road. There was discipline among the passengers and the drivers were at their best, with the drivers having increased income and spending less time on the road.

But here is the downside: after three months, the system broke down as the drivers learned to outwit the controls and bribery corrupted the system. The system in place, relying on the personal supervision of the MMDA ground personnel, proved to be so vulnerable to corruption and so, with the bad work ethic and the greed of drivers and government workers, the system collapsed. But unbowed in its determination, the MMDA used newer technologies available at that time. Each bus was equipped with radio frequency identification or RFID, and RFID readers and CCTVs were installed to monitor every unit on the road with minimum personal attendance. With this minimum personal attendance, the system worked. However, I lost count of the system after my untimely departure from the agency in 2009; but watching from the sidelines and after all these years, I have not seen a better alternative in place. So, I have taken a risk to bring about these unsolicited recommendations to the present dispensation.

Number one, the MMDA has the technology and the experience to manage the system, use them and acquire more. Put the geometrics and all necessary road furnishings like fences, signages, signals and monitoring equipments like cameras, RFIDs and readers back in place. Give all buses a priority grade in crossing any intersection. All other vehicles must stop and make way for buses to cross. This was never done before as the need then is not as much as now. Buses must not stop at any point except at the bus stops with their doors right in front of the gates of the platforms. The bus, if unimpeded, can move more people at any given time and its constancy will make more accurate dispatch forecasts and will minimize passenger waiting or queuing time as well as reduce the number of idle

bus units on the road which are occupying the muchneeded road space.

With the controlled dispatching, all units will have the same average number of trips in a day, thereby giving no reason for any operator and driver to break the rules or to take advantage, as each driver can only make so much established number of trips in a day, no more than the others. This can lead to the extinction of the age-old problem of boundary or commission system. The drivers, in time, may opt to be paid regular salaries and be more abiding road users. The operators in the end may see the wisdom of incorporation, and then we can see a separate, corporatized one route, with the bus company being more efficient and professionally managed, giving better monetary returns to former operators who, by then, may have become stockholders.

Mr. Speaker, this is how this OBR differs from the BRTs of other countries where most transport companies are run by their governments and/or highly subsidized by government. Our bus systems are not receiving any subsidy from government up to this time. This OBR is maintaining the concepts of privatization but not taking away the entrepreneurial opportunities for the private operators. Trains take commuters to the nearest station from their homes, but buses will then take them to the last mile from their homes. The bus is mass transport then and now. Let us put back in place a system that will improve the convenience of the commuters. I believe that the Organized Bus Route System could contribute to the solution that we are all looking for.

Mr. Speaker, I hope that the DOTr and the MMDA will consider, in their policy formulations, these unsolicited recommendations from this humble Representation.

Thank you very much.

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized.

REP. LACSON-NOEL. Mr. Speaker, I move that we recognize the Hon. Gabriel H. Bordado Jr. from the Third District of Camarines Sur to interpellate the Hon. Bayani Fernando.

THE DEPUTY SPEAKER (Rep. Hernandez). The Honorable Bordado is hereby recognized.

REP. BORDADO. Thank you, Mr. Speaker. I am also very interested in this particular topic. In fact, I already delivered two privilege speeches expressing my position regarding the MMDA and the LTFRB move to ban provincial buses from EDSA.

Mr. Speaker, I am happy to note that the former Chairman of the Metro Manila Development Authority for eight years has just shared with us his recommendations to what is happening right now at the EDSA. Mr. Speaker, may I know if my friend here, our fellow member of the Minority, is willing to answer some questions.

REP. FERNANDO. Gladly, dear colleague.

REP. BORDADO. Thank you.

Mr. Speaker, Deputy Minority Leader, what could be the reason the current MMDA administration did away with the OBR?

REP. FERNANDO. Mr. Speaker, I could not see any reason because it has been tried during my time and it produced good results. There were some setbacks but finally, we overcame the setbacks by digitizing, by using newer technologies, so we can do away with the ground personnel, with the personal supervision of the MMDA personnel, to eliminate corruption which actually damaged the system. When I got out of the agency, it was still I working but unfortunately, I had to leave the office for some reason. In any case, the succeeding leadership in the MMDA did not give it a real effort to get the system going, even a semblance of operation. But it is not what was envisioned, and it is not what we have learned in the few times or in the year that it has been there when it was implemented quite well.

REP. BORDADO. Mr. Speaker, Deputy Minority Leader, am I to understand that the scheme being introduced by the MMDA now may not prove to be effective?

REP. FERNANDO. Mr. Speaker, you could be talking about the removal of provincial buses in Manila.

REP. BORDADO. Yes, Mr. Speaker.

REP. FERNANDO. It is good that they are trying to do something but unfortunately, it may not be timely, it may be too early for that. In the concepts laid down in this presentation, you need to put in place an organized, a very effective dispatch system that will catch the passengers from wherever they will be dropped off. An efficient, effective working dispatch system should be there to minimize the inconvenience to the public and the added cost that they will have to bear.

REP. BORDADO. Okay.

REP. FERNANDO. In effect, I agree or I commiserate with our dear colleague for this predicament and for the trouble that it may have brought you and the public. The past few days really made it hell to move in the city.

REP. BORDADO. Mr. Speaker, Deputy Minority Leader, am I also to understand that any system that may be introduced will always somehow fail if the MMDA personnel and drivers will succumb to the temptation of corruption, as you mentioned in your privilege speech?

REP. FERNANDO. Yes, I think that is the evil that we really have to eliminate to make any system work. That is the reason we have substituted it with technology. It is just like a non-contact apprehension wherein the operative or the enforcer only need to take photo of any violation, without any personal contact with the violator. That is enough evidence, and the summon is sent to the violator for him or her to pay fines.

REP. BORDADO. Okay. Mr. Speaker, Deputy Minority Leader, do you agree with the position taken by the MMDA and later on, by the LTFRB to proceed with the dry run of this bus ban?

REP. FERNANDO. Actually I have advised them, in a way, not to proceed with it because I do not think they are prepared for that. I think they are ill-prepared and as I said, there has to be a bigger system that is needed to be put in place to make that effective.

REP. BORDADO. Okay, thank you very much, Deputy Minority Leader.

REP. FERNANDO. Mr. Speaker, dear colleague, this is the reason I am here standing. I really tried to refrain from or I have been shying away or I avoid talking about the MMDA and this traffic problem because I have been there and I might be accused of something. I already made suggestions and I think it fell on deaf ears. At least I feel it as a duty for me to stand up and inform everybody about it, where some good souls might pick it up and help me to convince them. There is one good thing that could have happened if we had a working organized bus route, though I was not able to try it. I did not try in my time because at that time, it was still not necessary, that is, to give all buses priority in crossing any intersection, for all modes, for all vehicles to stop and give way to crossing buses on EDSA. That is similar to the trams in Europe or elsewhere in the world where everyone stops when the tram has to cross. With that, we could see the advantage of the system, where the buses will continue moving and will have no excuse in stopping at any point except in the loading platforms. Unfortunately, it was never done, and I am sorry about that. Anyway, I hope this presentation will actually make them hear or to at least consider my unsolicited proposals.

REP. BORDADO. Okay. Thank you, Mr. Speaker. Thank you, Deputy Minority Leader.

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized

REP. SINGSON-MEEHAN. Mr. Speaker, I move that we recognize the Lady from ACT TEACHERs Party-List, Rep. France L. Castro.

THE DEPUTY SPEAKER (Rep. Hernandez). The Hon. France L. Castro is hereby recognized.

REP. CASTRO (F.L.). Salamat po, Mr. Speaker. Magandang hapon po sa ating lahat.

Ang kalayaan sa loob ng eskuwelahan upang magpahayag ng saloobin, mag-organisa o punahin ang pamahalaan ay kalayaan din ng buong lipunan. Ang kalayaan ng mga kabataan sa kritikal na pag-iisip at makabayan at kolektibong pagkilos ay sumasalamin sa kalayaan ng bawat mamamayan.

REP. BARBERS. Point of order, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized.

REP. BARBERS. Mr. Speaker, I was made to understand that the Gentleman from Marikina is being interpellated by our colleagues. I know how much eager our colleague, Congresswoman...

THE DEPUTY SPEAKER (Rep. Hernandez). France Castro.

REP. CASTRO (F.L.). France.

REP. BARBERS. ...France Castro to deliver her speech, but I think it is still the time of the Gentleman from Marikina. May I know, Mr. Speaker, is this still the time of the Congressman from Marikina in answering interpellations from our colleagues.

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized.

REP. BONDOC. Mr. Speaker, we would like to enjoin our colleagues who wish to interpellate those availing of the Privilege Hour to kindly approach the Majority Leader so that we can acknowledge them. Since none of our colleagues moved to be recognized by the Majority Leader, we proceeded with the next person who wishes to avail of the Privilege Hour. We apologize to the Hon. France Castro and move that she be allowed to continue with her privilege speech.

THE DEPUTY SPEAKER (Rep. Hernandez). Is

there any objection? (Silence) The Chair hears none; the motion is approved.

The Majority Leader is recognized.

REP. BONDOC. With that, Mr. Speaker, the Hon. France Castro will avail of the Privilege Hour and deliver her privilege speech.

I so move.

THE DEPUTY SPEAKER (Rep. Hernandez). The Hon. France Castro from the Party-List ACT TEACHERs is hereby recognized.

PRIVILEGE SPEECH OF REP. CASTRO (F.L.)

REP. CASTRO (F.L.). Maraming salamat po, Mr. Speaker.

Ang akin pong privilege speech ay ukol po sa atake sa mga kabataan at sa sektor ng edukasyon. Ang kalayaan sa loob ng eskuwelahan upang magpahayag ng saloobin, mag-organisa at punahin ang pamahalaan ay kalayaan din ng buong lipunan. Ang kalayaan ng mga kabataan sa kritikal na pag-iisip at makabayan at kolektibong pagkilos ay sumasalamin sa kalayaan ng bawat mamamayan.

G. Ispiker, mga kapwa Mambabatas at sa lahat ng nakikinig, magandang hapon. May isang kagyat at seryosong isyu na kailangang ipaabot sa Kongreso ang sektor na aking pinanggalingan, kaya ipinagpaliban ko muna ang inihanda kong talumpati para sa Buwan ng Wika at anibersaryo ng "The Battle of Manila." Hayaan ninyo akong ipagpaliban muna ang talumpating iyon para sa susunod na linggo at kunin ang hapong ito para sa sektor ng edukasyon.

Mr. Speaker, I take this opportunity to throw my wholehearted support behind our children and youth who choose the hard road of serving the people by organizing themselves and fighting for the rights and welfare of their own sector and of others who are also in the margins of our society. I also take this opportunity to express my dismay for the seemingly systematic efforts to malign, demonize and vilify this courage of our youth, whose efforts are part of the continuing attacks against the education sector to forward an agenda for further oppression.

Mr. Speaker, nasa high school pa lang po ako ay naging kasapi na ng iba't ibang organisasyon sa eskuwelahan. Naging kasapi ako ng Student Catholic Action, Mathematics Club at naging opisyal din ako ng CAT. Nang ako ay pumasok sa kolehiyo, sumapi muli ako sa iba't ibang organisasyon sa paaralan gaya muli ng Student Catholic Action, Student Volunteers Organization, Math Club at League of Filipino Students. Ang pagsapi sa anumang organisasyon ay isang batayang karapatan ninuman, bata man o matanda, at dahil dito, makikita at malalaman ang iba't ibang

interes, perspektiba at pananaw sa mga bagay-bagay at sa paligid. Unang taon ko pa lang sa kolehiyo, ako ay 16 taong gulang, nagsimula na akong magtanong-tanong sa mga nangyayari sa aking kapaligiran. Dito ko unang naranasang lumahok sa aktibo at sama-samang pagkilos laban sa pagsupil sa karapatang pagpapahayag. Dito na ako naging aktibista. Nang ako ay naging guro, dinanas ko ang apat na taon sa pagiging kontraktwal. Alam na siguro natin, mga kapwa Mambabatas, ang katayuan at kalagayan ng isang kontraktwal sa trabaho kaya't kumilos ako at iba pang mga guro upang mabago ang aming kalagayan. Ang kapaligiran at ang sitwasyon ang nagtuturo para humanap ng solusyon na makabubuti hindi lamang para sa sarili pero para din sa ibang tao at sa bayan.

Matagal din akong naging public high school teacher at masasabi kong kakaiba talaga ang talino ng ating mga kabataan, lalo na ang mga mula sa mga mahihirap na pamilya. Marunong silang mangatwiran, tama man o mali, pilosopo man o hindi. Bilang guro, Mr. Speaker, tinatanggap ko itong lahat bilang bahagi ng kanilang kaalaman at karanasan but at the end of the day, kasabay nila akong nagpo-proseso ng mga kaalamang ito hanggang sa marating ang tamang katuwiran.

Kaya ganoon na lang ang lungkot ko sa nagaganap sa Senado simula noong nakaraang linggo. Sa isang witchhunt, na ituturing kong witch-hunt na binabansagang "committee hearing" at "inquiry in aid of legislation," mukhang minamaliit ang talino at kapasidad ng mga kabataan na magkaroon ng kritikal na pag-iisip at sinasabing bini-brainwash sila. Tila tinatakot ang mga kabataan, magulang at guro na tumahimik na lang at huwag punahin o labanan ang mga nakikitang mali sa lipunan at pamahalaan. Ginagamit ang Kongreso at pinagsasamantalahan ang mga personal na isyu ng mga pamilya upang sirain ang mga progresibong organisasyon na walang ibang kasalanan kundi ang pumuna sa mga mali ng pamahalaan at lumaban para itama ang mga maling ito.

Dinedemonisa ang mga militanteng samahan ng mga kabataan gaya ng pagdedemonisa sa samahan ng mga guro, magsasaka, manggagawa at iba pang marginalized sectors. Ang ANAKBAYAN Party-List, League of Filipino Students at KABATAAN Party-List daw ay leftist, communist fronts, recruiter diumano ng NPA at kung anu-ano pang mga terrorist groups. Pero kailan ba naging credible at malinis ang layunin ng ganitong pagle-label? Ang red-tagging na ito, Mr. Speaker, ay mula sa iisang pakete ng sistematikong pagpatahimik, intimidasyon at paglabag sa mga karapatan ng mga kabataan, guro at iba pang mga kabahagi ng sektor ng edukasyon. Ito ay pangwawasiwas ng kamay na bakal sa mga eskuwelahan. Ang malisyosong red-tagging ay napatunayang puro kasinungalingan, walang ebidensiya at iligal. Kinukondena na ito sa loob at labas ng bansa gaya ng Commission on Human Rights, National

Privacy Commission at Education International. Itong nangyari sa Senado ay walang pagkakaiba sa iligal na profiling at pananakot na ginawa ng PNP laban sa unyon ng mga public school teachers at UP faculty sa ilalim ng Alliance of Concerned Teachers at All-UP Academic Employees Union. Wala itong pagkakaiba sa pinalulutang na "destabilization plot" kuno gaya ng "Red October" or "White December" na inamin mismo ng pulis at militar na walang ebidensiya. Produkto ito ng mga utak na nag-iimbento ng discredited "intelligence reports," nanira sa martial law film screenings at nagbanta na kakasuhan ang mga gurong nag-i-instigate daw ng mga estudyante na magrebelde. Inulit pa nga ng PNP at AFP sa Senado ang kanilang kathang-isip na datos na pinagbasihan ng mga ito gaya ng listahan ng mga eskuwelahan, kabilang ang PUP at UP, na may recruitment daw ng mga terorista. Kathang-isip din ang paratang na "rebel schools" ang mga paaralan ng mga Lumad, ang dahilan ng utos na bombahin ang mga ito at kung bakit natigil ang pag-aaral ng libong kabataang Lumad ngayon. Nauna ko nang kinondena, Mr. Speaker, ang modus ng red-tagging at itinuturing kong "wholesale death threat" ito dahil sa iisang pagpaparatang lang sa tao o organisasyon, kahit walang mga factual o ligal na basehan, ay nilalagay na sa panganib ang buhay ng mga inosente at sibilyan. Itinuturing silang mga rebelde kaya target ng militar at pulis ang mga kabataan, pati na ang mga guro, magsasaka, pesante at human rights defenders.

Dinedemonisa ang pagra-rally. Buwan po ng Agosto ngayon at ngayon ay isang mahalagang araw sa kasaysayan. Ang wika, gaya ng rally, ay manipestasyon ng pagkakaisa ng saloobin at pagkamakabayan. Alalahanin din natin na sa sama-samang pagkilos nagsimula ang pagtindig ng milyung-milyong Pilipino laban sa dayuhang mananakop, ang Espanya at Estados Unidos. Sa mga rally ay naipapahayag ng ilang milyong Pilipino ang kanilang pagkondena sa korapsyon at pork barrel, at sama-samang naitutulak ng maliliit na mamamayan ang kanilang mga panawagan. Ang bawat amyenda sa Salary Standardization Law, halimbawa, itinutulak ng mga titser at empleyado ng gobyerno na lumabas at igiit sa gobyerno ang kanilang karapatan sa nakabubuhay na sahod. Mga rally at ibang porma ng kolektibong pagkilos ang nagpanalo sa mahabang kampanya para sa libreng edukasyon sa kolehiyo. Dinedemonisa ang aktibismo pero ang tapang at dedikasyon ng mga aktibista, lalo na ng mga kabataan at mga grupong nagmumula sa sektor ng edukasyon, ang nagpapanatiling maalab ang pambansang laban, gaya ng kampanya para sa nakasasapat na budget para sa edukasyon. Ang kanilang tapang at dedikasyon ang nagpabagsak sa isang diktador at naging susi sa pagbagsak sa iba pang rehimeng napatunayang gumamit ng poder para pagsilbihan ang pansariling interes at hindi ang interes ng mamamayan.

Sa katunayan, Mr. Speaker, ginagawa ang redtagging dahil sa napakatinding takot nila sa kabataan at sa kapangyarihan ng sama-samang pagkilos. May witchhunt at sistematikong mga atake dahil kinakatakutan ang produkto ng tapang at dedikasyon ng mga estudyanteng aktibista. Napakainit ng dugo ng mga kabataan sa kanilang mga organisasyon at mga representante sa loob at labas ng Kongreso dahil sila ang nagmumulat, nag-oorganisa at nagmomobilisa laban sa mga kamalian ng gobyerno at inhustisya sa lipunan.

Kung hihiramin ko nga, Mr. Speaker, ang wika ng mga kabataan, "Walang mali sa paglaban, may mali kaya may lumalaban." Kaya pinananawagan ko na ang red-tagging sa mga lehitimong samahan at lehitimong karaingan ng mga mamamayan ay tigilan na. Sa halip na witch-hunt, atupagin natin sa Kongreso ang paghuli sa malalaking drug lords, ang pagpapatigil ng polisiyang EJK, iligal na pag-aresto at detensyon, mga programang tokhang at anti-tambay na bumibiktima sa di bababa sa daang mga bata at kabataan, at ang paglaban sa panghihimasok ng Tsina sa ating exclusive economic zone. Pinapahayag ko rin ngayon ang pagkondena ng sektor ng edukasyon sa mga kahalintulad na pakana ng kamay na bakal sa loob ng ating mga eskuwelahan gaya ng pagpapasok ng mga pulis sa mga eskuwelahan, mandatory drug testing, ROTC, programang "junior police" at seminars kontra droga at terorismo kuno pero walang ginagawa kundi mag-red-tag.

Kamay na mapagkalinga ang dapat ibigay sa ating mga eskuwelahan at mga estudyante, mas mataas na pondo para sa mga pangangailangan, mas mataas na suweldo para sa ating mga guro at kawani, at hindi kamay na bakal. Ang isang rehimen ang naglalantad sa sariling disenyo para sa pambansang diktadurya kung pati mga eskuwelahan ay nilalapatan ng diktaduryang sumisikil sa mga karapatan ng mga kabataan.

Iyan lang po, Mr. Speaker, at sa mga kapwa kong Mambabatas, marami pong salamat.

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized.

REP. LACSON-NOEL. Mr. Speaker, for his interpellation, I move to recognize the Gentleman from BAYAN MUNA Party-List, the Hon. Carlos Isagani T. Zarate.

THE DEPUTY SPEAKER (Rep. Hernandez). The Hon. Carlos Zarate is hereby recognized.

REP. ZARATE. Thank you, Mr. Speaker. Puwede ho bang magtanong tayo sa ating kagalang-galang na Kinatawan ng ACT TEACHERs Party-List, the Hon. France Castro.

REP. CASTRO (F.L.). My pleasure, Mr. Speaker.

REP. ZARATE. Salamat po, G. Ispiker.

G. Ispiker, katulad po ni Kagalang-galang France Castro, ang Kinatawang ito, noong siya po ay nasa kolehiyo pa, ay naging isang estudyanteng aktibista rin dahil sa mga panahong iyon sa gitna ng diktadura ay sobra ang paninikil sa mga karapatan ng ating mamamayan. Ang nagpamulat po sa akin ay ang organisasyon ng Student Christian Movement of the Philippines kung saan naging miyembro tayo, at naging miyembro din ng College Editors Guild of the Philippines. Sa katunayan, noong panahon na iyon, Mr. Speaker, talagang ang mga kabataan at mga estudyante noong panahong iyon ang siyang nangunguna, kasama ng ibang sektor, para sa panawagan na wakasan na ang diktadura at magkaroon na ng pagbabago sa ating lipunan. Sa bulwagang ito, sa aking pagkakaalam, napakaraming mga Kinatawan ng iba't ibang distrito at maging ng mga party-list na sa kanilang kapanahunan na sila ay estudyante ay naging mga aktibista rin at nanawagan ng pagbabago sa ating lipunan.

Ito pong nangyayari ngayon na witch-hunt sa mga kabataan at estudyante sa iba't ibang mga unibersidad at paaralan ay nakakabahala po, at parang ini-equate natin ang aktibismo, ang pagiging mapanuri ng mga kabataan, sa terorismo at kailangan supilin ito. Para tayong dinala o binalik doon sa panahon ng diktadurang Marcos na kapag ikaw ay nagsalita at nagtanong ay puwede ka nang hulihin, puwede ka nang ikulong at ang masaklap pa, puwede kang patayin. Kaya ang unang katanungan ko po, Kagalang-galang France Castro, doon sa inyo pong talumpati, ano po ba ang dahilan o bakit ba ang mga kabataang estudyante ay nagiging mga aktibista, sa tingin po ninyo?

REP. CASTRO (F.L.). Maraming salamat po doon sa tanong ng ating kasamahan at Representante mula sa BAYAN MUNA Party-List. Kung pagbabatayan po iyong aking naging karanasan bilang estudyante mula sa institusyon ng mga estudyante ng pagtuturo, sa Philippine Normal University, ang naging simula ng pagiging aktibista or tanong ng estudyanteng aktibista, ay parang inquiry, parang gusto nating malaman mula sa katanungan—bakit nakikita natin itong mga bagaybagay na mayroong conflict sa ating lipunan? At nakikita natin, tinatanong natin-bakit? Ako noong una, first year college pa lang ako, patuloy na iyong pagra-rally para sa press freedom. Kaya nga 16 years old pa lang ako, marami na akong mga tanong kung bakit may mga ganito sa lipunan. So, doon nagsisimula iyong inquiry bakit tila itong mga karapatan na ito ay nasasagkaan, samantalang ang mga ito naman ay ginagarantiyahan ng ating Konstitusyon. Dito nagsisimula kung bakit ang estudyante ay nagiging aktibista, nagsisimula siya sa pagtanong sa mga bagay-bagay na, sa tingin nila, ay dapat normal na nae-enjoy sana ng mga mamamayan pero hindi nangyayari. So, doon nagsimula iyong aking

pagiging aktibista, dito nagsimula, at sa tingin ko, ito iyong bakit ang mga estudyante natin ay kumikilos—para baguhin itong nakikita nilang mga mali sa ating lipunan.

REP. ZARATE. Salamat po, G. Ispiker. Tama po iyan dahil sa lahat ng mga sektor ng lipunan, ang kabataang estudyante ay may mahabang panahon, nasa unibersidad sila, nasa eskuwelahan, may panahon silang magsuri, at iyon nga, ang magtanong. Kahit tingnan natin sa ating kasaysayan, talagang ito ang sektor na nangunguna doon sa pananawagan sa mga reporma sa lipunan. Kung matatandaan natin, kahit na ang ating mga pambansang bayani na sina Rizal, Bonifacio, Emilio Jacinto, mga kabataan sila noong sila ay namulat na mayroong masama at hindi maganda sa lipunan at kailangang baguhin ito. Hindi ho masama talaga ang magtanong at hindi masama ang pagiging aktibista.

Kaya nakakabahala po itong naririnig natin ngayon, na sinasabi ng iba na pinapayuhan ang ating magulang na kapag napansin daw ng mga magulang na ang mga bata ay nagtatanong na at suplado na raw, ay dapat daw mabahala na sila dahil baka naimpluwensiyahan na daw ito ng mga komunista. So, nakakabahala po iyon dahil, ang ibig ba nating sabihin, halimbawa, sa Hong Kong ho ngayon, nagpoprotesta ang mga residente ng Hong Kong dahil sa isang napakasamang batas na ipapasa sana ng kanilang lehislatura, iyong Extradition Treaty. Ang ibig po bang sabihin, itong mga kabataan ng Hong Kong ay naimpluwensiyahan na rin ng mga komunista?

So, iyon po ang nakakabahala dito dahil ito ngang nabanggit ninyo kanina, kahit na noong nakaraang taon, iyong palpak na palabas na *The Hunt for Red October*, ang target din doon ay mga kabataan. Ang sunod ko pong tanong, bakit ho sa ating kasaysayan noon pa man at hanggang ngayon, gusto nilang supilin, lalung-lalo na ang unang susupilin nila ay ang hanay ng ating mga kabataang estudyante, kaya ano ho sa tingin ninyo ang dahilan doon?

REP. CASTRO (F.L.). Alam ninyo po, Mr. Speaker, ang kabataan po ay punung-puno iyan ng ideyalismo. Ang mga kabataan po ay punung-puno ng mga pagtatanong sa mga paligid-ligid sa ating lipunan, kaya iyong mga kabataan po na naghahayag ng mga katanungan sa ating lipunan, sana ay hindi ito— maging tayong mga adult, mga magulang at siyempre, iyong mga nakatataas na katungkulan sa ating lipunan, sana magpakita tayo ng halimbawa sa pagsunod sa mga batas, sa pag-fulfill ng mga pangangailangan ng mga kabataan at ng mga mamamayan, so, ito po, Mr. Speaker.

REP. ZARATE. Salamat po, G. Ispiker. Tama po kayo na dapat nga hong pagpugayan natin ang ating mga kabataan sa ngayon dahil hindi nila binibitawan iyong kanilang napakahalagang papel sa ating lipunan na patuloy na maging kritikal at mapagmasid, punahin ang kanilang magulang, ang kanilang mga lider kung ito ay may mga pagkakamali para maiwasan nating maulit na muli ang mga kamalian ng nakaraan.

Sa katunayan, sabi ko nga, parang umuulit-ulit lang ang kasaysayan dahil iyong mga ipinaglalaban ng ating mga bayani noon na sina Bonifacio at Rizalhalimbawa, nabanggit ninyo kanina ang panghihimasok at pakikialam ng mga dayuhan ay nangyayari pa rin iyan ngayon. Kaya ito ay buhay na mga isyu na dapat talagang lahukan at makialam ang ating mga kabataan. Hindi ko na ho hahabaan ang aking pagtatanong at mayroon pang ibang magbibigay ng kanilang talumpati. Siguro, ang mensahe lang natin dito, G. Ispiker, lalo pa ang institusyong ito, ang Kongreso, ay hindi dapat maging instrumento para mas lalo pang supilin ang mga karapatan ng ating mga mamamayan, ang kabataan o iba pa at kahit ano pa mang sektor, sa ating pagtutulak ng mga imbestigasyon, paghahain ng mga panukalang batas o kung ano pa mang aksiyon na gagawin ng institusyong ito. Bagkus, dapat ang institusyong ito ay maging tagapagtanggol sa mga karapatan ng ating mga kababayan, sa mga karapatan ng ating mga mamamayan, lalung-lalo na sa panahong ito na puno ng mga pangamba ang ating mga mamamayan dahil sa mga sunud-sunod na mga pangyayari sa ating lipunan.

Kaya nagpapasalamat po ako kay Kagalang-galang France Castro sa pagdala ng isyung ito sa bulwagang ito, at hinihikayat natin ang ating mga kasamahan na samahan ang ating mga kabataan. I-encourage sila na gampanan ang kanilang napakahalagang papel sa ating lipunan, lalung-lalo na sa ating paghanap ng tunay na pagbabago at tunay na pag-unlad sa ating bayan.

Maraming salamat po, Kagalang-galang na France Castro. Maraming salamat, G. Ispiker

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized.

REP. SINGSON-MEEHAN. Mr. Speaker, I move to refer the speech of Rep. France Castro and the interpellations thereon to the Committee on Rules.

THE DEPUTY SPEAKER (Rep. Hernandez). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.

The Majority Leader is recognized.

REP. SINGSON-MEEHAN. Mr. Speaker, I move to recognize the Gentleman from the BUHAY Party-List, Rep. Jose L. Atienza Jr.

THE DEPUTY SPEAKER (Rep. Hernandez). The Hon. Jose Atienza of BUHAY Party-List is hereby recognized.

PRIVILEGE SPEECH OF REP. ATIENZA

REP. ATIENZA. Maraming salamat, Mr. Speaker, Majority Leader. With the indulgence of my colleagues, the honorable Members of Congress, this Representation would like to deliver a message today as a matter of privilege.

Mr. Speaker, today marks the 1,109th day of the Duterte administration—tatlong taon at 14 na araw. On day one, he declared war on drugs. Nagdeklara po ng all-out war. I am just quoting his terminology at totoo po naman naging giyera ang labanang ito at ang problema ay tinugis sa lahat ng sulok ng ating bansa.

Today, we ask the question, as I asked the question in the communities. Tinatanong ko po sila kung nasaan na tayo sa droga. Ang sagot nila ay simple at malinaw—wala pong pagbabago sapagkat ang droga ay lumalaganap sa ating mga lungsod at maraming probinsiya.

So, I ask the question: What can we do at this point in time to help the President in this declared war against drugs? We are elected Members of Congress. You are representing districts; we are representing party-lists nationwide. I ask the same question to my fellow partymate: Ano ang magagawa ng Kongreso upang ang giyerang ito ay maipanalo ng ating bansa? We should ask this question, Mr. Speaker; otherwise, if the President loses this war, we will be in deeper—pardon my word—we will be in deeper shit sapagkat ang giyerang ito ay giyera ng lahat ng tao. Ang puhunan dito ay bilyun-bilyong dolyar na umaapaw sa mga bansang dinudumog ng droga.

Today, all over the country, in our open oceans, in our high seas, we find bundles and crates of cocaine, shabu and other forms of drugs-illegal drugs which are obviously ready for pickup. Ano ang ibig sabihin nito? Ang ibig sabihin nito, ang Pilipinas ay nagiging sentro na at tambakan ng droga. Maaari ngayon ay Asya, subalit sa darating na panahon ay maaaring tayo na ang sentro ng mundo. So, we have no choice, my dear colleagues. We are part of the solution. We have to help the President. Ngayon, binabatikos siya by no less than the United Nations. Can you imagine that—the United Nations meddling in our internal problem? Siya ay binabatikos ng mga diyaryong tulad ng The New York Times in their editorials, calling him practically stupid and nincompoop. Iyan po ay hindi natin dapat tanggapin, mga minamahal ko at iginagalang na mga kasamahan sa Eighteenth Congress. The President declared war and the least we can do is to support him if we cannot do anything else. When he declared war, I was in Congress. The Seventeenth Congress did not utter one word to support the President on this war. Wala po akong alam na giyera na idineklara ng isang Pangulo na hindi sinuportahan ng Kongreso.

Ang Amerika ay nagdeklara ng giyera sa Hapones,

sinuportahan agad ng Kongreso. And United Kingdom ay nagdeklara ng giyera sa Germany, suportado ng Kongreso. Lumaban sa Hapones, suportado ng Kongreso. Tinatanong ko po ang aking sarili, tanungin din ninyo ang inyong sarili: Ano ang ginawa natin noong Seventeenth Congress? Nganga! Iyan ang salitang kalye. Nganga! Wala tayong ginawa sapagkat hindi natin interes labanan ang droga.

So, I call on each and every Member of Congress today in the Eighteenth Congress, search your conscience, ask yourselves: What can we do at this point in time? After 1,109 days, we have not won the war. The President is on his rounding bend, nasa homestretch na siya. Three more years and after that, he will be gone in the daily affairs of our country. By that time, if he has not won this war, we will inherit the problem. Wala po tayong choice. We have no choice at this point in time but to join him in this war. In every district, in every province, in every city, let us lead the war against drugs; otherwise, you and I and our family members and our grandchildren will suffer the consequences of inaction. Talo po tayo rito kapag hindi tayo gumalaw. I call on everyone, let us have a unanimous resolution to support the President and declare to the whole world that the Philippines is united in this fight, in this war against drugs. We cannot just fold our arms and watch. We cannot just watch the parade. We cannot enjoy even the clowns now going around. If we cannot be part of the solution, let us not even contribute to the problem.

Ang droga ay isang mapanganib na elemento. Ang giyera sa droga, kung tutuusin natin, masahol pa sa giyera ng sangkatauhan. We defeated the Japanese in less than three years. We defeated them and we won our war against these Japanese in equal time, but the problem on drugs is even growing bigger and bigger everyday. We have no choice except violence, and violence will only beget more violence. Alam na natin iyan kaya naririnig natin ngayon, death penalty is the solution.

Sira ba mga ulo natin? Death penalty. Hindi na nga natatakot iyong mga drug lord, mga drug pusher sa kamatayan—death penalty, as if it is the panacea, the solution. It is the solution of people who are not thinking about the future and who are not concerned about the present, and we will all be blamed by history that here is an opportunity for us to beat to a pulp and remove this from the bowels of our earth and the beauty of our country, the beauty of our island, the beauty of our people. Alisin natin ang problema ng droga. Ngayon ang pagkakataon.

I call on all of you. I call on those who are involved and, in fact, many contributed much of their time to try and address the problem. Individually, maybe coming from the outside, they filed a resolution in this Congress, maybe. Pero, tinatanong ko kayo, mayroon ba tayong na-file na resolution dito to support President Duterte para sabihin sa International Court of Justice, "Huwag kayong makialam, the Congress of the Philippines is in action." Sabihin natin sa United Nations—any one of you can stand up there and say—"The Philippine Congress, we, the Members of Congress, are all behind the President."

I would like to do my share at this point in time. I am on my third term as Congressman and here comes an opportunity to be more useful. Gusto kong masabi sa mga darating na henerasyon, "Si Lito Atienza, ginawa ang kanyang tungkulin bilang halal, hindi hangal." Nagmumukha tayong hangal nito, pasipul-sipol tayo. Wala tayong pinag-uusapan kundi pera, budget. Tayo ba ay pang-budget lang, para sa renaming of schools, the building of another extension office? Iyan ba ang ating pinagkakaabalahan dito? Why do we not look at the problem of drugs in the country? Prevention—how can we prevent the growth of the problem when we are not even attending to the possible solution?

Our colleague, Cong. France Castro, stood here, interpellated by the Heneral Antonio Luna of the Seventeenth Congress, and correctly, they are worried about the activism that the youth are getting involved with. Mabuti na lang mayroong activism silang napupuntahan dahil kung hindi, droga rin ang pupuntahan ng mga iyan. Pumunta kayo sa mga public school, pagtunog ng bell ay takbuhan ang mga bata, nasa internet café na at nagbabayad upang gumamit ng social media. Why do we not study how to educate the young today in a more effective manner? Wala silang kultura. Wala silang palakasan. We have removed culture and sports in schools and then we are surprised that they are now clinging to drugs and shabu. Everything is definitely glaringly clear. The young people today have nowhere to go except to cling to drugs when they are depressed and many come from troubled families.

Ibalik natin ang kultura. Magagaling sumayaw ang ating mga batang Pilipino. Ibalik natin ang palakasan, kampeon tayo at one time. Name it, the Filipino was a champion in swimming, tennis, even basketball—matatangkad ang kalaban natin pero panalo ang Pilipino. We were number three at one point in the world. Nasaan tayo ngayon? We are facing the Southeast Asian Games—I predict we will be in the bottom rung, if not in the last rung. Wala po tayo talagang programa para sa mga bata. Mabuti na lang kung sila ay napupunta sa aktibismo upang ipaglaban ang mga kamalian sa lipunan. Pero huwag nating pabayaan sila sapagkat wala pong pupuntahan ang mga kabataan kung puro sa kalye na lang ang kanilang aasikasuhin.

Let us give them a more meaningful experience in grade school, in high school. We can produce the best swimmers of Asia. We can produce the best boxers. If Manny Pacquiao can become a world champion for the eighth time in eight divisions, many Filipinos could be like Manny Pacquiao. We are gifted by God with

so many talents. We are gifted with a country having luscious green mountains and at one point, 14 million hectares of virgin forests. Nandiyan po lahat ang yaman ng kalikasan. Ang ating katubigan, at one point in time, was the envy of the world pero tingnan po ninyo ngayon, tingnan ninyo ang Manila Bay, isang malaking poso negro. Tingnan ninyo ang Laguna de Bay, nagsisigaw na tayo rito ngunit hanggang ngayon marumi, polluted ito. Ang mga isda diyan ay lasang gilik, burak, at hindi ninyo dapat kainin sapagkat baka mayroong mercury.

Tayo ay hindi pinabayaan ng Panginoon. Noong nilikha ang sangkatauhan, ang Pilipino ay binigyan Niya ng espesyal na atensiyon. Magagandang tao tayo. Tingnan ninyo ang ating Congresswomen, they can all qualify as Binibining Pilipinas, bawasan lang natin ng 10 taon ang kanilang edad. Tingnan ninyo ang mga kalalakihan, magagandang lalaki tayo, matatalino, subalit hindi natin ginagamit ito sa mga problemang kailangan ng solusyon.

Iyong enforcement, tingnan po natin, magkano po ang budget ng PDEA, isang bilyon? Naglalaro ba tayo, nagbibiro ba tayo? Pagdating ng budget dito, silipin natin ang budget ng PDEA kung isang bilyon pa rin. Aminin na natin na tayo ang nagkukulang. Bigyan natin ng 10 bilyon iyan, bigyan natin ng 20 bilyon upang iyong enforcement arm ay maging mas epektibo. Tingnan natin ang rehabilitation, ano ang ginagawa natin to rehabilitate drug addicts? Do we consider them as criminals? That is the simplest way of doing it. "Impose the death penalty" ang sigaw ng marami. Maghunos-dili tayo dahil hindi solusyon ang death penalty. Ang solusyon ay nasa kamay ng Kongreso. Ang tunay na paraan upang masugpo ang droga ay nasa kamay ng Congressmen. Dito nagmumula ang pondo ng pamahalaan. Dito natin pag-usapan kung papaano tayo makakatulong sa ating Pangulo. Tayo ay magpasa ng resolusyon sapagkat malaking pagkukulang ito na ang Kongreso ng Pilipinas ay tahimik sa problema ng droga. Maaaring magtanong ang iba, "Kasali ba kayo diyan? Bakit kayo ay hindi nag-iingay? Bakit hindi kayo kasali doon sa kampanya?"

We should be part of the war against drugs. This is the call that I am making today. Huwag natin sayangin ang pagkakataon na tayo ay makibahagi sa solusyon ng droga; otherwise, the President will not succeed and we will all be part of the sector to be blamed, especially us Members of Congress. Now, we should set aside partisan consideration. We should set aside personal differences. Let us unite and tell the world that in this country, we are united with the President in the fight against drugs and to remove drugs in our country. And if we succeed, we would have proven, once again, that the Filipino indeed is different from the rest.

We removed the dictatorship without shedding a drop of blood. Inalis natin ang mga Marcos sa kanilang pagiging diktador ng bansa nang hindi natin kinailangang pumatay at hindi tayo nagpadanak ng dugo. Maaari nating gawin ito ngayon na hindi na mapapatay ang mga bata, at marami sa kanila ay walang kamalay-malay o kaya ay nasasangkot lang dahil sa kahirapan. We cannot turn our heads away from the fact that the solution that the President is using today needs a lot of refinement, and we can make suggestions if we are part of the effort. Otherwise, we can be branded as nothing but young politicians who are sourgraping and doing nothing but to criticize, not offering a solution.

Ito na ang paraan, Mr. Speaker. Let us urge this Eighteenth Congress to make history. Kung nakalimutan ng Seventeenth Congress ito, huwag nating kalimutan ngayon. We should all be part; we should all be major sponsors. It is not going to be sponsored by me or anyone, but it will be sponsored by the Congress of the Philippines that we are solidly behind President Duterte in his war against drugs. Let *The New York Times* say whatever they want. Let the United Nations say what they want. Let the International Criminal Court say what they want. What is important is what the Filipinos are saying through their elected Members of Congress. Iyan ang kailangan ng ating panahon ngayon.

Hinahamon ko kayong lahat, magkaisa tayo. Let us back up the President in his war against drugs; otherwise, we might as well close shop kung ang pag-uusapan lang natin dito ay renaming provinces, streets, alleys, extension of offices, development here, development there. Wala na pong dadatnan ang susunod na henerasyon kung ang droga ay hindi masusugpo ngayon. Parang mikrobyo iyan, parang bacteria iyan, na kapag iyan ay ginalaw, kapag iyan ay hindi nabura at hindi nakuha sa isang iglap, iyan po ay lalala. I dread the day when President Duterte is no longer around and we are left behind with the big problem of the drug menace engulfing each and every home in the country.

So after this, honorable Members of Congress, let us go around our districts, let us spread to each and every home, ibalita natin sa kanila at sa lahat ng ating makakausap, sa bus, tren at eroplano, na ang Kongresong ito ay hindi titigil hanggang hindi natin nasusugpo ang droga sa pangunguna ng ating mayroong lakas ng loob na Pangulo na si Pangulong Rodrigo Duterte.

Maraming, maraming salamat po sa inyong pakikinig.

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized.

REP. SINGSON-MEEHAN. Mr. Speaker, I move that we recognize the Hon. Robert Ace S. Barbers for his interpellation of the Honorable Atienza.

THE DEPUTY SPEAKER (Rep. Hernandez). The Honorable Barbers is hereby recognized.

REP. BARBERS. Thank you very much, Mr. Speaker, and Mr. Majority Leader.

REP. ATIENZA. Gladly, Mr. Speaker, to the Gentleman, Ace Barbers.

REP. BARBERS. Will the Gentleman from BUHAY Party-List be willing to answer a few clarificatory questions? Is the Gentleman from the Party-List BUHAY willing to answer a few questions from this Representation?

REP. ATIENZA. Opo.

REP. BARBERS. Maraming salamat po. Mr. Speaker, my distinguished colleague, nabanggit ninyo po kanina na kailangang magkaisa ang Kongreso sa pagpapakita ng pagsuporta sa deklarasyon ng giyera laban sa droga ng ating Pangulo. Tama po ba?

REP. ATIENZA. Tama po iyon. Iyon po ang aking binigkas.

REP. BARBERS. Iyon po bang sinasabi ninyong pagkakaisa na dapat gawin ng Kongresong ito, dapat po ba tayo ay magpasa ng isang resolusyon, wherein it will be adopted by this House, expressing our sentiments and support for the war against drugs of our President?

REP. ATIENZA. Iyon po sana ang ating minumungkahi. Immaterial whether you belong to the Nacionalista Party, the Liberal Party, Buhay Party, birthday party.

REP. BARBERS. Ako po ay nagtatanong lang, Mr. Speaker, my distinguished colleague. If this resolution would be material, if we adopt and submit this to the United Nations for whatever it is worth, ito po ba ay makakatulong sa imahe ng ating Pangulo, na sa aking paniwala, ay negatibo sa mata ng mga taga-United Nations. Tama po ba?

REP. ATIENZA. Of course, malaking tulong po iyan, Mr. Speaker, sapagkat ang UN ay, siyempre, tumitingin sa ating bansa. Ang kanilang mga isyu roon, sinasabi nilang ito ay personal na kampanya ng isang tao, ang Pangulo ng Republika, dahil wala nga pong suporta ang Kongreso. Para bang kung nagdeklara ng giyera si Franklin Delano Roosevelt at hindi sumuporta ang Kongreso ng Amerika, palagay ko ay pagtatawanan siya ng mundo. Ganoon din po ang UK noong nagdeklara ng giyera ang Prime Minister ay agad sumagot, sumigaw ang Kongreso nila, ang Parliament nila, at nagsabing, "Sinasamahan namin ang ating Pangulo dito sa labang ito."

Tayo po ay nandito noong Seventeenth Congress

nang sinimulan ito. Naghintay-hintay ako na baka naman mayroong panukala, at tutulong ako, susuporta ako. Pero dumaan iyong tatlong taon, walang ganoong nangyari. Ito ngayon, tuloy ang giyera—homestretch na ang Pangulo natin, nakademanda sa ICC, binabatikos sa UN. Hindi ba kayo naiinsulto, sa editorial ng New York Times na ang Pangulo natin ang binabatikos? Bakit, si Trump ba ay kapuri-puri? Mayroon siyang ginagawang siya lang ang nakakaintindi pero our editorials should not touch on President Trump because he is the President of the United States. President Duterte is the President of the Republic of the Philippines, why is he the subject, hindi lang minsan, hindi lang dalawa, marahil hindi lang lima, na editorial ng *New York Times* upang batikusin siya at pagmukhaing kriminal.

REP. BARBERS. Ako po, sang-ayon, Mr. Speaker, my distinguished colleague, sa inyong panukala na magkaroon ng isang boses na magpapakita ng suporta sa ating Pangulo dito sa kanyang giyerang idineklara laban sa illegal drugs. Ang akin lamang po, Mr. Speaker, Your Honor, is if this would, in any way, help improve or perhaps erase the negative image of the President before the United Nations. Maybe, perhaps, we can also ask our colleagues from the Senate to do the same if we, indeed, are interested to pass and adopt a resolution to that effect.

Alam ninyo po, Mr. Speaker, distinguished colleague, iyong buong Seventeenth Congress ho ay maraming accomplishments sa ating giyera laban sa droga. Kaliwa't kanan ang batikos na tinanggap ng ating administrasyon dito sa laban na ito, ngunit maraming hindi napapag-usapan na accomplishments. Sang-ayon po ba kayo diyan, my distinguished colleague from BUHAY Party-List?

REP. ATIENZA. Tama po iyon, iyan ang nangyayari. Ang naririnig lang ay iyong bumabatikos at walang naririnig na sumasang-ayon. Kaya tayong mga halal na Kinatawan ng bayan ay dapat marinig, we have to be heard on this issue. As I have said, if war has been declared, then Congress should react. Are we in support of the declaration or do you want to keep quiet? I urge all of you, as silence is not an option and so, we must shout at the top of our voices so that our people will hear the message—we are with the President. And the UN, whether they are influenced in their thinking or not, is not a material thing, but they should and they would listen if they realize that the 302 Members of Congress are in agreement with the war declared by the President.

REP. BARBERS. Well, maraming salamat, distinguished colleague, Mr. Speaker, pero sa aking paniwala, siguro ho, before we even express iyong ating 101-percent support sa ating Pangulo dito sa

giyera laban sa droga, ay dapat ipakita muna natin sa taumbayan, even among our constituents, even among the different provinces and districts in this country, that we, as Members of this Congress are, 'ika nga, may karapatan na, kaakibat ng ating Pangulo, lumaban sa giyera sa pamamagitan siguro ng pagpapakita na tayo ay hindi mga gumagamit ng illegal drugs.

Mr. Speaker, distinguished colleague, this Representation filed a resolution in the Seventeenth Congress, and I also refiled that resolution in this Congress, that we should all undergo drug testing to prove to our constituents that we are in unison with our President in this fight against this drug menace. Hindi po biro ito. Ito ho ay napakahabang giyera. In fact, the US has fought this war in the past four decades, and they are just inching closer every decade to achieving iyong kanilang goal.

Sa atin po, sa panahon ng ating Pangulo, no other President in this country has been bold enough to announce and make public those involved in the drug problem. What I am referring to, Mr. Speaker, my distinguished colleague, are officials of government, narco-generals, narco-judges, narco-fiscals, narco-politicians—all these names have been kept by the last several Presidents who served in this country, but this President was bold enough to mention their names. Unfortunately, there were names mentioned that have not been validated, but these were, later on, corrected by no less than the President.

Mr. Speaker, my distinguished colleague, itong givera must go on for the next, perhaps, two, three more decades before we can even accomplish 50 percent of the fight. Ako po ay naniniwala, dahil diyan sa inyong panukala, na kung tayo ay magkakaisa, kung tayo ho ay magsasama-sama, at tayo ay magpapakita ng suporta sa ating Pangulo—tama ho kayo, iyong silence is not an option. If we keep silent or if we keep on hearing all these critiques against our President but never dare to answer them, never dare to make a comment correcting that impression, Mr. Speaker, Your Honor, maaaring negatibo ang magiging tingin sa ating Pangulo. That is why, with that, Mr. Speaker, my distinguished colleague—I would like to say this because ang ating butihing kagalang-galang na Congressman mula sa BUHAY Party-List ay isa po sa mga iniidolo ko at alam ko po, noong siya ay nanungkulan bilang Mayor ng City of Manila ay maraming mga drug cases ang kanyang binigyan ho ng priority na supilin itong mga drug pushers at drug addicts sa kanyang lungsod.

Let me just state for the record, Mr. Speaker, Your Honor, that the Committee on Dangerous Drugs in the last Congress approved several bills on Third Reading. Unfortunately, hindi na po ito napasa at hanggang House na lang po ang mga ito dahil ang ating mga counterpart measures sa Senado ay hindi po umabot ng Third Reading. So, I hope I get the support of the distinguished

Congressman from the BUHAY Party-List in all these bills that we will be tackling in this Congress.

Thank you, Mr. Speaker.

REP. ATIENZA. Mr. Speaker, the challenge posed by the Gentleman, Congressman Barbers, should not go unheeded by this Congress. We should all accept it. We should all undergo a drug test and let those who are afraid to have a drug test be known to the whole country. Kayo ayaw ninyo, kami gusto namin. I second the motion of the Congressman that we, all Members of Congress, should start our own war on drugs. In support of President Duterte, let us first clear ourselves. Hindi tayo kasali sa problema; kasama tayo sa solusyon. Kaya ito po ay magiging panimula, and it will serve as an impetus for the second half of the administration of President Duterte. As you said, he is the only President who dared to stand up to the problem of drugs in the country, kaya tulungan natin dito sa susunod na dalawang taon by way of providing what he needs to succeed: prevention, reinforcement and rehabilitation. Hindi makukuha ito sa patayan lang nang patayan.

As I have said, and I will repeat it, violence will only beget more violence. It will not solve the problem. I hope, after the drug testing or during the drug testing, ipasa natin ang resolusyon na ito. I will prepare it. I will ask all of you to sign or co-sign it. We are all sponsoring it—not one, not two, but 302, all of us, except those who will have second thoughts about signing such a document and will refuse to have a drug test done on themselves. Then, we should understand why they are shying away from the solution. Malaking tulong ito sa ating Pangulo sapagkat napipinto ang imbestigasyon ng ICC at kapag narinig nilang 302 Congressmen are part of the war, they will have serious thoughts about fighting the whole nation. Sa UN, bago tumayo ang sinuman doon, mag-iisip din. Ang New York Times, they are a regular media member, they will think twice if they know that Filipinos are united behind this war on drugs. Kaya sana ang aming pag-uusap na ito ni Congressman Barbers ay magbunga ng reaksiyon sa inyo pagdating ng resolusyon sa inyong mga tanggapan at ivong schedule ninvo for sa drug testing.

I will wait for the action of Congressman Barbers along that line. It is very, very essential for us to go into battle with clean hands so that nobody can get back at us and say, "Iyan, kaya lang nagagalit iyan ay dahil nauubos iyong kanyang negosyo sa kanyang distrito." Maririnig ninyo iyan dahil hindi naman lahat ay natutuwa dito sa aming pag-uusap na ito. I am sure I will be condemned by many quarters but I do not care. I care for the future of our children, the future of our nation. We want a prosperous Philippines by the next generation, or even during this time. We are doing our best for all of them.

Thank you, Congressman Barbers. Thank you, Mr. Speaker.

Mukhang nagbago kayo ng anyo. Thank you, Mme Floor Leader.

THE DEPUTY SPEAKER (Rep. Hernandez). The Majority Leader is recognized.

REP. SINGSON-MEEHAN. Mr. Speaker, I move to extend the Privilege Hour.

THE DEPUTY SPEAKER (Rep. Hernandez). Is there any objection? (*Silence*) The Chair hears none; the motion is approved.

The Majority Leader is recognized.

REP. SINGSON-MEEHAN. Mr. Speaker, for his chance to interpellate, I move that we recognize the Gentleman from the Second District of Caloocan, the Hon. Edgar R. Erice.

THE DEPUTY SPEAKER (Rep. Hernandez). The Hon. Egay Erice is hereby recognized.

REP. ERICE. Thank you, Mr. Speaker. Will the Gentleman from the BUHAY Party-List yield to some questions.

REP.ATIENZA. Opo, with pride and joy, I will answer questions coming from the Gentleman from Caloocan.

REP. ERICE. Thank you, Mr. Speaker. Mr. Speaker, I agree that all of us, not only the Members of this Congress, but all the Filipino people should support the government's efforts to curtail the drug problem, the drug menace. The drug problem is a very complex problem. It is not only experienced in this country but in the whole world.

Ang katanungan ko po, dahil complex na problema ito, kailangan din po ng isang polisiya na talagang makakasagot sa lahat ng aspeto ng problema ng droga pero hanggang sa ngayon po, hindi ko po masyadong lubos na nauunawaan iyong polisiya ng ating pamahalaan para bigyan ng kalutasan ang problema ng drug abuse, ng pagkalat ng droga sa ating bansa. Kaya gusto ko po sanang—gaya ng sinabi ninyo, we should support the war on drugs. Puwede ninyo po bang ipaliwanag ano iyong anong klaseng giyera laban sa droga? Sapagkat marami na pong giyera laban sa droga sa buong mundo. Gaya ng nasabi ng ating kasamahan, the Gentleman from Surigao del Norte, ang bansang Amerika po, 40 years ang war on drugs nila pero ang sabi po ni Pres. Barack Obama ay they have spent so much time and effort, but failure ang war on drugs nila. So, ano po ba ang konsepto ng war on drugs dito sa ating bansa?

REP. ATIENZA. Sa paningin po ng inyong lingkod, malinaw ang nangyayari—ang Pangulo lang natin ang

nandoon sa gitna na puwede. Umaasa lamang siya sa pulis. Ang Kongreso kasama ba niya? Hindi po. Iyon ang aking panawagan, ang samahan natin siya. Marahil makikinig siya sa atin kapag mayroon tayong iminungkahi dahil kasama tayo sa giyera. Pero kung hindi tayo kasama sa giyera, iyong pulis lang ang pinakikinggan niya. Maraming problema kapag pulis lang ang nagbibigay ng solusyon. Kung anuman ang problema natin ngayon sa mga distrito, sa mga barangay, iyan ay bunga ng sitwasyon na ang Pangulo ay nagsosolo. Nag-deklara ng giyera iyong tao, alangan namang makiusap sa atin, "Tulungan nga ako ninyo rito." Hindi ginagawa ng lider iyon. Nasa atin ang magkusa. Kaya itong aking panawagan ay kusang-loob. Kung sa tingin ninyo makakatulong tayo, ako, sa tingin ko, makakatulong tayo.

Unang-una, iyong pondo. Mayroon ba namang PDEA, drug enforcement na ang budget ay kulangkulang sa isang bilyon lang. Saan aabot iyon? Magkano kaya ang budget ng DEA sa Amerika? Marahil ay daandaang milyong dolyar. Kaya puwede natin bigyan ng mas malaking pondo ang PDEA. Iyong ating sistema ng edukasyon—inalis natin ang kultura at palakasan sa mga public schools. Sino ang nag-alis niyan? Kongreso. Marahil kailangan ibalik na natin ito para ang mga bata ay hindi naliligaw. Kung mayroon siyang pinagaaralang folk dance, aba, makikinabang siya diyan. Kung siya ay basketball player, makikinabang siya diyan. Imbes na magpunta iyan sa internet café, gagawin niya iyong kanyang hilig sa kultura o kaya ay paligsahan sa palakasan. But definitely, it will give the young more inspiration to be part of this great nation. Sila ay taasnoo na haharap kanino pa man—sila ay Pilipino.

Ngayon, pagdating ng SEA Games, tatayo ako ulit dito sapagkat tinitiyak ko, lalampasuhin na naman tayo sa lahat ng larangan. Why? Because we have not given sports an opportunity to go down to the grassroots. Iyong mga maliliit na bata na sumisisid sa Sulo, gawin nating swimmer iyan, pagkagaling-galing na swimmer niyan. Iyong mga batang magaling na kumanta, i-train sila sa ating sariling kultura, pero wala tayo niyan. Mr. Speaker, Honorable Congressman from Caloocan, take a look at our public schools today in Caloocan or Manila. Kulang ang kanilang edukasyon at pagkukulang iyan ng Kongreso. Punahin natin iyan. I will do that, I will do the chore of pointing out to Secretary Briones that there is much to do in reshaping our education curriculum. Otherwise, napakahina ng pundasyon ng mga batang Pilipino na lumalaki ngayon. Kaya iyong nakikita nating kampanya sa droga ay one angle lang, one perspective.

Hindi iyan, I am sure. Ako ay naging mayor din, madalas iyong gusto kong mangyari ay hindi ko magawa sapagkat kulang ako ng suporta mula sa community. Ang police ay ready and willing iyan kaya sabi nga ni Pangulo, "Gusto ko ang mga pulis, sunod lang ng sunod iyan." Iyon ang problema, sunod ng sunod at madalas naabuso na iyong mga tao dahil sa pulis, hindi dahil sa pulitiko. Mas mayroon tayong panimbang kung sino ang tama, sino ang mali at nagingat tayo sa ating hakbang pero ang pulis ay iba. So, we want to be part of the solution, Mr. Speaker, and that is the gist of our message.

At this juncture, Deputy Speaker Hernandez relinquished the Chair to Deputy Speaker Johnny Ty Pimentel.

REP. ERICE. Salamat po, kagalang-galang na Kinatawan ng Party-List BUHAY. Sa pagkakaunawa ko po sa inyong kasagutan, ang ibig ninyo pong sabihin, kinakailangan po talaga ng mga komprehensibo at maliwanag na mga polisiya at hindi lamang nomenclature na "war on drugs." Sa pagkakaunawa ko po sa inyong kasagutan, mukhang hindi po maliwanag kung ano ang ibig sabihin noong war on drugs policy ng ating pamahalaan. Natatandaan ko po, kulang-kulang higit sa tatlong taon na nagkaroon din po ako ng privilege speech dito at nasabi ko nga po na kinakailangan talaga ng komprehensibong programa at kailangan magtulong-tulong tayo dito. Hindi lang iyong mga nasa administrasyon, hindi lang iyong mga nasa oposisyon, kung hindi maging iyong mga nasa health sector, iyong mga scientists natin, mga health experts natin, sapagkat ang problema ng droga ay hindi lang naman criminal justice issue, kung hindi napakalaki pong bahagi ng problema ng droga ay iyong health issue.

So, dahil nabanggit ninyo na rin, mas maganda po siguro kung through the initiative of this Congress ay magkaroon talaga ng isang sangay ng pamahalaan na talaga namang pag-aaralan ang problemang ito at magbibigay ng mga panukala na magiging batayan sa ating pakikipaglaban sa droga. Dapat po mayroong scientific basis iyong ating pakikipaglaban. Sabi ko nga, iyon pong mga bansang gumamit ng puwersa na gaya ng Amerika ay nag-fail. They tried to control the supply of drugs, nagkaroon po ng bayolenteng komprontasyon. Noong kanila po namang na-curb iyong demand side, napuno iyong kanilang mga preso at gumastos po ng bilyun-bilyon ang bansang Amerika sa kanilang prison system pero wala rin pong nangyari at nag-fail din. Ganoon din po sa Indonesia, nagkaroon po ng bayolenteng komprontasyon between the police authorities and drug traffickers and drug users pero napuno rin ang kanilang mga prisons pero wala rin pong nangyari sa kampanya nila sa droga.

Ang kaisa-isang bansang nakita ko po at napagalaman ko na nagtagumpay ay iyong bansang Portugal kung saan dati-rati po dalawang porsiyento ng populasyon nito ay drug addicts o drug dependents. Na-try po na nila iyong war on drugs, the violent type of the war on drugs pero hindi po nag-succeed. So, anong ginawa po nila? Ang ginawa nila ay tinawag po nila iyong mga health experts, mga pulitiko, ang mga magkabilang side sa oposisyon at administrasyon, at gumawa po sila ng maliwanag na mga polisiya—nagtulong-tulong sila at nakagawa po sila ng mga polisiya. Niyakap nila iyong mga drug dependents, binigyan nila ng pagkakataon makapagtrabaho, binigyan nila ng mga maliwanag na polisiya ang criminal justice system, at tinulungan po nila iyong kanilang mga drug dependents. After 14 years, they were able to reduce drug addiction in Portugal by 50 percent and drug-related deaths by 80 percent, pero ang naging susi po noon ay ang napakamaliwanag na mga polisiya nila from criminal justice to health issues, jobs and other social issues. Maliwanag po at naroon lahat, pinagtulung-tulungan ng mga politiko mula sa administrasyon at oposisyon, mula sa mga health experts at mga social scientists, kaya po nabigyan ng tamang solusyon iyong problema. Sa pamamagitan ng mga binanggit ninyo kanina, napa-isip lang po ako na puwedeng iyon ang pagmulan ng mas maliwanag na polisiya upang makapagtulung-tulong tayong mabigyan ng solusyon ang problema ng droga sa ating bansa.

Maraming salamat po.

REP. ATIENZA. Mr. Speaker, marami po sa sinabi ng ating Kinatawan ng Caloocan ay tama and we are in agreement, but the point is, before we ask questions, before we even ask and demand for a genuine program, nasa gitna na po tayo ng labanan at nagpuputukan po. Ang hinihingi po ng inyong lingkod, magdeklara muna tayo, nasaan ba tayo? Are we in support of the President or are we on the silent side. We do not want to involve ourselves and we would like to get a clear picture. Hindi po ganyan ang hinihingi ng panahon. Sumali tayo, sumuporta tayo, and we are entitled to be listened to. Even daily, we can talk about the drug problem here and the President, I am sure, will be listening because we are already part of his special forces. Pero kung hindi tayo kasali, marami pa tayong hihingin muna, hindi po siguro magpapasalamat ang Pangulo at sasabihin na lang: manood na lang kayo ha at ako-nagtatrabaho ako.

So, let us act on this suggestion and let us act on the suggestion of Congressman Barbers. Let us start with clean hands, magpa-drug test tayo, wala naman sigurong mahuhuling drug pusher dito, therefore, we can go to war prepared and unquestioning in the beginning but later on, we have to be listened to, as we also hold the power of the purse. Sabi ko sa inyo na kailangan ng PDEA ng pondo, kailangan ng ating mga paaralan ang bagong curriculum, kailangan ang rehabilitation centers ay matulungan. Hindi kaya ng mga LGUs iyan. Kailangan mareporma ang criminal justice system. Kailangan i-check natin kung totoo itong nangyayari na

sa Muntinlupa ay walang VIP diyan, dahil alam natin ang nangyari diyan, nakakulong pa hanggang ngayon iyong dating Department of Justice Secretary because of that. So, ang aking mungkahi ay pumasok na muna tayo and let us discuss all the points that you are raising in coming up with a better option. We can suggest and we have to be listened to. This is the Congress of the Philippines, hindi puwedeng isantabi ito at siguradong makikinig naman ang mga kinauukulan.

REP. ERICE. Thank you, Mr. Speaker, Your Honor. The mere fact that we are suggesting some solutions, tested solutions, is an expression of support, that is why we are suggesting. As far as I remember, for the past three years, this Congress have been very supportive of the President's agenda on the war on drugs. Even during the last Congress, I was an Independent, but I voted for the passage of our budget which included large amounts of allocation for the war on drugs.

Thank you, Mr. Speaker. Thank you, Your Honor.

REP. ATIENZA. Thank you, Mr. Speaker. Maraming salamat po, Majority Leader, sa pagkakataong ibinigay ninyo.

THE DEPUTY SPEAKER (Rep. Pimentel). The Majority Leader is recognized.

REP. LACSON-NOEL. Mr. Speaker, I move to refer the speech and interpellations thereon to the Committee on Rules.

THE DEPUTY SPEAKER (Rep. Pimentel). Is there any objection? (Silence) The Chair hears none; the motion is approved.

REP. LACSON-NOEL. Mr. Speaker, I move that we recognize the Gentleman from 1-PACMAN Party-List, the Hon. Enrico A. Pineda, for his privilege speech.

THE DEPUTY SPEAKER (Rep. Pimentel). Rep. Enrico A. Pineda of Party-List 1-PACMAN is hereby recognized.

PRIVILEGE SPEECH OF REP. PINEDA

REP. PINEDA. Thank you, Mr. Speaker.

Mr. Speaker, my distinguished colleagues, I stand before all of you today in this august Chamber to bring your attention to a serious problem. Before I go to the main topic of discussion, may I ask if anyone would recall where you were at around 5:11 p.m. on April 22 of this year? As for me, I was in the car going to Tarlac that day. We were travelling on the San Simon viaduct when suddenly, our vehicle started to swerve violently. It felt like we had several flat tires. We managed to stop safely

and while we stopped the car, I looked out the window and I saw several lamp posts swinging back and forth. That was when I realized that we were in the middle of a very strong earthquake, Mr. Speaker. I told my driver to move on because I was afraid that the viaduct might collapse while we were on it. It was a 6.1 magnitude earthquake that struck Central Luzon, leaving at least 13 dead, three missing and 256 others injured.

Mr. Speaker, this was only the beginning of a series of tremors experienced by the Philippine islands for that month. It started last April 22 in Luzon, April 22 in Eastern Samar, Visayas, and April 24 in Davao Oriental and Occidental in Mindanao. Just recently, two successive earthquakes hit the town of Itbayat, Batanes, one with a 5.4 magnitude at 4:16 a.m. followed by another that hit at 7:37 a.m. with a 5.9 magnitude. These unfortunate events took nine lives and left at least 100 injured. It also brought to the ground traditional houses and heritage structures that make up the beautiful islands of Batanes.

Mr. Speaker, are all these a prelude to a major earthquake that will hit the Philippines in the near future? Similar to the devastating earthquake in 1990 as can be shown in the screen, that was what happened to the Hyatt Terraces Hotel in Baguio. It was total destruction and a lot of lives were lost due to the collapsed building and many other unfortunate buildings in Baguio and other parts of the country that collapsed. To recap, it happened on July 16, 1990 at 4:26 p.m., and it was a 7.8 magnitude earthquake that struck the northern and central parts of Luzon, affecting six provinces and resulting in over 1,000 deaths and P10-billion worth of damage to property.

In the last five years alone, the deadliest earthquake in Asia had taken more than 15,000 lives. In 2014, a 6.1 magnitude earthquake in China took the lives of nearly 600 people; in 2015, an earthquake with 7.8 magnitude in Nepal had a death toll of 9,000; in 2016, 116 died as a result of a 6.4 magnitude earthquake that struck Taiwan; and in 2017, a 7.3 magnitude earthquake hit Iran and left at least 620 people dead; and last year, two major earthquakes took almost 5,000 lives in Indonesia. More than the 15,000 lives were lost, Mr. Speaker, and that number is only from the deadliest earthquakes in Asia.

For the past few years, our government has been conducting regular earthquake drills for the public and putting effort on educating our people on disaster preparedness. As mere human beings, we have no power or control over the natural disasters such as earthquakes, but what the government can do is to institute safeguards in order to avoid or at the very least, minimize the loss of lives that earthquakes may cause.

My dear colleagues, are you aware that the government has already issued the guidelines and implementing rules on Earthquake Recording Instrumentation (ERI) for buildings, signed by former DPWH Sec. Rogelio Singson in 2015? It formed part of the IRR of PD 1096 or the National Building Code of the Philippines. It required the installation of ERIs or accelerographs in buildings of a particular size or height. Under the said guidelines, Mr. Speaker, it stated that "the rules on ERIs for buildings were developed to primarily safeguard lives and for clear understanding of the actual dynamic behavior of buildings or structures under earthquake loading." Furthermore, the guidelines defined an accelerometer as a sensing equipment that measures seismic acceleration and passes the information to the accelerograph for further processing and conversion to intensity, velocity and displacement. The latter has the capability of giving an alarm, either audio or visual or both, during an earthquake event. It only takes a few seconds of an earthquake shaking to determine a person's ultimate fate. It could happen without even knowing that an earthquake was occurring. With an accelerograph, the occupants of a building will be alerted and warned that there is an impending earthquake and likewise alert them when there is a need to vacate the premises too.

Mr. Speaker, I was fortunate enough to be invited by the Japan Meteorological Institute when they came to Manila, and together with the representatives from the Road Board and the MMDA, they did an actual demonstration of an earthquake machine. As far as this Representation is concerned, I was very impressed, knowing that Japan has the technology to create such an equipment, but what I saw is a machine that can forewarn the building occupants where they will be given a two-minute window that an impending earthquake is coming. Once the earthquake hits and you are not able to get out of the building, if the building's structural design is unsafe already, the machine will alarm again and tell the occupants that this building is not safe and so, everyone should leave. If there is no alarm after an earthquake, it means that the building is safe and nobody has to get out of the building anymore.

What happened during the last earthquake here in Metro Manila, when it struck, everybody went out of the building, including my 87-year old mother who stayed in a condominium. It took the building administrator eight hours before he allowed my mother to go inside the building because they do not have the necessary people to inspect and check if the building is still safe for occupancy, Mr. Speaker. With this machine, it will be very practical because if it does not sound the alarm, nobody has to get out of the building anymore as it means that the building is safe.

Mr. Speaker, under the IRR, the proposed seismic instrumentation site must be incorporated in the plan before a building permit is released. Newly constructed buildings, meanwhile, must install ERIs before these are issued occupancy certificates. This is also a prerequisite

for business permit renewals for existing buildings. Under Part IV of the said guidelines, Mr. Speaker, the ERI requirement applies to both government and private buildings. It requires building contractors or owners to install ERIs before these buildings will be issued a certificate of occupancy. Thus, it is necessary that building owners and proprietors must comply with the requirements under the ERI guidelines as the lives of the citizenry are of utmost importance, Mr. Speaker.

Unfortunately, we discovered that 90 percent—I repeat, 90 percent—of the buildings within the Philippines remained noncompliant, and some of the ERIs that were installed do not meet the minimum specification requirement under the guidelines. These were installed merely to comply but not with public safety in mind. These buildings, with or without ERIs, were still issued occupancy permits, Mr. Speaker.

Perhaps, the guidelines were being ignored because the legal consequences are very minimal, which is an imposable administrative fine not exceeding P10,000 and imposable penalties of a fine of not more than P20,000 or imprisonment of not more than two years or both. Mr. Speaker, these penalties are too low. If public safety is our priority, then why do LGU building officials still issue certificates of occupancy to noncompliant buildings? In the first place, why are we even allowing the sale of seismic instruments that are not within the specs of the IRR that was signed last 2015? There is a need to address this problem, because lives are at stake. We need legislations which shall impose higher penalties to ensure compliance.

Likewise, may I also call your attention, Mr. Speaker, that this very building wherein I stand before all of you, as well as the rest of the buildings here at the House of Representatives, are also noncompliant with the guidelines. There are no ERIs in these buildings, Mr. Speaker, so, imagine what would happen if a high-intensity earthquake would strike during the State of the Nation Address. I dare not speculate. One need not be an engineer to know what safety is. If we fail to ensure compliance with the IRR and when the Big One comes, the loss of lives and limbs would be unspeakably devastating.

Lastly, I am calling for your support on House Resolution No. 32, directing the Committee on Public Works and Highways and other appropriate Committees to conduct an inquiry, in aid of legislation, on the compliance with the guidelines and implementing rules on ERIs for buildings as provided for by Presidential Decree No. 1096, otherwise known as the National Building Code of the Philippines.

Thank you, my colleagues. Thank you very much, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Pimentel). The Majority Leader is recognized.

REP. LACSON-NOEL. Mr. Speaker, I move to refer the speech of the Honorable Pineda to the Committee on Rules.

I so move, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Pimentel). Is there any objection? *(Silence)* The Chair hears none; the motion is approved.

The Majority Leader is recognized.

REP. LACSON-NOEL. Mr. Speaker, I move to recognize the Lady from BAYAN MUNA Party-List, the Hon. Eufemia "Ka Femia" C. Cullamat for her privilege speech.

I so move, Mr. Speaker.

THE DEPUTY SPEAKER (Rep. Pimentel). Rep. Eufemia Cullamat from the Party-List BAYAN MUNA is hereby recognized.

PRIVILEGE SPEECH OF REP. CULLAMAT

REP. CULLAMAT. Maraming salamat, G.Ispiker. G. Ispiker, minamahal na mga kapwa kong Mambabatas, magandang hapon sa ating lahat.

Noong Agosto 9, 2019, ipinagdiwang ng mga katutubong Pilipino ang Pangdaigdigang Araw ng Mga Katutubo. Una sa lahat, taas-kamao kong binabati ang mga pambansang minorya sa buong mundo na patuloy na nakikibaka para sa sariling pagpapasya at pagtatanggol sa lupang ninuno. G. Ispiker, mainit ko ding binabati ang pambansang minorya dito sa ating bansa: ang mga Itneg, Apayao, Kankanaey, Ibaloi, Ifugao, Kalinga, Bontoc, Ilongot, Aeta, Tinguian, Ibanaag, Agta, Banwaon, Mangyan, Dumagat, Higaunon, Tumanduk, Mamanwa, Mandaya, Mangguwangan, Manobo, Mansaka, Talaandig, Subanen at iba pang mga pambansang minorya.

G. Ispiker, bilang kauna-unahang Lumad leader na Kinatawan ng BAYAN MUNA Party-List, kinokondena ko ang walang humpay na pagpatay sa aming mga Lumad. Sa mismong Pandaigdigang Araw ng Mga Katutubo ay nakarating sa amin ang isang nakakagulat at nakakagalit na balita na isang Lumad na magsasaka sa Bukidnon ay pinaslang. Ito ay si Alex Lacay, miyembro ng Kaugalingog Sistema Igpapasindog to Lumadnong Ogpaan (KASILO Organization), na walang-awang pinagbabaril ng anim na beses sa Salawagan, Quezon, Bukidnon noong August 9, alas kuwarto ng hapon habang siya ay papunta sa palengke. Noong 11:00 a.m. ay pinatay din, binaril din si Jeffrey, isang miyembro din ng organisasyon ng KASILO.

G. Ispiker, nais ko ding isalaysay ang pagpunta ko sa Haran sa Davao City noong August 10 kung saan nandoon pa rin ang mga bakwit na mga kapatid nating Lumad. Limang taon na silang nakatira doon. Dapat nagdiriwang sila sa kanilang espesyal na pandaigdigang araw sa kanilang lupang ninuno mismo, at hindi doon sa mga bakwitan kung saan mahirap ang tulugan at halos walang makain. Hindi ito katulad ng kanilang komunidad kung nasaan lang ang kanilang mapagkukunan ng mga pagkain.

Kasabay din dito sa pagdiriwang ng Araw ng mga Katutubo, ang walang habas na kawalan ng respeto ng mga militar sa mga katutubo sa Isabela. Nilabag nila ang karapatang pantao ng mga katutubo, sapilitan silang pinaamin sa krimen na hindi nila alam, sapilitan silang pina-surrender sa kampo ng 95th Infantry Battalion ng kasong hindi nila naiintindihan, inaresto sila ng iligal, sinampahan ng mga gawa-gawang kaso, at nilapastangan ang mga kababaihan sa pamamagitan ng sapilitang pagpapasayaw, pambabastos at panghihipo sa maseselang bahagi ng kanilang katawan. Gayundin, patuloy ang mga red-tagging sa Lumad at Lumadnong mga organisasyon. Sukdulang nakakagalit ang mga pambababoy na ito sa aming mga kababaihan, gayundin ang walang habas na paglabag sa karapatang pantao ng mga katutubo, G. Ispiker.

Ang lahat ng mga ito ay sistematikong pakana ng kasalukuyang administrasyon. Ginagamit din nila ang ibang Lumad para magkawatak-watak kami. Dinala din nila sa ibang bansa para magpahayag ng mga sinungaling impormasyon tungkol sa tunay na nangyayari sa pambansang minorya. Sa patuloy nilang paninikil at pamamaslang sa aming mga pambansang minorya, sa layuning manahimik kami para depensahan ang aming lupang ninuno laban sa pagpasok ng mga dambuhalang minahan, plantasyon at dam ay lalong-lalo lamang tumatag ang aming paninindigan na talagang dapat lumaban para sa aming lupaing ninuno, para sa sariling pagpapasya, para sa kinabukasan ng aming mga pamilya at sa darating pang henerasyon ng mga katutubong Pilipino. Lalo lamang naming pasisikhayin ang aming pakikibaka para ipagtanggol ang aming mga karapatan.

Kaya, G. Ispiker, patuloy kaming nananawagan na igalang ang karapatan naming mga pambansang minorya para sa sariling pagpapasya. Ayon sa Article 20 ng United Nations Declaration on the Rights of Indigenous Peoples, kami ay may karapatan na panatilihin at paunlarin ang aming mga sistema at institusyong pampulitika, pang-ekonomiya at panlipunan, maging panatag at maligaya sa aming sistema ng kabuhayan at pag-unlad, at maging malaya sa aming mga tradisyunal at pangkabuhayang sistema ng pamumuhay. Nakasaad din dito na kung kami ay tatanggalan ng mga karapatang ito para namin mabuhay at mapaunlad ang aming mga sarili, kami din ay may karapatang ding ituwid at baguhin ito.

Muli, ang aming panawagan mula sa BAYAN MUNA, G. Ispiker, na itigil ang karahasan laban sa mga katutubo. Hayaan kaming magtakda ng paraan kung paano kami mabubuhay ng mapayapa at kung

paano namin pauunlarin ang aming kultura, ekonomiya at sistema pampulitika. Itigil na ang pangangamkam ng mga dayuhang korporasyon sa aming mga lupang ninuno. Higit sa lahat, G.Ispiker, itigil na ang martial law sa Mindanao.

Ito lang po, G. Ispiker. Maraming salamat.

PRIVILEGE SPEECH OF REP. ELAGO

REP. ELAGO. Thank you, Mr. Speaker. Nagpapasalamat po ang kabataan sa pagkakataon na ito upang maipaabot ang aming tinig hinggil sa mga usapin sa aming representasyon ng mga kabataan.

Ang KABATAAN Party-List is a youth sectoral party. KABATAAN, being a genuine youth sectoral party or an organized group of youth whose primary advocacies are on education, rights, labor and services, invites the Filipino youth to become a member because we, the young people, are stronger when we are together in working on our dreams for a better future, for a better life, not only for our sector, but also for our families and for our nation. As the youth party-list representation in Congress, we are committed to giving voice to the marginalized youth and to all those who have yet to gather enough courage and confidence to speak up.

Our programs are in line with our mission of heeding Rizal's challenge for the young people, for the kabataang Filipinos, to become the hope of our land. Firmly believing in the power of information and persistence, we make each reform more meaningful and relevant to the call of the times through, first, Mr. Speaker, Your Honor, mga kapwa ko Mambabatas, conducting dialogues and discussions with those who may even have differing views with our Members,

learning from our constituents and fellow youth, especially those from other sectors such as the peasants, workers, professionals, women, indigenous peoples and their subgroups, such as people with special needs and those serving in public offices. Second, holding power to account and lastly, lobbying with and alongside them wherever our voice can be amplified and help contribute to a truly democratic society.

Nito lamang nakaraang lingo ay nakita po natin sa state of the youth address ng kabataan dito sa Batasang Pambansa kung paano ang iba't ibang mga kabataan mula sa mga political parties, magkakaiba po iyan sa mga eskuwelahan maski sa kanilang mga barangay, ay naririto sa Kongreso upang mapakinggan ang kanilang mga representante na nagsasalita tungkol sa iba't-ibang isyu. Ngayon, higit kailanman, ang mga kabataan ay interesadong-interesado kung paano sila makakapagambag sa mga hamon ng panahon.

Now, KABATAAN is on its fifth term in bringing politics of hope, action and development by serving as a bold and progressive voice of youth representation in Congress. Hence, each Congress, we have filed and passed thoroughly-studied measures, which we believe are needed to correct deeply scandalous inequality among Filipinos, with the Philippines having one of the highest rates of income inequality in the world and the highest in Southeast Asia. Addressing this deeplyentrenched problem is the development we need. As further articulated by economist and philosopher Amartya Sen, I quote, "Development requires the removal of major sources of unfreedom: poverty, as well as tyranny, poor economic opportunities as well as systematic social deprivation, neglect of public facilities as well as intolerance or overactivity of repressive states."

This youth representation, Mr. Speaker, Your Honor, fervently thanks our colleagues in the Eighteenth Congress for supporting us to fully realize our duty in nation-building. Nakita po natin iyan maski sa simpleng paglahok sa ating mga photo booth dito sa Congress, ang simpleng pagbati sa ating mga kabataan ng Happy International Youth Day na nagpakita kung paano rin natin kinikilala ang kanilang boses sa paggawa ng mga batas sa pagbabago, o pambabasura nito, sa mga programa na ating ipinapatupad. An attack against the youth is an attack against our future, Mr. Speaker. Ito po ang ating masasabi and this is in response to the Senate probe on the allegations of minors who had gone missing because they joined legal progressive organizations. Mr. Speaker, prior to this meeting, we have made known to the concerned Senate Committees our initial commentary, including our grave concerns at how the Senate Resolution No. 38 vaguely presented a dangerous mindset of tagging leftist groups and educational institutions as recruitment grounds for the communist insurgency.

In the history of the struggle for the exercise of political and civil rights, this affront is not new and it continues to be exploited as a pretext to legitimize stateled silencing and even worse, criminalizing dissent and opposition. Because of their stance on various peoples' issues, there have been similar desperate attempt to link the Lumads, the teachers, the members of the Makabayan bloc and the human rights defenders to communist insurgency, from the "Red October" scheme tagging certain Metro Manila universities in destabilization, the profiling of teachers who are members of the Alliance of Concerned Teachers, to vilification efforts undertaken by the military and the police themselves in schools in the guise of anti-war and anti-criminality campaigns.

Mr. Speaker, ang mga kaso pong ito ay nakapaloob na sa mga resolusyon na naipanukala ng Representasyon na ito at nanawagan po tayo na mapag-usapan ang mga ito, lalung-lalo na kung ang mga miyembro ng Kongreso ay ginagawan ng mga pekeng balita, mga pekeng statements, at ginagawang targets ng sexual na harassment, lalung-lalo na online. How can we not be gravely concerned when red-tagging has led to deaths, illegal arrests, fabricated charges and threats to life and our privacy? Earlier today, we read in the news that the youth involved had already spoken on the issue, rendering much on the malicious allegations devoid of any semblance of truth. Based on their statements, there were "no missing minors," only students of legal age whose choice of joining legal cause-oriented organizations is yet to be regarded by their parents who understandably are very concerned about the welfare of their children, of their sons and daughters.

We cherish our families and our love for them drives us to continue striving for a just and peaceful society, one wherein no parent has to worry about the safety of their children, and no family is broken apart by senseless killings.

We struggle towards a society wherein all families have equitable access to basic social services and livelihood opportunities, and every toiling parent is justly compensated for their hard work.

From the hearing last week, Mr. Speaker, it was evident that the pronouncements made underestimate the capacity of the youth to willingly participate in addressing various social issues when even citizens aged below 18, as we all know, are also guaranteed the right to expression, association and peaceful assembly. After all, dissent must always be welcomed as it is vital in any democracy. However, we are quite alarmed by the motives and the recent pronouncements surrounding these baseless and slanderous tirades against our youth representation, KABATAAN Party-List, and all other student and youth organizations based in their schools and communities, and even the Makabayan bloc and the National Union of People's Lawyers. Lamely, we find the calls for increased police presence and further

militarization of campuses especially disconcerting. Those behind the malicious allegations even orchestrated the filing of trumped-up charges against youth leaders for kidnapping their members. But it has already been exposed that these are based on false claims.

Just yesterday, Mr. Speaker, while we were in observance of the International Youth Day 2019, DILG Secretary Año also used the pronouncements made in this hearing to recommend the revival of the Anti-Subversion Law and echoing the calls in the Senate probe, to amend the Human Security Act. Such tyrannical measures, as we have seen in our history and at present, resulted in the repression and stifling of dissent, specifically targeting the students, teachers and school officials who have been at the forefront of opposing the drug war killings, attacks against human rights defenders, tax hikes, term extensions, among other youth and people's issues. Ito po iyong mga naglulunsad ng mga debate, ng mga diskusyon, mga forum sa kanilang mga eskuwelahan. Nag-iimbita pa nga ng mga Miyembro ng ating Kongreso at ng ating mga lider ng iba't ibang mga departamento upang magpaliwanag sa kanila dahil napakalimitado lang kadalasan ng mga napapanood natin sa balita. Kaya ang mga educational institution ay mahalagang parte doon sa pagkatuto, pati na rin po iyong unlearning at iyong mismong pagpili ng mga pagpapahalaga ng mga kabataan, kasama na rin ang kanilang teachers at university officials.

Lalo na po ngayon, sa panahon na napakalala ng disinformation at mga paninira. Tulad na lang nitong naulat ng check.ph, na ang nagpakalat raw po mula sa kanilang pananaliksik noong pekeng balita na diskwalipikado na ang Makabayan bloc noong nakaraang 2019 elections, na nanggaling sa official pages ng army reservists at ng mga pulis. Kaya ang pagkakataon na ito sa panahon ng fake news at malalang disinformation ay panahon din upang magdoble at magtriple ng mga pagsisikap upang kami ay magpaliwanag.

Naririto po ang ilang mga pekeng balita at gawa-gawang statements na ipinapakita na sinabi ko raw po, kahit hindi ko naman po sinabi—at iyong mga harassment din sa mga estudyante na nagsasalita lamang sa issues ng kanilang sektor at mga isyu ng ating bayan—sila po ay nakakaranas ng mga pagsunod sa kanilang mga bahay at napakalala na po nitong pekeng statements kasi marami po ang naaabot niyan, na talagang akala nila nanggaling sa aming youth representation. Ang photos po na nakikita ninyo ay posted sa mga official Facebook pages.

Kaya nananawagan ako sa aking mga kapwa Mambabatas na kung iyan po ay sa inyong mga lugar, suportahan po ninyo kami na ma-call out itong mga official Facebook pages na ito. Sinabi ko na rin po iyan kay PNP Spokesperson Banac kaninang umaga sa isang interview, na mismong official pages ang nagtwist po ng aking statements, nagbabago ng mga salita

ng KABATAAN Party-List para mai-dugtong lamang doon sa mga sinusulong na agenda ng mga naninira sa inyong Representasyon.

Marami pong nagtatanong sa atin, bakit ba interesadong-interesado iyong mga kabataan? Bakit ba sila—marami sa kanila ngayon parang gusto nilang lumaban, mag-ambag. Sa parte po namin, kapag may bumibisita dito sa atin at nagtatanong kung paano sila makakapag-contribute sa issues na ito, mula noong taong 2016, ang nilagay lang po namin dito sa panahon ng Duterte administration, pero marami dito ang mga matagal nang mga kinakaharap ng ating bayan. Iyan ang pakiusap ng mga kabataan, na imbes po na kami ay patahimikin, kontrolin o kaya naman pigilan sa pagtatanong, napakahalaga po ng espasyo, hindi lang sa school, kundi sa aming mga bahay, sa ating mga tahanan para makapagusap-usap, magkaroon ng mga dayalogo hinggil sa mga issue na ito ng ating bayan.

Mr. Speaker, tulad na lang po noong nabahagi ng Child Rights Network noong aming SOYA, naibahagi nila na mayroon nang 74 na children na na-tag as mga collateral damage ng drug war. Nandiyan din ang mga suportang kinakailangan ng mga bata na nakasaksi at ngayon ay mayroong trauma matapos nilang ma-witness ang drug operations sa kanilang mga barangay. Nandiyan rin po ang tala ng Child Rights Network na 18 bata iyong naulila po dahil sa drug war. Iyan po ang mga kaugnay na issues na kailangan natin na matugunan at kailangan nating pag-usapan dito sa loob ng Batasang Pambansa upang ganap nating magampanan iyong ating role na protektahan ang ating bayan para sa mga magmamana nito, para sa mga bata at para sa mga kabataan.

Dagdag sa mga atake sa human rights defenders at sa mga nagtatanong at aktibo na kumikilos para maimprove iyong ating mga polisiya. Itong Hulyo lamang ay napangalanan ng watchdog na Global Witness sa taunang report nito na ang Pilipinas ay bansang may pinakamaraming napaslang na environmental at rights defenders. Sa amin pong mga kabataan, ito ay talagang cause for a grave concern na sila pong mga nagsasalita para sa kalikasan, lalong-lalo na ngayon, marami nang nangangampanya hinggil sa climate justice at climate emergency, ngunit marami sa kanilang mga leader ay nagiging biktima ng mga pamamaslang. Mr. Speaker, nalagpasan na natin iyong bansang Brazil na may hawak ng pinakamataas na puwesto mula taong 2012.

Mula naman sa isang ulat ni Maria Elena O. Castillo ng *The Varsitarian* ng UST na nailathala noong ika-9 ng Agosto, winika ni Fr. Daniel Franklin Pilario na ang kawalan ng katarungan sa mga taong tinutuligsa dahil sa pagsisiwalat ng kanilang saloobin sa lipunan ang malaking hamon sa bansa sa kasalukuyan. Dagdag pa niya, kung sino pa ang mga taong may pakialam na nagsalita, tumulong at tumutol, sila pa ang tinutugis. Evidently, it is Duterte's regime of vilification and criminalization of dissent that puts our voice in

Congress, our lives and our future at risk. Now, what are the urgent tasks of the Filipino youth? This presents the urgent need to unite as Filipino youth and people for the following demands: First, we must intensify the campaign for schools as zones of peace wherein fundamental freedoms of organizations, peaceful assembly and expression are upheld. As vanguards of legislation, it is our duty to be fair and never allow educational institutions, being highly regarded as our children's and our siblings' second homes, to become a space for bigotry, prejudice, discrimination and attacks on human rights. We call for the urgent endorsement of the "Safe Schools Declaration." KABATAAN Party-List will be filing a resolution tonight urging the Duterte administration to sign the said declaration, which is an intergovernmental political commitment that provides countries the opportunity to express support for protecting education from attack during times of armed conflict; the importance of the continuation of education during war, and the implementation of conflict measures to deter the military use of schools.

Now, Mr. Speaker, at least 87 countries have already endorsed the Safe Schools Declaration and committed to take action to end targeting of schools and universities since:

Access to education may be undermined; the functioning of educational facilities may be blocked, or educational personnel and students may stay away, fearing for their safety. Attacks on schools and universities have been used to promote intolerance and exclusion to further gender discrimination, for example, by preventing the education of girls, to perpetuate conflict between certain communities, to restrict cultural diversity, and to deny academic freedom or the right of association. Where educational facilities are used for military purposes, it can increase the risk of the recruitment and use of children by armed actors or may leave children and youth vulnerable to sexual abuse or exploitation. In particular, it may increase the likelihood that educational institutions are attacked. By contrast, education can help to protect children and youth from death, injury and exploitation; it can alleviate the psychological impact of armed conflict by offering routine stability and provide links to other vital services. Education that is "conflict sensitive" avoids contributing to conflict and pursues a contribution to peace. Education is fundamental to development and to the full enjoyment of human rights and freedoms.

Mr. Speaker, by joining the Safe Schools Declaration, countries commit to undertake several common steps to make it less likely that students, teachers, schools

and universities will be attacked, and to mitigate the impact of attacks that occur. The Philippines has yet to commit to the declaration though it must be noted, Mr. Speaker, that in April 2019, Secretary Briones emphasized that the Department of Education strongly supports the Safe Schools Declaration through DepEd issuances and campaign materials, and I quote this is from the Department's statement:

As for the Safe Schools Declaration, we fully support it. We have issued a number of publications and circulars in our Department. We have campaigned for it, especially in Mindanao. We require all our schools to carry the posters with messages, "This is a zone of peace, this is a safe school." The declaration is already at the Office of the Executive Secretary for further comments and clearance.

Hinahangad din po ng Representasyon na ito na ang mga may pinapaabot na concerns mula sa mga Lumad schools na nakakaranas ng indiscrimate firing, may iba't ibang tipo ng threats ng closure, ng suspension, ay dapat madinig din nang maigi. Likewise, Mr. Speaker, we recommend to the House Committee on Public Order and Safety to investigate equally pressing issues, not only involving the overall welfare of children and educational institutions, but also the youth and the people.

To name a few, first, the spate of killings in Negros with a one-year old, a principal and a teacher as the latest victims; second, the profiling and surveillance of youth organizations and teachers, violating privacy laws in schools; third, the bungled scare tactics dubbed as "Red October" vehemently denied by universities; fourth, the reported and documented threats, harassment, intimidation and vilification against student activists, organizations, faculty unions and university officials, particularly state forces like the police, military and intelligence agents, all have been the subject of countless congressional measures since the Seventeenth Congress.

Finally, Mr. Speaker, this youth representation also pledges its support to the Declaration of Unity by hundreds of youth organizations, resisting this latest waves of attacks. They are calling on the Duterte administration to: 1. immediately stop its escalating campaign to demonize student activism and youth involvement in addressing the problems of our society; 2. dispense with its plan to relax existing agreements between the government and academic institutions, which hinder State forces from freely entering and roaming around campuses; and 3. junk all trumped-up cases filed against youth leaders. Isang mahigpit at mainit na pakikiisa ang ipinaaabot ng KABATAAN Party-List sa daan-daang youth and student organizations na nakapirma sa Unity Declaration na ito.

Mr. Speaker, bukas rin po ay may pagdinig na ipinatawag, pangalawang pagdinig, hinggil sa isyu na ating naibahagi kanina tungkol kay Senator Bato Dela Rosa. For the record, Mr. Speaker, mariin nating kinokondena iyong paggamit doon sa sitwasyon ng mga pamilya upang maitulak ang amendments sa Human Security Act, mapabilis ang pagdadagdag ng police at military presence sa schools na maaaring magbunga, at sa ating kasaysayan ay nagbunga na, ng pagtapak sa mga demokratikong karapatan sa campuses. Hindi po natin papayagan na magpatuloy ang mga ganitong pakana. Muli, imbes na pigilan at patahimikin, kailangan po nating bigyan pa nang mas malawak na espasyo upang mapakinggan natin ang ating mga kabataan, ang ating mga pamilyang Filipino, ang ating constituents.

I end this speech with an excerpt from "The Miseducation of the Filipino" by the late scholar and historian, Prof. Renato Constantino. This excerpt inspired me as a high school student in Parañaque Science High School. Simula po noong mabasa ko ito, hindi ko na po nakalimutan. I quote:

Education is a vital weapon of a people striving for economic emancipation, political independence and cultural renaissance. We are such a people. Philippine education therefore must produce Filipinos who are aware of their country's problems, who understand the basic solution to these problems, and who care enough to have courage to work and sacrifice for their country's salvation.

Mr. Speaker, sa aking mga kapwa Mambabatas, sa mga kapwa kabataan at sa mga kababayang Filipino, patuloy po tayo na mag-aral. Oo, mag-aaral po ng kasaysayan upang mas gumawa pa ng mas maraming kasaysayan, sumulat ng kasaysayan upang magkamit pa ng mga tagumpay para sa bayan at para sa susunod na henerasyon na mga Filipino.

PRIVILEGE SPEECH OF REP. NAVA

REP. NAVA. Thank you, Mr. Speaker.

Mr. Speaker, distinguished colleagues, I rise with regard to the maritime tragedy that happened in the Iloilo Strait between Guimaras and Iloilo City last August 3, 2019. Mr. Speaker, motor bancas have been the major means of marine transportation between Iloilo and Guimaras since the sailboats or paraws lost its steam several decades ago against this faster and more dependable rival locally known as the pump boat. Since its adoption as a means of transportation, there were only a handful of motor banca accidents recorded. The last was October 18, 2015 wherein two crew members and seven passengers died. That was the worst motor banca accident ever recorded along the Iloilo Strait until that fateful day of August 3, 2019.

Still, the Province of Guimaras is lingering from this heart-breaking maritime tragedy that left 31 people dead among the 96 passengers and crews of the three motor bancas plying the Iloilo-Guimaras route and vice versa. Unfortunately, the problem is aggravated by the day as the island province is experiencing several maritime transport shortages. Commuters, mostly students, traders, workers—workers employed in Iloilo, patients on follow-up in Iloilo City, are queueing in a very long line, more than 500 meters, for hours just to get the chance to board a vessel to Iloilo. I am sure the same thing is happening on the other side to a lesser magnitude. Iloilo, after all, is the major trading partner of Guimaras. It is its primary option for tertiary education and for tertiary health care, and it continuously provides employment opportunities to the Guimarasnons. Construction materials, petroleum products and almost all other goods pass by the city of Iloilo before they reach Guimaras.

With Guimaras agriculture and tourism industry, it is not difficult to imagine, as there are, more or less 18,000 commuters that cross the Iloilo Strait daily and almost always on board motor bancas plying the Iloilo-Guimaras Strait route and vice versa, while the big cargoes are transported through the RoRo vessels. However, the abrupt suspension of the operations of motor bancas had put a sudden stop to this progressive economic activity. Now, after economically dislocating the motor bancas' crews and allied occupations, it is slowly taking its toll on the island province's economy. I am sure that it will not be long before the provincial government declares another state of calamity, which

they did last month due to the dengue outbreak. Fortunately, just this morning, the ban on the motor bancas was temporarily lifted, with the following restrictions: first, fair-weather only; second, only 75 percent passenger capacity; third, rolling or removing of tarps or shades; and fourth, wearing of life vest throughout the voyage.

We recognize and appreciate the outpouring of support from various government agencies, with no less than His Excellency Pres. Rodrigo Duterte and Sec. Arthur Tugade leading the way as well as those coming from the private sector. We would also like to thank the Vice Pres. Leni Robredo for coming to Guimaras and offering her support. We, too, are deeply appreciative of the lifting of the ban. Yet it cannot be denied that more help is still necessary and very crucial for our island province to return to normalcy. Thus, this Representation is imploring the ardent support, once more, of the various agencies, especially the Department of Transportation, for the following priority interventions which will further ease the situation, to wit:

- 1. To continue to increase the number of vessels plying the Iloilo-Guimaras route and vice versa to accommodate the daily commuters which number, more or less, 18,000 per day. Presently, the vessels deployed can only accommodate approximately 6,000 passengers daily;
- 2. To extend the moratorium on the CPC or the Certificate of Public Convenience for wooden-hull motor bancas plying the Iloilo-Guimaras route and vice versa subject to the newly adopted restrictions for a reasonable period of time to finally comply with STWC Circular No. 2016-02. That is the revised rule on the phase-out of wooden-hull ships carrying passengers in domestic shipping;
- 3. To grant the wooden-hull motor bancas special permits for chartering or whatever mode of contracting, as water taxis, in the conveyance of and for, 1) cargo, and 2) tourism, and 3) medical emergencies, and its eventual adoption as such. This intervention will minimize the economic impact on those who will be displaced by the eventual retirement of the wooden-hull motor bancas as a regular passenger conveyance.
- 4. The eventual improvement and expansion of the Jordan RoRo wharf to include among others, the construction of more berthing facilities and a passenger terminal. Likewise, the improvement of the Municipal Wharves of Jordan and Buenavista to accommodate new vessels other than our motor bancas.

This Representation, Mr. Speaker, is confident that, with the realization of these interventions, we can sustain the economic opportunities in the Province of Guimaras.

More than a week had passed since the tragic

incident, but the question as to why so many died continues to haunt Guimarasnons. The site of the incident is less than two kilometers away from the wharves of Jordan and Buenavista in Guimaras, as well as from Parola in Iloilo City where the berthing areas for motor bancas are located. Technically, it is well within the sight of anybody standing from these areas. Parola, ironically, is also the location of the Philippine Coast Guard Station. Can we therefore say that this incident happened right at the backyard of the coast guard station? What further haunts this Representation is why there was a third boat, more or less, three hours after the two boats capsized? Why was the third boat not immediately recovered that day? The third boat was washed ashore some 16 kilometers away from the site of the incident and was recovered the following day with 11 bodies inside and along the said boat.

These are not only questions that haunt this Representation but as well as many of the residents of Guimaras and Iloilo, much more the families of those who perished in the tragedy. We will continue to speculate on the things that transpired that day. We will continue to imagine what could have been done that day. Not until we get hold of an official report from the Philippine Coast Guard, which this Representation have been seeking for over a week now, will we know if we will continue to experience one maritime tragedy or another, or have the chance to put an end to it. We have time to work together and guarantee a safer way to travel, so, let us do it now.

Nevertheless, I believe in the Guimarasnons' resiliency. If we had prevailed over the August 11 oil spill 13 years ago, I am confident that the Guimarasnons will once again overcome this adversity.

PRIVILEGE SPEECH OF REP. MARIANO-HERNANDEZ

REP. MARIANO-HERNANDEZ. Thank you very much, Mr. Speaker. Good evening to you and to the Members of this august Body.

Mr. Speaker, the topic of my speech will delve into the matter of child health care, particularly on government's efforts to address the needs of children with rare diseases.

Mr. Speaker, I would like to share the heart-rending story of the late Aquiro Jazz "Baby Aki" Detablan and the Detablan family in my home province of Laguna. I came to know them personally when they visited my office and asked for help when I was still a Provincial Board Member. This story caught the attention of Filipino netizens when a picture of a father carrying his baby while selling banana cakes on the streets of Calamba, Laguna to fund his son's liver transplant, was posted online and went viral. Mr. Speaker, that man was Antonio Detablan and his then eight-month-old Baby Aki who was diagnosed with biliary atresia, a rare disease of liver and bile ducts that occur in infants. Symptoms of the disease appear or develop about two to eight weeks after birth. Due to their financial situation, Antonio and his wife Joy were not immediately able to bring Baby Aki for a checkup. They were still paying off their loans for hospital fees of Arkhin, their second child who had an operation for hydrocephalus. Baby Aki was diagnosed with a rare disease last October 2018. According to medical journal sources, when a baby has a biliary atresia, the bile flows from the liver to the gall bladder, but Baby Aki's gall bladder was blocked. This caused the bile to be trapped inside the liver, quickly causing damage and scarring of the liver cells or cirrhosis of the liver and eventually, leading to liver failure.

Base po sa kuwento ng pamilya Detablan, Mr. Speaker, nagpunta po sila sa Philippine General Hospital (PGH) para sa kinakailangang medical intervention. Sa kanila pong konsultasyon sa mga espesyalista, they were told that the only way to save Baby Aki was through a liver transplant pero dahil po sa kakulangan ng pasilidad sa PGH to carry out the procedure, ang pamilya po ay nagsaliksik at naghanap ng iba pang posibleng options. They eventually found a Facebook group called LITRO or tinatawag po na LIver TRansplant Operation- LITRO Babies Phils Inc. Ang LITRO Babies Philippines po ay isang samahan ng mga pamilyang may anak na nangangailangan ng liver transplant.

Actually, Mr. Speaker, ngayon gabing ito, ang ilan

sa miyembro po ng LITRO organization ay nandito po sa Plenaryo.

The Detablan family was able to gather more information from this source, which helped them establish a link with a hospital in India to perform the liver transplant operation which would cost them P1.6 million. Mr. Speaker, Antonio and Joy resorted to selling banana cakes on the streets to help finance Baby Aki's transplant. In fact, when the shop where Antonio worked went bankrupt, Antonio asked to have the equipment and set up his own bakery. That became his family's main source of income. Since their baking equipment was limited, Antonio could only bake 12 loaves of banana cake per day. He sold each for P120. He would be lucky to sell them all within one day and earn him P1,440.

After that photo became viral online in March 2019 and received the sympathetic media attention, many donors from all walks of life pitched in to help. A lot of orders for their banana cakes came and many fund-raising events happened for Baby Aki. These fund-raising efforts helped the Detablan family raise the P1.6 million for Baby Aki's' liver transplant. They eventually flew to India on May 20, 2019 for the operation with his donor mother in Apollo Hospital in India last July 5, 2019. Mr. Speaker, though Baby Aki survived the liver transplant, unfortunately, there was a complication. Baby Aki died last July 22, 17 days after the surgery.

Mr. Speaker, this is a story that showed the multifaceted traits of our people: a struggling family, a generally sympathetic and helpful public, and the travails and sadness due to harsh realities that we are trying our best to address as policymakers in government. Mr. Speaker, the story of Baby Aki Detablan brought me to seriously look at our health care system and its capacity to attend to rare diseases afflicting our children here in our country. The World Health Organization defines a rare disease as "an oftendebilitating disease or condition with a prevalence of 0.65 percent to 1 percent." In our country, a rare disease affects one in 20,000 people.

In my humble view, Mr. Speaker, people, most especially children, who are afflicted with rare diseases need utmost attention, understanding and special care from our government. Why, in the first place, would the Detablan family need to seek help and go through major fund-raising efforts to go to a hospital in India for a chance to help their child beat this rare disease? Looking into the latest available statistics from the Department of Health, there are 476 government hospitals and 960 private hospitals in the country as of October 2017, Mr. Speaker. The same data also showed that there are 322 government infirmaries and 312 private infirmaries, while there are 2,598 rural health units and 20,241 barangay health stations nationwide. Mr. Speaker,

marami po tayong mga ospital pero mayroon pa rin mga kakulangan—mga kakulangang pasilidad, personnel at specialist doctors—para maharap ang mga taong may rare diseases tulad ng kay Baby Aki. Mr. Speaker, the Detablan family found only a single, possible option in a private hospital in the Philippines, but the cost was much more than what they had raised for a cheaper option abroad. Apparently, Mr. Speaker, our current health care system is not yet sufficiently funded to address many health sector concerns, including rare diseases in our children. But, Mr. Speaker, with a little more research, we can see that government has, in fact, put in place some policy tools to address rare diseases in the Philippines.

Mr. Speaker, the Department of Health and the Philippine Health Insurance Corporation or PhilHealth, already have Republic Act No. 10747 or the Rare Diseases Act of the Philippines. The said law aims to improve access of persons diagnosed to have a rare disease or persons highly suspected of having a rare disease to comprehensive medical care and to timely health information to help them cope with their condition. The law also mandates PhilHealth to provide benefit packages for patients, medical assistance as provided by the Sin Tax Reform Act of 2012, and incentives for donations intended for researches on rare diseases. The patients with rare diseases are also considered persons with disabilities (PWDs) and will be granted the corresponding benefits and privileges such as priority programs and discounts.

Mr. Speaker, the DOH said that patients afflicted with rare diseases often have their quality of life reduced to taking medications, having medical checkups, and suffering from pain. They are often dependent on other people to attend to their basic needs and need lifelong medical care, food supplements, medications, and multidisciplinary therapies to alleviate the symptoms and effects of rare diseases. Mr. Speaker, the DOH may need a little more push from the legislature to comprehensively address the rare diseases in our country. The government health sector would need a substantial amount to provide medicines, facilities and infrastructure for indigents with rare diseases.

Mr. Speaker, this Representation is hopeful that the current Congress can look at how the DOH is implementing the Rare Diseases Act so far, how we can help the Department get more funding to further develop our public health care system and address the rare disease cases in the country. Mr. Speaker, in the case of Baby Aki, apparently the Detablan family was not aware that there is an existing law that is supposed to provide support for them. Mr. Speaker, I beg your indulgence that this be referred to the Committee on Health upang mas malalim pong talakayin at pagtuunan ng pansin ang usaping ito upang makagawa pa po ng dagdag na mga batas kung kinakailangan or perhaps, amend the existing

laws if deemed necessary. Generations of our national heroes have in many ways said that the youth is the hope of the motherland, that the youth is the wellspring of new leaders and citizens of our one and only country.

To ensure that all our infants and children get to become healthy citizens, our health care system must be given the adequate and appropriate government support in the long term, including addressing rare diseases. Mr. Speaker, the story of Baby Aki may be only one of hundreds, if not thousands, of rare disease cases in the country. It is one major facet of health care that the government can and should address so that we do not fail the current and future generations of our country.
