## FACT SHEET

### House Bill No. 937

(As approved by the Committee on October 18, 2016)

### **DIVIDING BARANGAY NORTH BAY BOULEVARD SOUTH IN THE CITY OF NAVOTAS INTO THREE (3) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAYS NBBS PROPER, BARANGAY NBBS KAUNLARAN AND BARANGAY NBBS DAGAT-DAGATAN**

*Introduced by: Rep. Tobias "Toby" Tiangco*

*Committee Referral: Local Government*

*Committee Chairperson: Rep. Pedro B. Acharon, Jr.*

#### **OBJECTIVE:**

- To establish Barangays NBBS Proper, NBBS Kaunlaran, and NBBS Dagat-dagatan as distinct and independent barangays and entitle them to the appropriate Internal Revenue Allotment (IRA) share;

#### **KEY PROVISIONS:**

- Divides Barangay North Bay Boulevard South (NBBS) in Navotas City into three (3) Barangays to be known as (1) Barangays NBBS Proper, (2) NBBS Kaunlaran and (3) NBBS Dagat-dagatan;
- Provides for the conduct of a plebiscite the expenses of which shall be borne by the government of the City of Navotas.;
- Provides for the conduct of a special election of barangay officials in the newly created barangays;
- Provides that incumbent barangay officials shall continue to hold office until the officials of the newly created barangays have been duly elected and qualified;
- Transfers all existing public infrastructures and facilities for public use existing therein to the newly created Barangays;
- Entitles the newly created barangays to IRA shares pursuant to Section 285 of the Local Government Code.

#### **RELATED LAW:**

- Section 285 of Republic Act 7160, otherwise known as "The Local Government Code of 1991".
