House Bill No. 938

(As approved by the Committee on October 18, 2016)

DIVIDING BARANGAY TANGOS IN THE CITY OF NAVOTAS INTO TWO (2) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY TANGOS NORTH AND BARANGAY TANGOS SOUTH

Introduced by: Rep. Tobias "Toby" Tiangco

Committee Referral: Local Government

Committee Chairperson; Rep. Pedro B. Acharon, Jr.

OBJECTIVE:

- To establish Barangay Tangos North and Barangay Tangos South as distinct and independent barangays and entitle them to the appropriate Internal Revenue Allotment (IRA) share;

KEY PROVISIONS:

- Divides Barangay Tangos in Navotas City into two (2) distinct and independent barangays to be known as Barangay Tangos North and Barangay Tangos South
- Provides for the conduct of a plebiscite, the expenses of which shall be borne by the government of the City of Navotas.
- Provides for the conduct of a special election of barangay officials
- Transfers all existing public infrastructures and facilities for public use existing therein to the newly created Barangays
- Entitles Barangay Tangos North and Barangay Tangos South to IRA shares pursuant to Section 285 of the Local Government Code, as amended.

RELATED LAW:

- Section 285 of Republic Act 7160, as amended, otherwise known as "The Local Government Code of 1991".
