have considered the same and recommend that the attached House Bill No. 4598 entitled:



AN ACT
ESTABLISHING A NATIONAL TECHNICAL-VOCATIONAL HIGH SCHOOL IN
BARANGAY NASISI, CITY OF LIGAO, PROVINCE OF ALBAY, TO BE KNOWN
AS LIGAO CITY NATIONAL TECHNICAL-VOCATIONAL HIGH SCHOOL, AND
APPROPRIATING FUNDS THEREFOR

*Be it enacted by the Senate and the House of Representatives of the
Philippines in Congress assembled:*

1 SECTION 1. There is hereby established, under the supervision of the
2 Department of Education, a national technical-vocational high school in Barangay
3 Nasisi, City of Ligao, Province of Albay, to be known as Ligao City National
4 Technical-Vocational High School.

5
6 SEC. 2. The Secretary of Education shall immediately include in the
7 Department's program the operationalization of the Ligao City National Technical-
8 Vocational High School, the funding of which shall be included in the annual
9 General Appropriations Act.

10
11 SEC. 3. The Secretary of Education shall formulate the rules and regulations
12 to implement the provisions of this Act.

13
14 SEC. 4. This Act shall take effect fifteen (15) days after its publication in the
15 Official Gazette or in a newspaper of general circulation.
