The Committee on Local Government to which was referred House Bill No. 4496 introduced by Representative Rodolfo C. Fariñas entitled:



HOUSE BILL NO. 4925

Introduced by: **REPRESENTATIVE RODOLFO C. FARIÑAS**

AN ACT
DIVIDING THE ONE-BARANGAY MUNICIPALITY OF DUMALNEG IN THE PROVINCE OF ILOCOS NORTE INTO THREE (3) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY KALAW, BARANGAY CABARITAN AND BARANGAY QUIBEL

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

1 **SECTION 1. *Division of the One-Barangay Municipality of Dumalneg.*** - The
2 One-Barangay Municipality of Dumalneg in the Province of Ilocos Norte is hereby
3 divided into three (3) distinct and independent barangays to be known as Barangay
4 Kalaw, Barangay Cabaritan and Barangay Quibel.

5 **SEC. 2. *Composition.*** – The existing puroks and sitios shall comprise the new
6 barangays herein created as follows:

7 1. **Barangay Kalaw.** – Barangay Kalaw shall be composed of Purok Crisalita,
8 Purok Saniata, Sitio Pacac, Sitio Banbanag, Sitio Sta. Maria, Sitio Siraong,
9 Sitio As-asaan, Sitio Nasduan, Sitio Nappud, Sitio Nanguratao and Sitio
10 Sisilungen,

1 2. **Barangay Cabaritan.** – Barangay Cabaritan shall be composed of Purok
2 Timpuyog, Poblacion, Sitio Alilem, Sitio Cabaritan, Sitio Capcapitan, Sitio
3 Tapauan, Sitio Immalsung and Sitio Mangadamay.

4 3. **Barangay Quibel.** – Barangay Quibel shall be composed of Purok Namnama,
5 Purok Danggayan, Purok Regta, Sitio Namoc, Sitio Arapang, Sitio Nalames,
6 Sitio Baracbac, Sitio Bobog and Sitio Baset.

7 **SEC. 3. Existing Boundaries.** – The existing boundaries of the different puroks
8 and sitios enumerated in the immediately preceding section shall be retained and
9 maintained.

10 **SEC. 4. Seat of the Municipal Government.** – The seat of the municipal
11 government shall be at Poblacion, Barangay Cabaritan.

12 **SEC. 5. Conduct and Supervision of Plebiscite.** – The Commission on Elections
13 (COMELEC) shall conduct and supervise the plebiscite to be held in the entire
14 Municipality of Dumalneg, Province of Ilocos Norte within one hundred eighty (180)
15 days from the effectivity of this Act.

16 **SEC. 5. Barangay Officials.** – The first set of officials of the barangays shall be
17 appointed by the provincial governor, in consultation with the Representative of the
18 District, and shall hold office until such time that their successors have been duly elected
19 and qualified.

1 **SEC. 6. *Public Infrastructure and Facilities.***– All public infrastructure
2 and facilities for public use existing therein at the time of the approval of this Act are
3 hereby transferred without cost or compensation to and shall be administered by the new
4 barangays.

5 **SEC. 7. *Internal Revenue Allotment Shares.***– The Municipality of Dumalneg
6 and all the barangays herein created shall be entitled to Internal Revenue Allotment
7 (IRA) shares pursuant to Section 285 of Republic Act No. 7160 as amended otherwise
8 known as the Local Government Code of 1991.

9 **SEC. 8. *Effectivity.*** – This Act shall take effect fifteen (15) days after its
10 publication in the Official Gazette or in a newspaper of general circulation.

FACT SHEET

SUBDIVIDING THE ONE-BARANGAY MUNICIPALITY OF DUMALNEG IN THE PROVINCE OF ILOCOS NORTE INTO THREE (3) DISTINCT AND INDEPENDENT BARANGAYS TO BE KNOWN AS BARANGAY KALAW, BARANGAY CABARITAN AND BARANGAY QUIBEL

OBJECTIVES:

- To subdivide the one-barangay Municipality of Dumalneg into three (3) distinct and independent barangays and entitle them to the appropriate Internal Revenue Allotment (IRA) share;

KEY PROVISIONS:

- Subdivides the one-barangay Municipality of Dumalneg in the Province of Ilocos Norte into three (3) distinct and independent barangays to be known as Barangay Kalaw, Barangay Cabaritan and Barangay Quibel;
- Retains and maintains the existing boundaries of the different puroks and sitios;
- Provides for the conduct of a plebiscite to be held in the entire Municipality of Dumalneg, Province of Ilocos Norte within one hundred eighty (180) days from the effectivity of this Act;
- Transfers all existing public infrastructure and facilities for public use therein to the newly created Barangays;
- Entitles the newly created barangays to Internal Revenue Allotment shares pursuant to Section 285 of R.A. 7160 as amended.

RELATED LAW:

- Sections 285 and 384 of Republic Act 7160, as amended otherwise known as the "Local Government Code of 1991".
