**AN ACT**  
**CREATING A BARANGAY TO BE KNOWN AS BARANGAY SAN ISIDRO IN**  
**THE MUNICIPALITY OF TITAY, PROVINCE OF ZAMBOANGA SIBUGAY**

*Be it enacted by the Senate and the House of Representatives  
of the Philippines in Congress assembled:*

1           **SECTION 1.** *Creation of Barangay San Isidro.* - There is hereby created a  
2   barangay to be known as Barangay San Isidro in the Municipality of Titay, Province of  
3   Zamboanga Sibugay.

4           **SEC. 2.** *Conduct and Supervision of Plebiscite.* – The plebiscite conducted and  
5   supervised by the Commission on Elections (COMELEC) pursuant to Provincial  
6   Ordinance No. 2002-122 dated August 7, 2002 of the Sangguniang Panlalawigan of the  
7   Province of Zamboanga Sibugay, which ratified the creation of Barangay San Isidro  
8   proclaimed by the Plebiscite Board of Canvassers on April 16, 2005 shall serve as a  
9   substantial compliance with the plebiscite requirement under Section 10 of Republic Act  
10   7160 as amended, otherwise known as the Local Government Code of 1991.

1           **SEC. 3. *Incumbent Barangay Officials.*** – The incumbent barangay officials of  
2   Barangay San Isidro shall continue to hold office until such time that their successors  
3   have been duly elected and qualified.

4           **SEC. 4. *Public Infrastructures and Facilities.***– All public infrastructure and  
5   facilities for public use existing therein at the time of the approval of this Act are hereby  
6   transferred without cost or compensation to and shall be administered by the new  
7   barangay.

8           **SEC. 5. *Internal Revenue Allotment Shares.***- Barangay San Isidro shall be entitled  
9   to Internal Revenue Allotment shares pursuant to Section 285 of Republic Act No. 7160  
10   as amended, otherwise known as the Local Government Code of 1991.

11          **SEC. 6. *Effectivity.*** – This Act shall take effect fifteen (15) days after its  
12   publication the Official Gazette or in a newspaper of general circulation.

**CREATING A BARANGAY TO BE KNOWN AS BARANGAY SAN ISIDRO IN THE  
MUNICIPALITY OF TITAY, PROVINCE OF ZAMBOANGA SIBUGAY**

*Introduced by: Rep. Rep. Ann K. Hofer*

*Committee Referral: Local Government*

*Committee Chairperson: Rep. Pedro B. Acharon, Jr.*

**OBJECTIVE:**

- To establish Barangay San Isidro as a distinct and independent barangay and entitle it to the appropriate Internal Revenue Allotment (IRA) share;

**KEY PROVISIONS:**

- Creates Barangay San Isidro in the Municipality of Titay, Province of Zamboanga Sibugay;
- Provides that the plebiscite conducted and supervised by the COMELEC pursuant to Provincial Ordinance No. 2002-122 dated August 7, 2002 of the Sangguniang Panlalawigan of the province of Zamboanga Sibugay which ratified the creation of Barangay San Isidro as proclaimed by the Plebiscite Board of Canvassers on April 16, 2005 shall serve as a substantial compliance with the plebiscite requirement under Section 10 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991;
- Provides that the incumbent elected barangay officials of Barangay San Isidro shall continue to hold office until their successors have been duly elected and qualified.
- Transfers all existing public infrastructure and facilities for public use therein to the newly created Barangay;
- Entitles Barangay San Isidro to the IRA shares pursuant to Section 285 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991.

**RELATED LAWS:**

- Sections 10, 285 and 384 of Republic Act 7160, as amended.
- Provincial Ordinance No. 2002-122 of the Sangguniang Panlalawigan of the province of Zamboanga Sibugay which ratified the creation of Barangay San Isidro.
