The Committee on Local Government to which was referred House Bill No. 867 introduced by Representative Victor A. Yap entitled:



**AN ACT**  
**CREATING A BARANGAY TO BE KNOWN AS BARANGAY CARE IN THE**  
**CITY OF TARLAC, PROVINCE OF TARLAC**

*Be it enacted by the Senate and the House of Representatives  
of the Philippines in Congress assembled:*

1           **SECTION 1.** *Creation of Barangay Care.* - There is hereby created a barangay to  
2 be known as Barangay Care in the City of Tarlac, Province of Tarlac.

3           **SEC. 2.** *Conduct and Supervision of Plebiscite.* - The plebiscite conducted and  
4 supervised by the Commission on Elections (COMELEC) pursuant to Provincial  
5 Ordinance No. 2 Series of 1991 dated September 5, 1991 of the Sangguniang  
6 Panlalawigan of the Province of Tarlac, which ratified the creation of Barangay Care as  
7 proclaimed by the Plebiscite Board of Canvassers on March 14, 1993 shall serve as a  
8 substantial compliance with the plebiscite requirement under Section 10 of Republic Act  
9 7160 as amended, otherwise known as the Local Government Code of 1991.

1           **SEC. 3. *Incumbent Barangay Officials.*** – The incumbent barangay officials of  
2   Barangay Care shall continue to hold office until such time that their successors have  
3   been duly elected and qualified.

4           **SEC. 4. *Public Infrastructure and Facilities.***– All existing public infrastructures  
5   and facilities for public use therein at the time of the approval of this Act are hereby  
6   transferred without cost or compensation to and shall be administered by the new  
7   barangay.

8           **SEC. 5. *Internal Revenue Allotment Shares.***- Barangay Care shall be entitled to  
9   Internal Revenue Allotment shares pursuant to Section 285 of Republic Act No. 7160 as  
10   amended, otherwise known as the Local Government Code of 1991.

11           **SEC. 6. *Effectivity.*** – This Act shall take effect fifteen (15) days after its  
12   publication the Official Gazette or in a newspaper of general circulation.

## FACT SHEET

### House Bill No. 4937

(As approved by the Committee on October 18, 2016)

#### CREATING A BARANGAY TO BE KNOWN AS BARANGAY CARE IN THE CITY OF TARLAC, PROVINCE OF TARLAC

*Introduced by: Rep. Victor A. Yap*

*Committee Referral: Local Government*

*Committee Chairperson: Rep. Pedro B. Acharon, Jr.*

#### OBJECTIVE:

- To establish Barangay Care as a distinct and independent barangay and entitle it to the appropriate Internal Revenue Allotment (IRA) share;

#### KEY PROVISIONS:

- Creates Barangay Care in the City of Tarlac, Province of Tarlac;
- Provides that the plebiscite conducted and supervised by the Commission on Elections (COMELEC) in Barangay Care, pursuant to Provincial Ordinance No. 2 Series of 1991 of the Sangguniang Panlalawigan of the Province of Tarlac which finally ratified the creation of Barangay Care, as proclaimed by the Board of Canvassers on March 14, 1993 shall served as a substantial compliance to the plebiscite requirement under Section 10 of Republic Act 7160, as amended, otherwise known as the Local Government Code of 1991;
- Provides that the incumbent barangay officials of Barangay Care, City of Tarlac, Province of Tarlac shall continue to hold office until such time that their successors have been duly elected and qualified;
- Transfers all public infrastructure and facilities for public use existing therein to the newly created Barangay;
- Entitles Barangay Care to IRA shares pursuant to Section 285 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991.

#### RELATED LAWS:

- Sections 10, 285 and 384 of Republic Act 7160, as amended otherwise known as "The Local Government Code of 1991".
- Provincial Ordinance No. 2 Series of 1991 of the Sangguniang Panlalawigan of the Province of Tarlac which ratified the creation of Barangay Care.
