AN ACT
RENAMING THE ROAD TRAVERSING BARANGAY DOLORES IN THE
MUNICIPALITY OF TAYTAY AND BARANGAY BAGUMBONG IN THE
MUNICIPALITY OF JALA-JALA, ALL IN THE PROVINCE OF RIZAL, AS JOSE
RIZAL HIGHWAY

Be it enacted by the Senate and the House of Representatives in Congress assembled:

- 1 **SECTION 1.** The national road stretching from Barangay Dolores in the Municipality of
2 Taytay, up to Barangay Bagumbong in the Municipality of Jala-Jala, traversing the following
3 points, all in the Province of Rizal, is hereby renamed Jose Rizal Highway:

5 a) From Kay Tikling Junction to Taytay Diversion Road up to the Manila East Road in the
6 Municipality of Taytay;
7
8 b) From the Manila East Road, Taytay to Barangay Muzon, in the Municipality of Taytay;
9
10 c) From Barangay Muzon to Angono Diversion Road and up to Manila East Road,
11 Barangay Pag-asa, in the Municipality of Binangonan;

13 d) From the Manila East Road, Barangay Pag-asa to Binangonan Diversion Road up to
14 Binangonan-Cardona boundary;

16 e) From Binangonan-Cardona boundary to Looc-Calahan Diversion Road up to the
17 Manila East Road going to Morong and up to Sagbat Junction, in the Municipality of
18 Morong;

1 f) From Sagbat Junction to Sagbat-Pililia Road up to the Halayhayin Junction, Manila
2 East Road in the Municipality of Pililia; and,

4 g) From Halayhayin Junction to Pililia-Jala-Jala Road up to the Rizal-Laguna boundary.

6 **SECTION 2.** The Department of Public Works and Highways (DPWH) shall place
7 appropriate markers along the National Roads enumerated in the preceding Section and issue
8 the necessary orders and circulars to implement the provision of this Act.

11 **SECTION 3.** This Act shall take effect fifteen (15) days after its full publication in the
12 Official Gazette or in at least two (2) newspapers of general circulation.
