CREATING A BARANGAY TO BE KNOWN AS BARANGAY POBLACION 2 IN THE MUNICIPALITY OF VILLANUEVA, PROVINCE OF MISAMIS ORIENTAL

Introduced by: Rep. Juliette T. Uy

Committee Referral: Local Government

Committee Chairperson: Rep. Pedro B. Acharon, Jr.

OBJECTIVE:

- To establish Barangay Poblacion 2 as a distinct and independent barangay and entitle it to the appropriate Internal Revenue Allotment (IRA) share;

KEY PROVISIONS:

- Creates Barangay Poblacion 2 in the Municipality of Villanueva, Province of Misamis Oriental;
- Provides that the plebiscite conducted and supervised by the COMELEC pursuant to Provincial Ordinance No. 914-2006 of the Sangguniang Panlalawigan of the Province of Misamis Oriental, which ratified the creation of Barangay Poblacion 2 as proclaimed by the Plebiscite Board of Canvassers on April 22, 2006 shall serve as a substantial compliance with the plebiscite requirement under Section 10 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991;
- Provides that the incumbent elected barangay officials of Barangay Poblacion 2, Municipality of Villanueva, Province of Misamis Oriental shall continue to hold office until their successors have been duly elected and qualified.
- Transfers all existing public infrastructure and facilities for public use therein to the newly created Barangay;
- Entitles Barangay Poblacion 2 to IRA shares pursuant to Section 285 of Republic Act No. 7160, as amended, otherwise known as the Local Government Code of 1991.

- Sections 285 and 384 of Republic Act 7160, as amended otherwise known as "The Local Government Code of 1991".
- Provincial Ordinance No. 914-2006 of the Sangguniang Panlalawigan of the Province of Misamis Oriental.
