6 **WHEREAS,** Mark Louie Eballa was the head coach of paralympian
7 Josephine Medina who won the bronze medal in the Women's Table Tennis
8 Singles Class Eight (8) event on September 13, 2016 at the Rio Summer
9 Paralympic games, ending the Philippines' sixteen (16) year Paralympic medal
10 drought;

11 **WHEREAS,** on account of the overwhelming victory of Josephine
12 Medina, who earned the accolade of being the first ever Filipino paralympian
13 to have won a medal in table tennis, it is appropriate and timely to commend

1 and congratulate head coach Mark Louie Eballa who played a vital role in giving
2 Josephine Medina the exemplary training, in instilling discipline, and in keeping
3 her motivated to achieve greatness by winning the bronze medal in the 2016
4 Summer Paralympic tournament;

5 **WHEREAS**, Republic Act No. 10699 in fact recognizes the contribution of
6 national coaches in promoting sports development by providing incentives in
7 the form of cash rewards if the athlete or team they had trained for
8 international sports competition win: Now, therefore, be it
