1 **WHEREAS**, the Philippine Dragon Boat team participated in the 2016
2 International Canoe Federation (ICF) World Dragon Boat Championships held in the
3 waters of Krylatskoe, in Moscow, Russia and competed in the mixed 20-man, mixed
4 10-man and junior 10-man 200 meters and 500 meters events;

17 meter finals and crossed the line in one minute and fifty-five seconds (1:55),
18 prevailing over favorites Russia, Thailand and Ukraine by a split second;

1 **WHEREAS**, with discipline and hard work, the Philippine Dragon Boat team
2 won three (3) gold, one (1) silver and two (2) bronze medals in the competition
3 placing the Philippines third in the overall ranking in the 2016 Championships;

4 **WHEREAS**, the remarkable performance of the Philippine Dragon Boat Team
5 deserves to be commended and recognized as it has brought tremendous pride and
6 honor to the country: Now, therefore, be it
