The Committee on Revision of Laws to which was referred House Bill No. 213, introduced by Rep. Francisco Matugas, entitled:

"AN ACT

DECLARING MAY 15 OF EVERY YEAR AS A SPECIAL NON-WORKING HOLIDAY IN THE ENTIRE PROVINCE OF SURIGAO DEL NORTE TO BE KNOWN AS "ADLAW NAN PROBINSYA NAN SURIGAO" AND REPEALING FOR THE PURPOSE REPUBLIC ACT NO. 7553, ENTITLED "AN ACT DECLARING JUNE NINETEEN OF EVERY YEAR AS A SPECIAL NONWORKING HOLIDAY IN THE PROVINCE OF SURIGAO DEL NORTE, TO BE KNOWN AS 'ADLAW NAN SURIGAO DEL NORTE"

AN ACT

1 **DECLARING MAY 15 OF EVERY YEAR A SPECIAL NON-WORKING HOLIDAY**
2 **IN THE PROVINCE OF SURIGAO DEL NORTE, TO BE KNOWN AS "ADLAW**
3 **NAN PROBINSYA NAN SURIGAO DEL NORTE", THEREBY AMENDING**
4 **REPUBLIC ACT NO. 7553, ENTITLED "AN ACT DECLARING JUNE NINETEEN**
5 **OF EVERY YEAR AS A SPECIAL NONWORKING HOLIDAY IN THE PROVINCE**
6 **OF SURIGAO DEL NORTE, TO BE KNOWN AS "ADLAW NAN SURIGAO DEL**
7 **NORTE"**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

8 SECTION 1. Section 1 of Republic Act No. 7553 is hereby amended to read
9 as follows:

10 "SECTION 1. [June Nineteen] MAY 15 is hereby declared [as] a special
11 [nonworking] NON-WORKING holiday in the Province of Surigao del Norte, to
12 be known as "Adlaw NAN PROBINSYA Nan Surigao del Norte".

13 SEC. 2. This Act shall take effect fifteen (15) days after its publication in the
14 *Official Gazette* or in a newspaper of general circulation.
