The Committee on Revision of Laws to which was referred House Bill No. 636, introduced by Rep. Xavier Jesus D. Romualdo., entitled:


"AN ACT

2 **MOVING THE DATE OF "CATARMAN DAY" TO AUGUST 30 OF EVERY YEAR,**
3 **AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9203, ENTITLED "AN ACT**
4 **DECLARING THE FIFTEENTH (15TH) DAY OF AUGUST OF EVERY YEAR AS A**
5 **SPECIAL NONWORKING HOLIDAY IN THE MUNICIPALITY OF CATARMAN,**
6 **PROVINCE OF CAMIGUIN, TO BE KNOWN AS "CATARMAN DAY"**

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

7 SECTION 1. Section 1 of Republic Act No. 9203 is hereby amended to read
8 as follows:

9 "SECTION 1. August [Fifteenth (15th)] 30 of every year is
10 hereby declared [as] a special [nonworking] NON-WORKING
11 holiday in the Municipality of Catarman, Province of Camiguin, to
12 commemorate its foundation day anniversary, TO BE KNOWN AS
13 "CATARMAN DAY".

14 SEC. 2. The Municipal Government of Catarman in the Province of Camiguin
15 shall disseminate to its component barangays, as well as to the Provincial
16 Government of Camiguin, through means it deems proper and expedient, the
17 change of the date of Catarman Day, for proper coordination of activities.

18 SEC. 3. This Act shall take effect fifteen (15) days after its publication in the
19 Official Gazette or in a newspaper of general circulation.

20 Approved,
