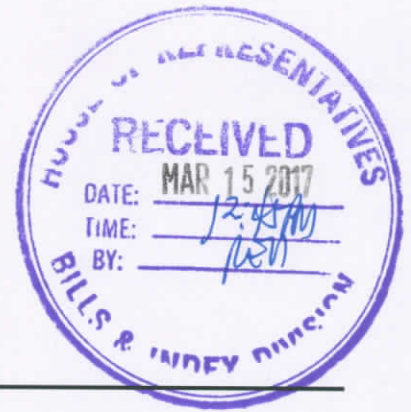





HOUSE BILL NO. 5273

INTRODUCED BY HONORABLE MOHAMAD KHALID Q. DIMAPORO and HONORABLE RENE L. RELAMPAGOS

AN ACT
TRANSFERRING THE PROVINCIAL AGRARIAN REFORM OFFICE OF LANA DEL NORTE FROM
ILIGAN CITY TO THE MUNICIPALITY OF TUBOD, LANA DEL NORTE AND APPROPRIATING
FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

SECTION 1. The Lanao del Norte Provincial Agrarian Reform Office, under the supervision of the Department of Agrarian Reform, is hereby transferred from Iligan City to the Municipality of Tubod, Lanao del Norte.

SECTION 2. The Secretary of the Department of Agrarian Reform shall immediately include in the Department's program the operationalization of the Lanao del Norte Provincial Agrarian Reform Office in the Municipality of Tubod, Lanao del Norte, the initial funding of which shall be charged against the current year's appropriations of the Lanao del Norte Provincial Agrarian Reform Office. Thereafter, the amount necessary for the continued operation of the said Provincial Agrarian Reform Office shall be included in the annual General Appropriations Act.

SECTION 3. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.

FACT SHEET

House Bill No. 1184

AN ACT TRANSFERRING THE PROVINCIAL AGRARIAN REFORM OFFICE OF LANA DEL NORTE FROM ILIGAN CITY TO THE MUNICIPALITY OF TUBOD, LANA DEL NORTE AND APPROPRIATING FUNDS THEREFOR.

OBJECTIVE:

- To facilitate ease of transacting business with multiple government agencies located mostly in the Municipality of Tubod.

KEY PROVISIONS:

- Transfers the Lanao del Norte PARO from Iligan City, to the Municipality of Tubod, the capital town of Lanao del Norte.
- Mandates the Secretary of the Department of Agrarian Reform (DAR) to include in their Department's program the operationalization of the Lanao del Norte PARO in Tubod, and providing funding therefor to be initially charged against DAR's current annual appropriation, and against the DAR's yearly budget under the General Appropriations Act.

RELATED LAWS:

- **BP 181** transferred the seat of the provincial government of Lanao del Norte from Iligan City to the Municipality of Tubod, same province (1982);
- **RA 9724** created the Lone District of Iligan City by separating it from the 1st District of the Province of Lanao del Norte (2009).
