**AN ACT**  
**NAMING THE POBLACION-CANIOGAN NATIONAL ROAD TRAVERSING  
BARANGAY POBLACION AND BARANGAY BARAKANAS, IN THE  
MUNICIPALITY OF TUBOD, PROVINCE OF LANA DEL NORTE AS THE  
ARSENIO ARCELO QUIBRANZA HIGHWAY**

*Be it enacted by the Senate and the House of Representatives in Congress assembled:*

1       **SECTION 1.** The Poblacion-Caniogan National Road traversing Barangays Poblacion,  
2 San Antonio, Patudan, Pinpin, Malingao, Licapao, Candis, Caniogan and Barakanas in the  
3 Municipality of Tubod, Province of Lanao Del Norte, is hereby named as the Arsenio Arcelo  
4 Quibranza Highway.

7       **SEC. 2.** The Department of Public Works and Highways shall issue the necessary  
8 rules, orders, and circulars to implement the provisions of this Act.

11       **SEC. 3.** This Act shall take effect fifteen (15) days following the completion of its  
12 publication in the Official Gazette or in a newspaper of general circulation.
