**AN ACT**  
**DECLARING MARCH 2 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE PROVINCE OF LA UNION IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY, TO BE KNOWN AS "LA UNION DAY"**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1           SECTION 1. March 2 of every year is hereby declared a special nonworking  
2 holiday in the Province of La Union in commemoration of its founding anniversary, to  
3 be known as "La Union Day". When the holiday falls on a Saturday or a Sunday, or  
4 on a nationally declared nonworking holiday, the special nonworking day shall be  
5 observed on the next business day that follows.

6           SEC. 2. This Act shall take effect fifteen (15) days after its publication  
7 in the *Official Gazette* or in a newspaper of general circulation.
