**AN ACT**  
**DECLARING NOVEMBER 15 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE PROVINCE OF OCCIDENTAL MINDORO IN COMMEMORATION OF ITS FOUNDING ANNIVERSARY**

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1           SECTION 1. November 15 of every year is hereby declared a special  
2 nonworking holiday in the Province of Occidental Mindoro in commemoration of its  
3 founding anniversary.

4           SEC. 2. This Act shall take effect fifteen (15) days after its publication in the  
5 *Official Gazette* or in a newspaper of general circulation.
