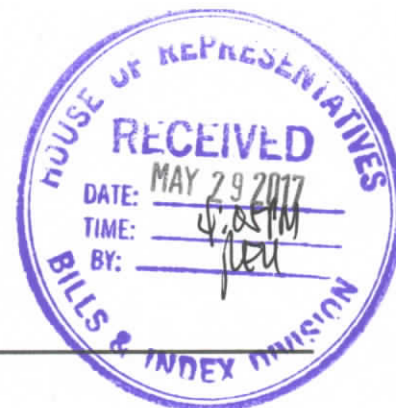



HOUSE BILL NO. **5755**
(In substitution of House Bill No. 1640)

Introduced by Representatives Tambunting, Escudero, Durano and Nograles (K.A.)

AN ACT

SEPARATING THE PARAÑAQUE NATIONAL HIGH SCHOOL – DON BOSCO EXTENSION IN BARANGAY DON BOSCO, PARAÑAQUE CITY, FROM THE PARAÑAQUE NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS DON BOSCO NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Parañaque National High School – Don Bosco Extension in
2 Barangay Don Bosco, Parañaque City, is hereby separated from the Parañaque National
3 High School and converted into an independent national high school to be known as Don
4 Bosco National High School.

5
6 SEC. 2. All personnel, assets, liabilities and records of the Parañaque National High
7 School – Don Bosco Extension are hereby transferred to and absorbed by the Don Bosco
8 National High School.

9
10 SEC. 3. The Secretary of Education shall immediately include in the Department's
11 program the operationalization of the Don Bosco National High School, the initial funding
12 of which shall be charged against the current year's appropriation of the Parañaque National
13 High School – Don Bosco Extension. Thereafter, the amount necessary for the continued
14 operation of the school shall be included in the annual General Appropriations Act.

15
16 SEC. 4. Within one hundred twenty (120) days after the approval of this Act, the
17 Secretary of Education shall formulate the rules and regulations implementing the
18 provisions of this Act.

19
20 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the
21 Official Gazette or in a newspaper of general circulation.
