HOUSE BILL NO. **5757**
(In substitution of House Bill No. 3510)

Introduced by Representatives Tambunting, Escudero, Durano and Nograles (K.A.)

AN ACT

SEPARATING THE PARAÑAQUE NATIONAL HIGH SCHOOL – SAN ANTONIO HIGH SCHOOL ANNEX IN BARANGAY SAN ANTONIO, PARAÑAQUE CITY, FROM THE PARAÑAQUE NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS SAN ANTONIO NATIONAL HIGH SCHOOL PARAÑAQUE, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1 SECTION 1. The Parañaque National High School – San Antonio High School
2 Annex in Barangay San Antonio, Parañaque City, is hereby separated from the Parañaque
3 National High School and converted into an independent national high school to be known
4 as San Antonio National High School Parañaque.

5
6 SEC. 2. All personnel, assets, liabilities and records of the Parañaque National High
7 School – San Antonio High School Annex are hereby transferred to and absorbed by the
8 San Antonio National High School Parañaque.

9
10 SEC. 3. The Secretary of Education shall immediately include in the Department's
11 program the operationalization of the San Antonio National High School Parañaque, the
12 initial funding of which shall be charged against the current year's appropriation of the
13 Parañaque National High School – San Antonio High School Annex. Thereafter, the
14 amount necessary for the continued operation of the school shall be included in the annual
15 General Appropriations Act.

16
17 SEC. 4. Within one hundred twenty (120) days after the approval of this Act, the
18 Secretary of Education shall formulate the rules and regulations implementing the
19 provisions of this Act.

20
21 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the
22 Official Gazette or in a newspaper of general circulation.
