The Committee on Higher and Technical Education, to which was referred:

House Bill No. 4650, introduced by Rep. Aurelio "Dong" D. Gonzales, Jr., entitled:

"AN ACT

AN ACT

RENAMING THE DON HONORIO VENTURA TECHNOLOGICAL STATE UNIVERSITY IN THE MUNICIPALITY OF BACOLOR, PROVINCE OF PAMPANGA AS THE DON HONORIO VENTURA STATE UNIVERSITY, AND EXPANDING ITS CURRICULAR OFFERINGS, AMENDING FOR THE PURPOSE REPUBLIC ACT NO. 9832, ENTITLED "AN ACT CONVERTING THE DON HONORIO VENTURA COLLEGE OF ARTS AND TRADES IN THE MUNICIPALITY OF BACOLOR, PROVINCE OF PAMPANGA INTO A STATE UNIVERISTY TO BE KNOWN AS THE DON HONORIO VENTURA TECHNOLOGICAL STATE UNIVERSITY (DHVTSU) AND APPROPRIATING FUNDS THEREFOR"

*Be it enacted by the Senate and the House of Representatives in Congress assembled:*

1       **SECTION 1.** The Don Honorio Ventura Technological State University (DHVTSU) in  
2 the Municipality of Bacolor, Province of Pampanga is hereby renamed as the Don Honorio  
3 Ventura State University (DHVSU).  
4

5       **SEC. 2. General Mandate.** – The University shall primarily provide advanced  
6 instruction and professional training in education, engineering, science and technology, arts and  
7 humanities, information and communication technology education, liberal arts, medical, health-  
8 related programs, and other relevant fields of study. It shall also undertake research, extension  
9 services, and production activities in support of the socioeconomic development of Pampanga  
10 and provide progressive leadership in its areas of specialization.

12       **SEC. 3. Curricular Offerings.** – The University shall offer undergraduate and graduate  
13 courses in the fields of education, engineering, science and technology, arts and humanities,  
14 information and communications technology, liberal arts, legal management, law, medicine  
15 sciences, health related courses, entrepreneurial program, creative industries, travel  
16 management, culinary management, and other relevant courses within its areas of specialization  
17 and according to its capabilities, as the Board of Regents may deem necessary to carry out its  
18 objectives, in order to meet the needs of the Province of Pampanga and Region III.

20       **SEC. 4. Repealing Clause.** – All provisions of Republic Act No. 9832 referring to the  
21 name of Don Honorio Ventura Technological State University are hereby modified  
22 accordingly.

24       **SEC. 5. Effectivity.** – This Act shall take effect fifteen (15) days after its publication in  
25 the Official Gazette or in a newspaper of general circulation.
