AN ACT ESTABLISHING THE SOCCSKSARGEN GENERAL HOSPITAL IN THE MUNICIPALITY OF SURALLAH, PROVINCE OF SOUTH COTABATO, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:

- 1 **SECTION 1.** There shall be established a general hospital in the Municipality of
2 Surallah, Province of South Cotabato, to be known as the SOCCSKSARGEN General
3 Hospital.
- 4 **SEC. 2.** The Provincial Government of South Cotabato shall provide funding for the
5 establishment of the SOCCSKSARGEN General Hospital in the Municipality of Surallah,
6 Province of South Cotabato. The Secretary of Health shall include in the Department's

1 programs, subsidy support for the capital outlay requirements of the said general
2 hospital.

4 **SEC. 3.** The DOH Regional Director of the Center for Health Development, Region XII,
5 and the Chief of the SOCCSKSARGEN General Hospital, in coordination with the
6 concerned local government units, shall also draw up a mechanism for sourcing
7 supplementary funds to augment its operation.

9 **SEC. 4.** The Department of Health, in consultation and coordination with local
10 government officials concerned and the Mindanao Development Authority (MinDA),
11 shall promulgate the necessary rules and regulations for the effective implementation of
12 this Act.

13
14 **SEC. 5.** This Act shall take effect fifteen (15) days after its publication in the *Official*
15 *Gazette* or in a newspaper of general circulation.
