

House Bill No. 198

(Approved by the Ctte. on Appropriations on 22 February 2017)

OBJECTIVE:

- To ensure the speedy disposition of cases and to declog court dockets.

- Creates an additional branch of the Regional Trial Court (RTC) in the City of Baybay, Leyte.
