

**OBJECTIVE:**

- To ensure the speedy disposition of cases and to declog court dockets.

**KEY PROVISION:**

- Creates two (2) additional Regional Trial Court (RTC) branches in the Municipalities of Sto. Tomas and Agoncillo in the Province of Batangas.
