**AN ACT CONVERTING THE EXTENSION OFFICE OF THE LAND
TRANSPORTATION OFFICE IN THE MUNICIPALITY OF SANCHEZ MIRA,
PROVINCE OF CAGAYAN INTO A REGULAR DISTRICT OFFICE,
TRANSFERRING ITS LOCATION TO THE MUNICIPALITY OF ABULUG,
PROVINCE OF CAGAYAN, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in
Congress assembled:*

SECTION 1..The existing Land Transportation Office (LTO) Extension located in the Municipality of Sanchez Mira, Province of Cagayan is hereby converted into a regular LTO District Office and transferred to the Municipality of Abulug, Province of Cagayan.

Sec. 2. The Secretary of the Department of Transportation (DOTr) shall immediately include in the Department's programs the operationalization of the LTO District Office in Abulug, the initial funding of which shall be charged against the current year's appropriations of the Municipality of Sanchez Mira LTO Extension Office. Thereafter, such sums as may be necessary for the continued implementation of this Act shall be included in the annual General Appropriations Act.

Sec. 3. The Secretary of the DOTr shall issue rules and regulations necessary for the effective implementation of this Act within sixty (60) days from its effectivity.

Sec. 4. This Act shall take effect fifteen (15) days after its publication in the *Official Gazette* or in a newspaper of general circulation
