Mr. Speaker:

The Committee on Transportation and the Committee on Appropriations to which was referred House Bill No. 3169 introduced by Rep. Mario Vittorio A. Marino, entitled:

“AN ACT CONVERTING THE LAND TRANSPORTATION OFFICE (LTO) LICENSING CENTER IN THE CITY OF BATANGAS, PROVINCE OF BATANGAS INTO A REGULAR LICENSING CENTER TO BE KNOWN AS THE BATANGAS CITY LICENSING CENTER OF BATANGAS CITY, BATANGAS, AND APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES”

have considered the same and recommend its approval with the following amendments:

- On Section 2, delete the entire provision and in lieu thereof, substitute the following:

SECTION 2. THE SECRETARY OF TRANSPORTATION SHALL IMMEDIATELY INCLUDE IN THE DEPARTMENT’S PROGRAM THE OPERATIONALIZATION OF A REGULAR LTO LICENSING CENTER TO BE KNOWN AS THE BATANGAS CITY LICENSING CENTER, THE FUNDING OF WHICH SHALL BE CHARGED AGAINST THE CURRENT YEAR’S APPROPRIATIONS OF THE BATANGAS CITY LICENSING CENTER. THEREAFTER, SUCH SUMS AS MAY BE NECESSARY FOR THE CONTINUED OPERATION OF BATANGAS CITY LICENSING CENTER SHALL BE INCLUDED IN THE ANNUAL GENERAL APPROPRIATIONS ACT.

- On the last line of the Title, substitute the word “**THEREFORE**” with “**THEREFOR**” and delete the phrase “**AND FOR OTHER PURPOSES**”

with Reps. Mario Vittorio A. Marino, Cesar V. Sarmiento, Karlo Alexei B. Nograles as authors thereof.
