AN ACT

DECLARING JANUARY 21 OF EVERY YEAR A SPECIAL NONWORKING HOLIDAY IN THE MUNICIPALITY OF RODRIGUEZ, PROVINCE OF RIZAL, IN COMMEMORATION OF THE BIRTH ANNIVERSARY OF HON. EULOGIO "AMANG" ADONA RODRIGUEZ, SR.

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

1           SECTION 1. January 21 of every year is hereby declared a special  
2 nonworking holiday in the Municipality of Rodriguez, Province of Rizal, in  
3 commemoration of the birth anniversary of Hon. Eulogio "Amang" Adona Rodriguez,  
4 Sr., and in recognition of his altruistic acts and contribution to public service.

5           SEC. 2. This Act shall take effect fifteen (15) days after its publication in the  
6 *Official Gazette* or in a newspaper of general circulation.
