entitled:



AN ACT

2 **INCREASING THE BED CAPACITY OF THE BILIRAN PROVINCIAL HOSPITAL IN**
3 **ITS PROPOSED RELOCATION SITE IN BARANGAY LARRAZABAL,**
4 **MUNICIPALITY OF NAVAL, PROVINCE OF BILIRAN, FROM SEVENTY FIVE (75) TO**
5 **TWO HUNDRED (200) BEDS, AND APPROPRIATING FUNDS THEREFOR**

7 *Be it enacted by the Senate and House of Representatives of the Philippines in*
8 *Congress assembled:*
9

10 **SECTION 1.** The bed capacity of the Biliran Provincial Hospital in its proposed
11 relocation site in Barangay Larrazabal, Municipality of Naval, Province of Biliran, shall
12 be increased from seventy five (75) to two hundred (200) beds.
13

14 **SEC. 2.** The existing hospital facilities and professional health care services of
15 the Biliran Provincial Hospital are hereby upgraded and increased to conform with and
16 be commensurate to the increase in bed capacity. The number of medical personnel
17 shall be correspondingly increased.
18

19 **SEC. 3.** The Provincial Government of Biliran shall provide the necessary funds
20 to support the increase in bed capacity of the Biliran Provincial Hospital and the
21 corresponding upgrading of its facilities and services. The Secretary of Health shall
22 include in the Department's program, subsidy support for the capital outlay
23 requirements of the said hospital.

25 **SEC. 4.** The Department of Health (DOH) and the Department of Public Works
26 and Highways (DPWH) shall promulgate the necessary rules and regulations for the
27 effective implementation of this Act, including the provision of technical support in the
28 use of the needed equipment for the construction of the infrastructure.

1 **SEC. 5.** Republic Act No. 7194, entitled "An Act Increasing the Bed Capacity of the
2 Naval General Hospital in the Municipality of Naval, Subprovince of Biliran, Leyte, from Twenty-Five
3 (25) to Fifty (50) Beds" and Republic Act No. 3875, entitled "An Act Converting Naval Emergency
4 Hospital into a General Hospital" are hereby repealed. All laws, decrees, ordinances, rules
5 and regulations, executive or administrative orders, and other presidential issuances
6 inconsistent with this Act are hereby repealed, amended or modified accordingly.
7

8 **SEC. 6.** This Act shall take effect fifteen (15) days after its publication in the
9 *Official Gazette* or in a newspaper of general circulation.
