



**AN ACT MANDATING THE TRANSFER OF THE PROVINCIAL AGRARIAN REFORM OFFICE IN THE
MUNICIPALITY OF SOGOD TO THE CITY OF MAASIN, SOUTHERN LEYTE AND APPROPRIATING
FUNDS THEREFOR**

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress
assembled:*

SECTION 1. The Southern Leyte Provincial Agrarian Reform Office, under the supervision of the Department of Agrarian Reform, is hereby transferred from the Municipality of Sogod to the City of Maasin, Southern Leyte.

SECTION 2. The Secretary of the Department of Agrarian Reform shall immediately include in the Department's program the operationalization of the Southern Leyte Provincial Agrarian Reform Office in the City of Maasin, Southern Leyte, the initial funding of which shall be charged against the current year's appropriations of Southern Leyte Provincial Agrarian Reform Office. Thereafter, the amount necessary for the continued operation of the said Provincial Agrarian Reform Office shall be included in the annual General Appropriations Act.

SECTION 3. This Act shall take effect fifteen (15) days after its publication in the Official Gazette or in a newspaper of general circulation.
