
The Committees on Justice and Appropriations, to which were referred House Bill No. 286, introduced by Rep. Maximo B. Dalog, entitled:

**OBJECTIVE:**

- To ensure the speedy disposition of cases and to declog court dockets.

**KEY PROVISION:**

- Creates an additional Regional Trial Court (RTC) branch in Mountain Province to be stationed in the Municipality of Paracelis.
