The Committees on Justice and Appropriations, to which was referred House Bill No. 2830, introduced by Rep. Raneo E. Abu, entitled:

**AN ACT
CREATING SIXTEEN (16) ADDITIONAL BRANCHES OF THE REGIONAL TRIAL COURTS IN THE WHOLE PROVINCE OF BATANGAS, FOR THE PURPOSE OF AMENDING BATAS PAMBANSA BILANG 129, OTHERWISE KNOWN AS 'THE JUDICIARY REORGANIZATION ACT OF 1980', AS AMENDED, AND APPROPRIATING FUNDS THEREFOR**

OBJECTIVE:

- To ensure the speedy disposition of cases and to declog court dockets.

KEY PROVISION:

- Creates an additional fifteen (15) Regional Trial Court (RTC) branches in the whole Province of Batangas.

RELATED LAWS:

- **BP 129** (Judiciary Reorganization Act of 1980)
