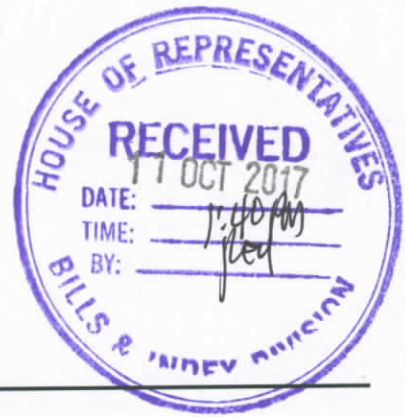

HOUSE BILL NO. **6603**
(In substitution of House Bill No. 5141)

Introduced by Representatives Bautista-Bandigan, Durano and Nograles (K. A.)

AN ACT

SEPARATING THE KALBAY NATIONAL HIGH SCHOOL ANNEX IN BARANGAY SUGAL, MUNICIPALITY OF JOSE ABAD SANTOS, PROVINCE OF DAVAO OCCIDENTAL FROM THE KALBAY NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS EMELIANO S. FONTANARES SR. NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in the Congress assembled:

1 SECTION 1. The Kalbay National High School Annex in Barangay Sugald, Municipality
2 of Jose Abad Santos, Province of Davao Occidental is hereby separated from the Kalbay
3 National High School, and converted into an independent national high school to be known as
4 Emeliano S. Fontanares Sr. National High School.

6 SEC. 2. All personnel, assets, liabilities, and records of the Kalbay National High
7 School Annex are hereby transferred to and absorbed by the Emeliano S. Fontanares Sr. National
8 High School.

10 SEC. 3. The Secretary of Education shall immediately include in the Department's
11 program the operationalization of the Emeliano S. Fontanares Sr. National High School, the
12 initial funding of which shall be charged against the current year's appropriation of the Kalbay
13 National High School Annex. Thereafter, the amount necessary for the continued operation of the
14 school shall be included in the annual General Appropriations Act.

16 SEC. 4. The Secretary of Education shall formulate the rules and regulations necessary
17 to carry out the purpose of this Act within one hundred twenty (120) days after its effectivity.

19 SEC. 5. This Act shall take effect fifteen (15) days after its publication in the Official
20 Gazette or in a newspaper of general circulation.
