
have considered the same and recommend that the attached House Bill No. **6605**, entitled:

HOUSE BILL NO. 6605

**AN ACT PROVIDING FOR THE ESTABLISHMENT OF AN INDIGENOUS TRAINING CENTER
IN THE CITY OF KIDAPAWAN, PROVINCE OF NORTH COTABATO,
AND APPROPRIATING FUNDS THEREFOR**

Be it enacted by the Senate and the House of Representatives of the Philippines in Congress:

1 **SECTION 1.** There shall be established an indigenous training and learning center in
2 the City of Kidapawan, Province of North Cotabato.

3 **SEC. 2.** It shall be the duty of the National Commission on Indigenous Peoples (NCIP),
4 in coordination with the Technical Education and Skills Development Authority (TESDA), to
5 provide appropriate training of skills development to recipient members of the indigenous
6 cultural communities (ICCs) in the City of Kidapawan, Province of North Cotabato.

7 To this end, the NCIP shall formulate learning programs that shall be relevant to the
8 needs of the concerned ICCs who themselves shall determine the types of skills they need to
9 be trained at, given their circumstances. For this purpose, the NCIP shall coordinate with the
10 Department of Public Works and Highways (DPWH) for the construction of a building where
11 the skills training and learning sessions shall be conducted.

12 **SEC. 3.** The Chairperson of the NCIP shall include in the Commission's program the
13 implementation of this Act, the funding of which shall be included in the annual General
14 Appropriations Act.

15 **SEC. 4.** Within sixty (60) days after the effectivity of this Act, the NCIP, in coordination
16 with the TESDA, shall promulgate the necessary rules and regulations to govern the effective
17 implementation of this Act.

18 **SEC. 5.** Any provision of law, orders, issuances, rules or regulations inconsistent with
19 this Act is hereby repealed, revoked, or modified accordingly.

20 **SEC. 6.** This Act shall take effect fifteen (15) days after its publication in the Official
21 Gazette or in a newspaper of general circulation.

OBJECTIVE:

- To equip indigenous cultural communities in the City of Kidapawan, Province of Cotabato with the proper knowledge, training and resources to make them economically self-sufficient.

KEY PROVISIONS:

- Establishes an indigenous training and learning center in the City of Kidapawan, Province of North Cotabato;
- Mandates the National Commission on Indigenous Peoples (NCIP), in coordination with the Technical Education and Skills Development Authority (TESDA), to provide, formulate and conduct the necessary and relevant skills development training to recipient members of indigenous cultural communities.
