

**AN ACT**

**SEPARATING THE LAWA NATIONAL HIGH SCHOOL ANNEX IN BARANGAY LAPUAN, MUNICIPALITY OF DON MARCELINO, PROVINCE OF DAVAO OCCIDENTAL FROM THE LAWA NATIONAL HIGH SCHOOL, CONVERTING IT INTO AN INDEPENDENT NATIONAL HIGH SCHOOL TO BE KNOWN AS LUISA JOYCE MALLARI NATIONAL HIGH SCHOOL, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and House of Representatives of the Philippines in the Congress assembled:*

1           SECTION 1. The Lawa National High School Annex in Barangay Lapuan, Municipality  
2 of Don Marcelino, Province of Davao Occidental is hereby separated from the Lawa National  
3 High School, and converted into an independent national high school to be known as Luisa  
4 Joyce Mallari National High School.

5  
6           SEC. 2. All personnel, assets, liabilities, and records of the Lawa National High School  
7 Annex are hereby transferred to and absorbed by the Luisa Joyce Mallari National High School.

8  
9           SEC. 3. The Secretary of Education shall immediately include in the Department's  
10 program, the operationalization of the Luisa Joyce Mallari National High School, the initial  
11 funding of which shall be charged against the current year's appropriation of the Lawa National  
12 High School Annex. Thereafter, the amount necessary for the continued operation of the school  
13 shall be included in the annual General Appropriations Act.

14  
15           SEC. 4. The Secretary of Education shall formulate the rules and regulations necessary  
16 to carry out the purpose of this Act within one hundred twenty (120) days after its effectivity.

17  
18           SEC. 5. This Act shall take effect fifteen (15) days after its publication in the Official  
19 Gazette or in a newspaper of general circulation.
