**OBJECTIVES**

- To increase the rates of allowances for local travels of government officials and personnel

**KEY PROVISIONS**

- Emphasizes the need to restructure the system of adjusting the allowances by implementing a periodic increase in the travel allowance for local travels of government officials and personnel.
- Increases the rates of local travel allowance from Eight Hundred Pesos (P800.00) to Two Thousand Pesos (P2,000) per day, with the following breakdown:

Hotel/Lodging	50%	P1,000
Meals	30%	600
Incidental Expenses	20%	<u>400</u>
Total		<u>P2,000</u>

- Resolves that the House of Representatives urges His Excellency President Rodrigo R. Duterte to issue an Executive Order to implement an increase in the travel allowance for local travels of government officials and personnel from P800 to P2,000 per day.
