**AN ACT ESTABLISHING A ONE HUNDRED (100)-BED CAPACITY HOSPITAL IN BARANGAY HABAY 2 IN THE CITY OF BACOR, PROVINCE OF CAVITE, TO BE KNOWN AS THE BACOR DISTRICT HOSPITAL, AND APPROPRIATING FUNDS THEREFOR**

*Be it enacted by the Senate and the House of Representatives of the Philippines in Congress assembled:*

2       **SECTION 1.** There shall be established under the technical supervision of the  
3 Department of Health, a one hundred (100)-bed capacity hospital in Barangay Habay 2,  
4 City of Bacor, Province of Cavite to be known as the Bacor District Hospital.

5       **SEC. 2.** The Provincial Government of Cavite shall provide funding for the  
6 establishment of Bacor District Hospital. The Secretary of Health shall include in the  
7 Department's subsidy program, support for the capital outlay requirements of the said  
8 hospital.

9  
10       **SEC. 3.** This Act shall take effect fifteen (15) days after its publication in the  
11 *Official Gazette* or in a newspaper of general circulation.
