# SEVENTEENTH CONGRESS Second Regular Session 6620 HOUSE BILL NO.

(In substitution of House Bill No. 4824)

Introduced by Representatives Rodrigo A. Abellanosa and Karlo Alexei B. Nograles

## AN ACT INCREASING THE BED CAPACITY OF ST. ANTHONY MOTHER AND CHILD HOSPITAL IN CEBU CITY, FROM TWENTY-FIVE (25) TO ONE HUNDRED (100), AND APPROPRIATING FUNDS THEREFOR

Be it enacted by the Senate and House of Representatives of the Philippines in Congress assembled:

- SECTION 1. The bed capacity of St. Anthony Mother and Child Hospital (SAMCH) is hereby
- 2 increased from twenty-five (25) to one hundred (100) beds.
- 3 Sec. 2. The SAMCH shall primarily provide medical, maternity, and pediatric care to the
- 4 urban poor in Region VII, particularly in Cebu City.
- 5 Sec. 3. The SAMCH's existing service facilities and professional health care services are
- 6 also hereby upgraded to conform with and be commensurate to the bed capacity increase as
- 7 provided in Section 1 hereof.
- 8 Sec. 4. The existing workforce of the SAMCH shall also be correspondingly increased. The
- 9 Department of Health, in coordination with the Department of Budget and Management and
- 10 the Civil Service Commission, shall determine the additional plantilla positions to be created
- and filled up upon prior consultation with the SAMCH.
- 12 Sec. 5. All accounts and expenses of the SAMCH shall be audited by the Commission on
- 13 Audit or its duly authorized representative.
- 14 Sec. 6. The Secretary of Health shall immediately include in the Department's programs the
- 15 implementation of this Act, the funding of which shall be included in the annual General
- 16 Appropriations Act.
- 17 Sec. 7. The Department of Health shall issue the necessary rules and regulations for the
- 18 effective implementation of this Act.
- 19 Sec. 8. This Act shall take effect within fifteen (15) days after its publication in the Official
- 20 Gazette or in a newspaper of general circulation.
- 21 Approved,
